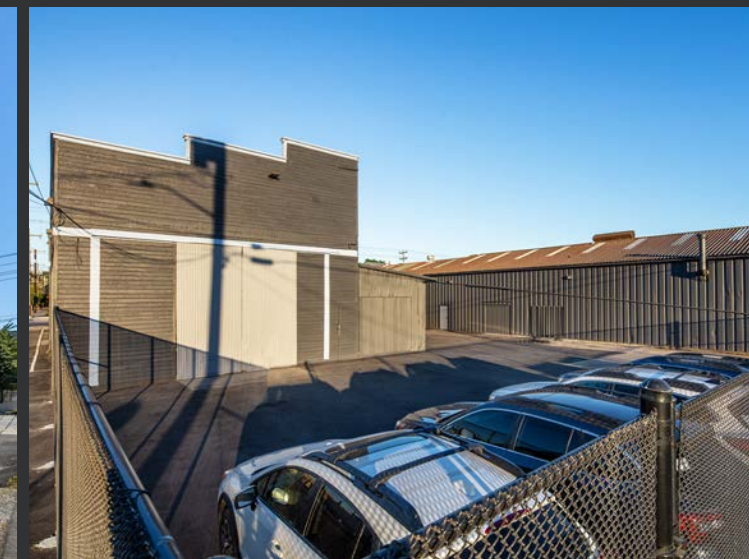

The building features open timber frame construction and an eclectic, industrial aesthetic – ideal for a dramatic open loft-style concept such as a gallery, brewery, or distillery.

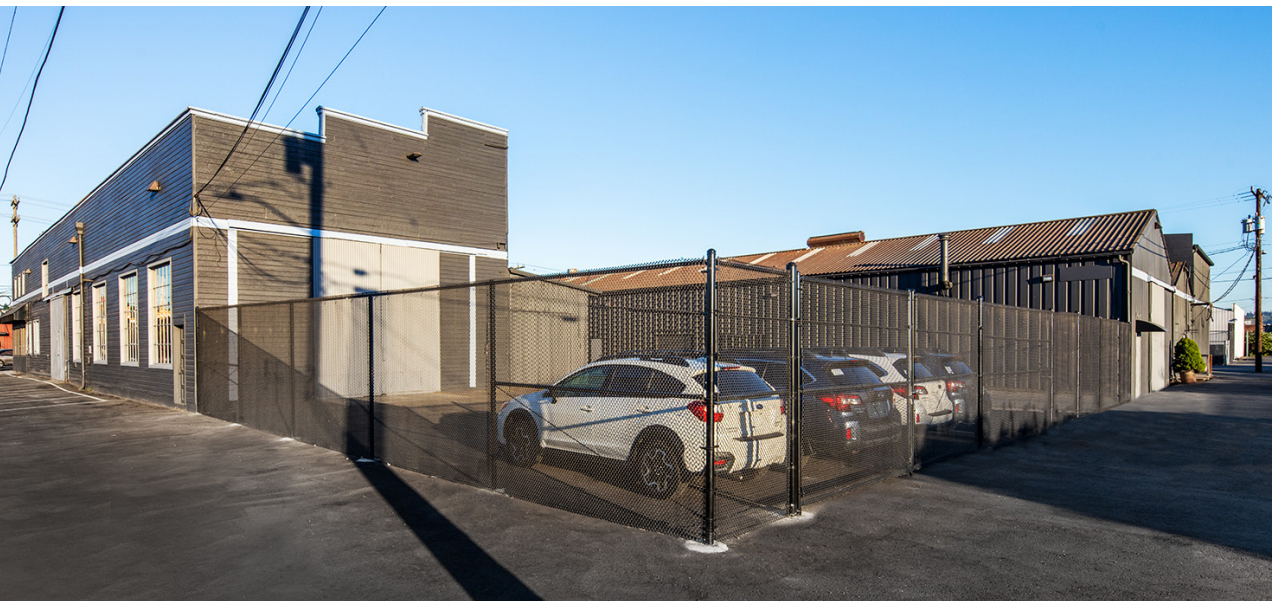

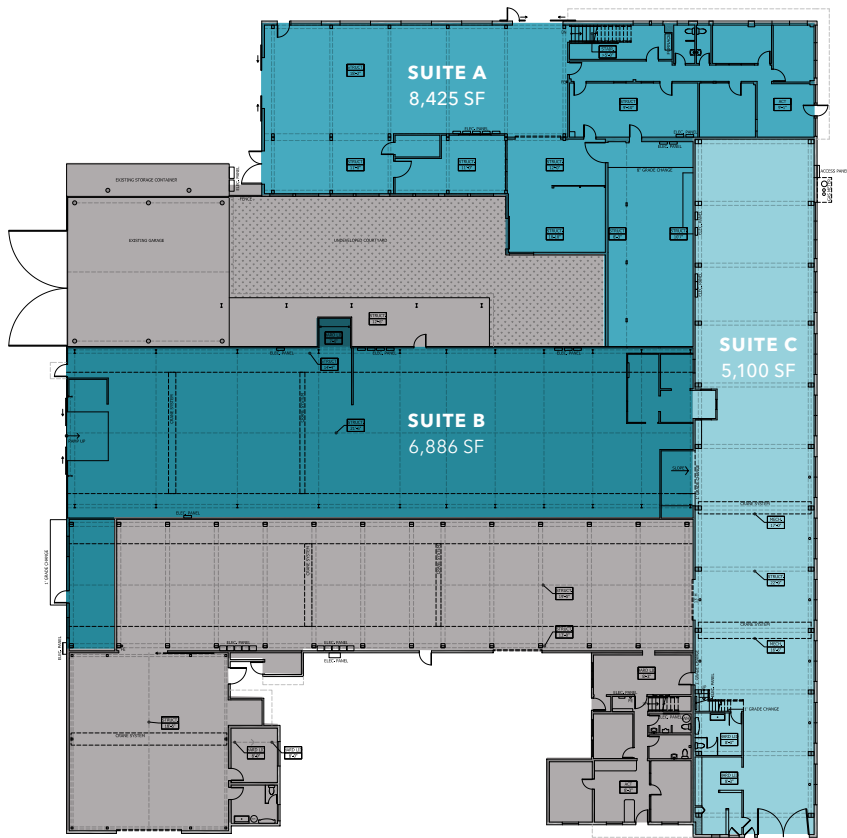

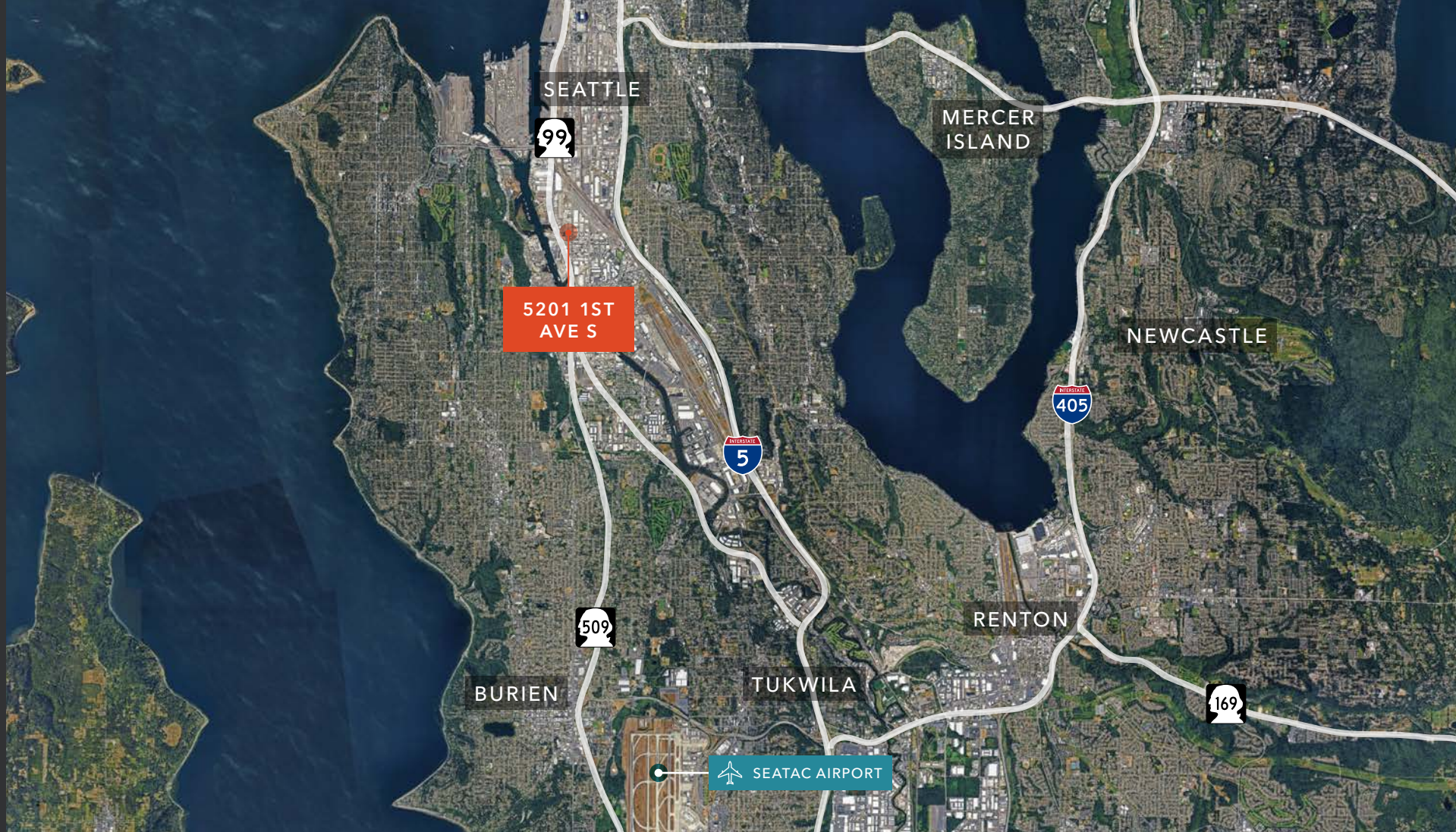
