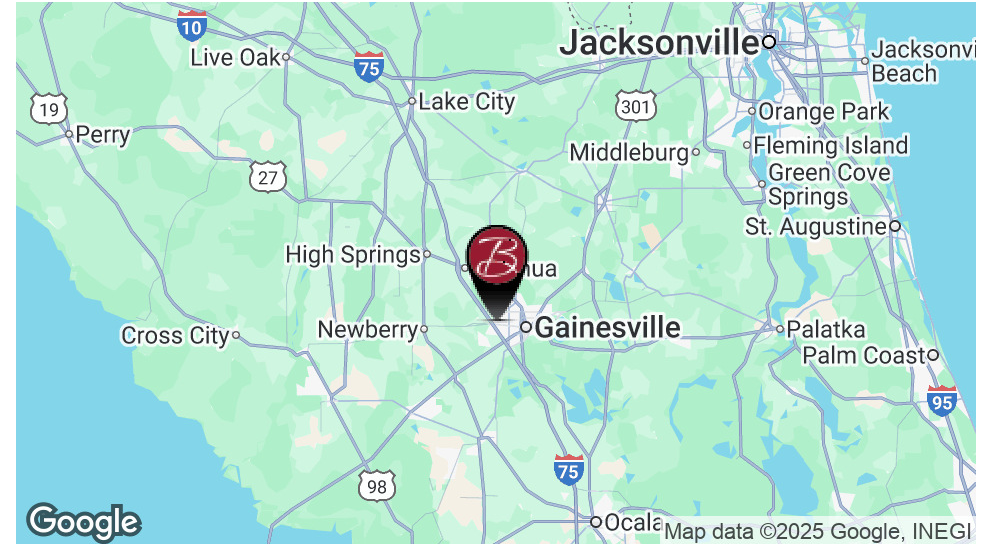

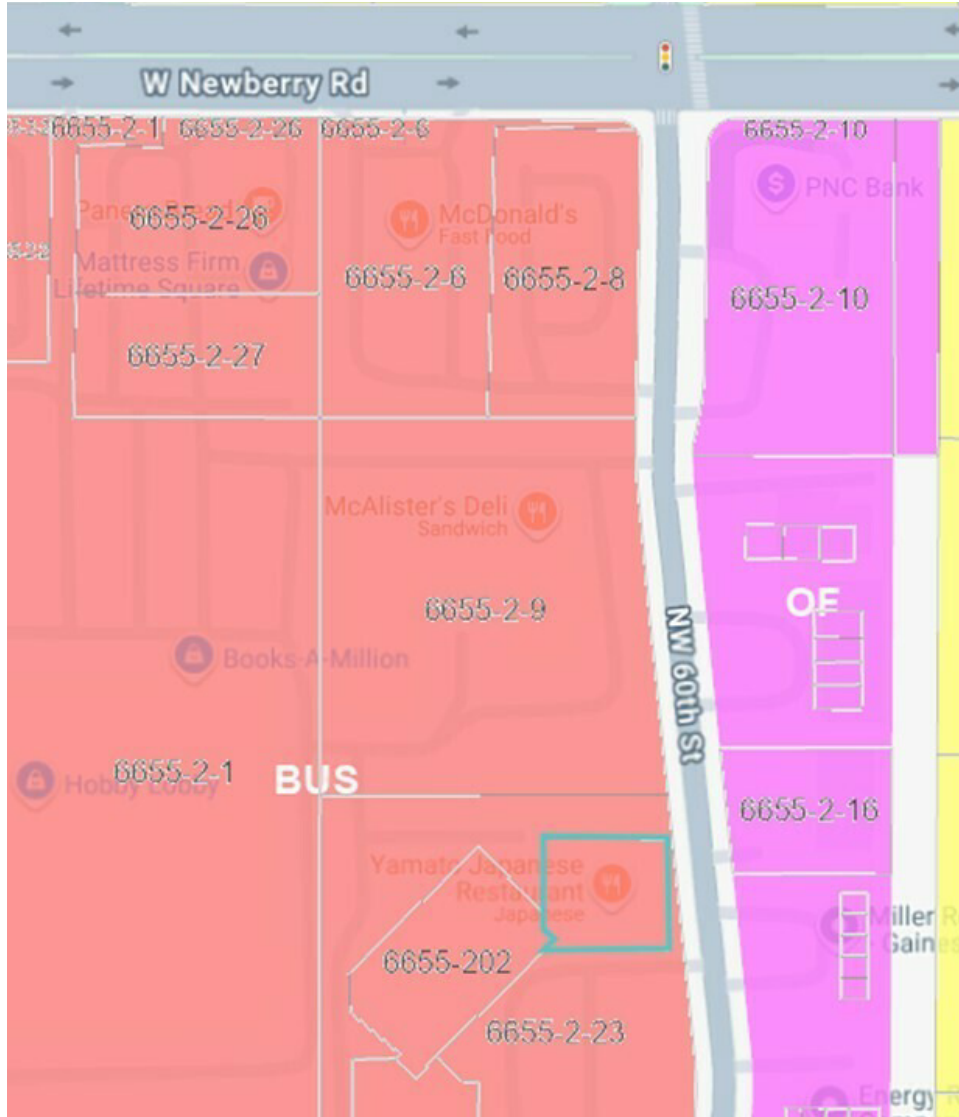

ZONING

BUS (GENERAL BUSINESS)

The BUS (General Business) zoning district in the City of Gainesville is designed to accommodate a wide range of commercial, retail, and service-oriented uses that serve both local neighborhoods and the broader community. It allows for flexibility in business development while maintaining compatibility with surrounding land uses.

Typical permitted uses include retail stores, restaurants, offices, and personal or professional services. Some higher-intensity or automobile-oriented uses, such as drive-throughs or fuel stations, may require a special use permit. Mixed-use projects that include residential components may also be permitted under certain conditions, particularly when aligned with the City's Live Local Act provisions.

Development in the BUS district must follow Gainesville's Land Development Code standards for setbacks, height, buffering, landscaping, and traffic access. Projects adjacent to residential areas may be subject to additional design or operational requirements to minimize impacts. Overall, BUS zoning provides strong commercial flexibility while ensuring orderly growth and compatibility within Gainesville's urban fabric. here...

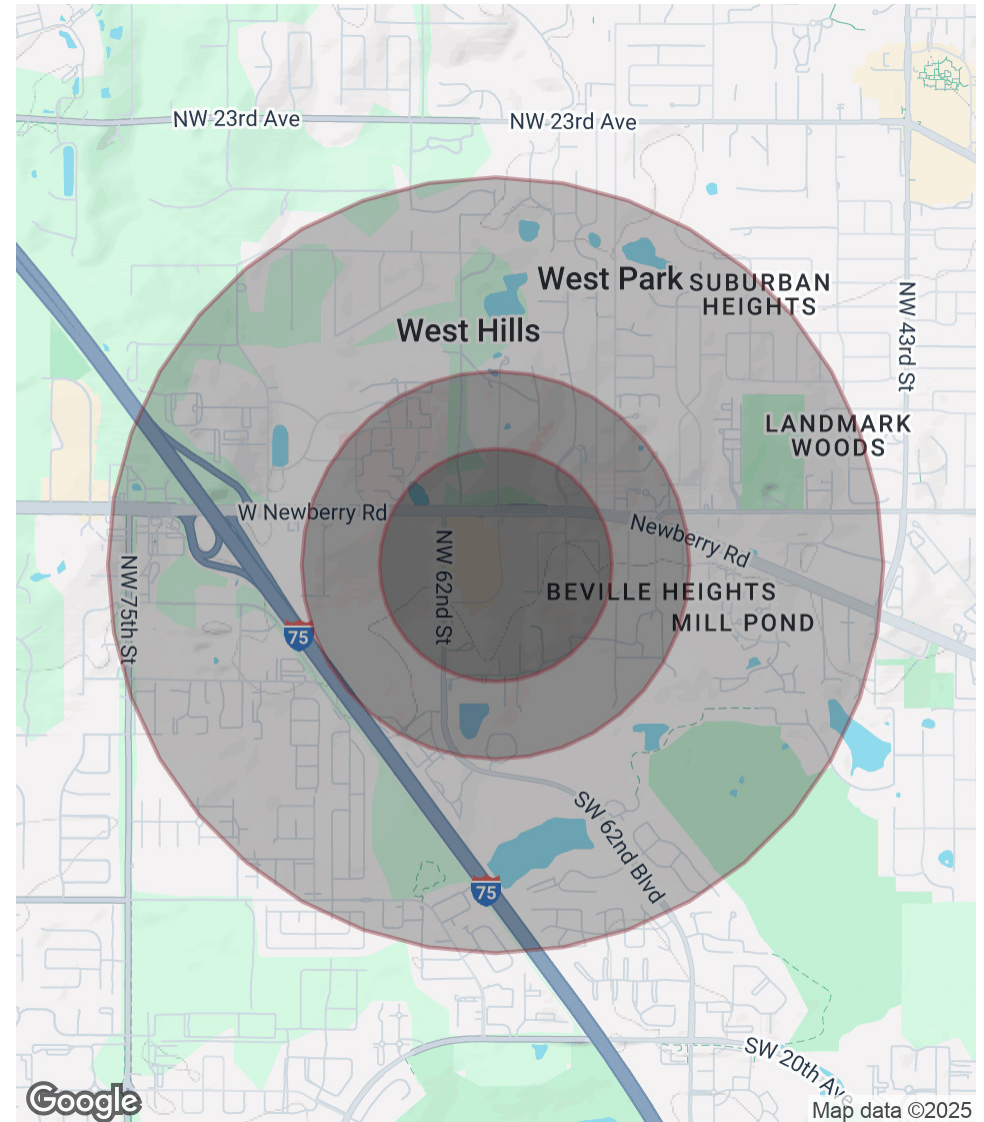
