





# Gardena, CA

Located in the heart of the South Bay submarket of Los Angeles, Gardena offers strategic access to major logistical corridors, including proximity to the Ports of Los Angeles and Long Beach, and key freeways such as the I-110 and I-405. This infill industrial location benefits from limited available land and strong regional transportation connectivity, making it ideal for businesses that rely on efficient goods movement across Southern California.

Gardena supports a stable residential base with a population nearing 60,000. The median household income and home values reflect a balanced economic environment with sustained local demand. The surrounding area is well suited for industrial tenants, manufacturers, and last-mile distribution operations due to its blend of urban density and direct highway access.




## Greater Los Angeles Industrial Market Overview

The Greater Los Angeles industrial market remains one of the most critical logistics hubs in North America, driven by its proximity to the Ports of Los Angeles and Long Beach, the nation's two busiest container ports. This extensive gateway handles over 40% of all U.S. containerized imports, feeding a highly integrated industrial supply chain that stretches inland through the Inland Empire and across the country. The region's industrial inventory exceeds 1 billion square feet, encompassing a wide range of assets from legacy manufacturing plants to modern high-bay distribution centers. With limited land availability and strict zoning, new development remains constrained, keeping vacancy rates among the lowest in the nation despite recent economic headwinds.

## Los Angeles, CA -MSA



### Local Market Overview

Located in Los Angeles County's South Bay region, Gardena benefits from a central position between Downtown Los Angeles and the coastal employment hubs of El Segundo and Torrance. The city maintains a stable residential base supported by diverse industries and convenient access to major transportation routes, including the I-110, I-405, and State Route 91. This connectivity allows businesses and residents to efficiently reach key job centers throughout the Los Angeles Basin.

As a built-out infill community, Gardena offers long-term stability with limited new development opportunities, supporting sustained demand for commercial and industrial space. The surrounding South Bay area is driven by aerospace, manufacturing, healthcare, and professional services employment, reinforcing a strong workforce presence. Its proximity to one of the nation's largest consumer markets positions Gardena as a strategic and dependable location for a range of industrial and business users.

### Economic Drivers

Gardena's economy is supported by its infill location within the South Bay industrial corridor, a critical component of the Greater Los Angeles logistics network. Close proximity to the Ports of Los Angeles and Long Beach, Los Angeles International Airport, and multiple freeway systems enables efficient goods movement and regional distribution. The broader South Bay economy is anchored by aerospace, advanced manufacturing, healthcare, and trade-related industries, with major employers located in nearby El Segundo, Torrance, and Carson. Access to a deep labor pool and integrated transportation infrastructure continues to drive long-term demand for industrial and flex space in the area.
