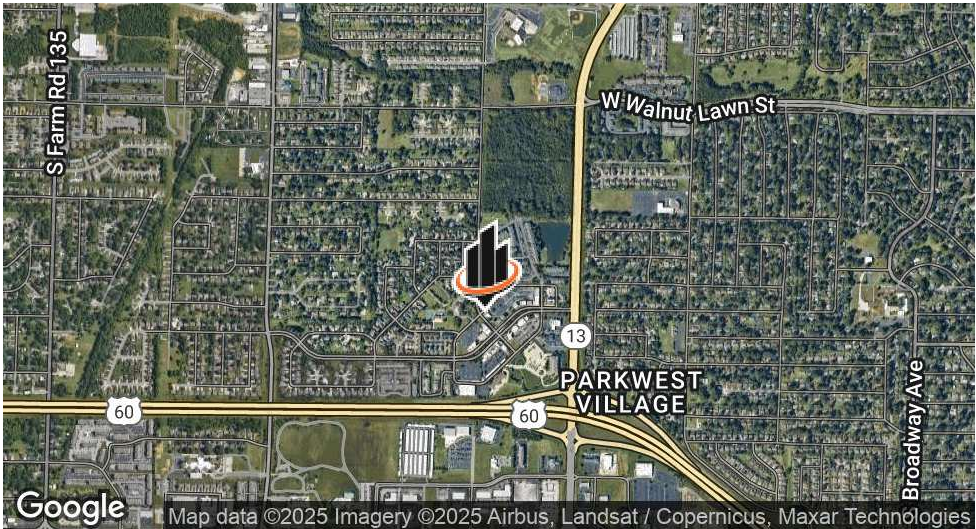

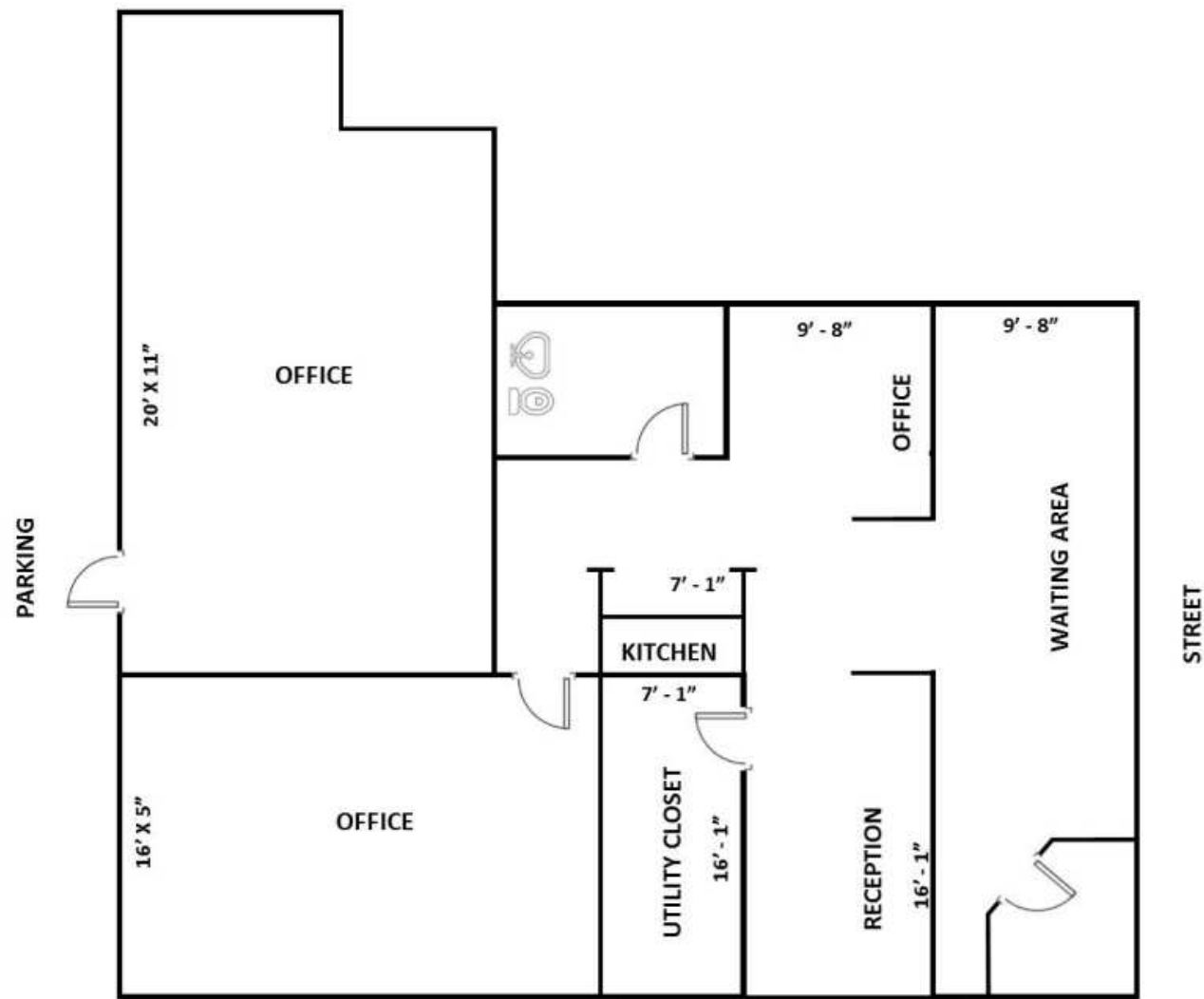

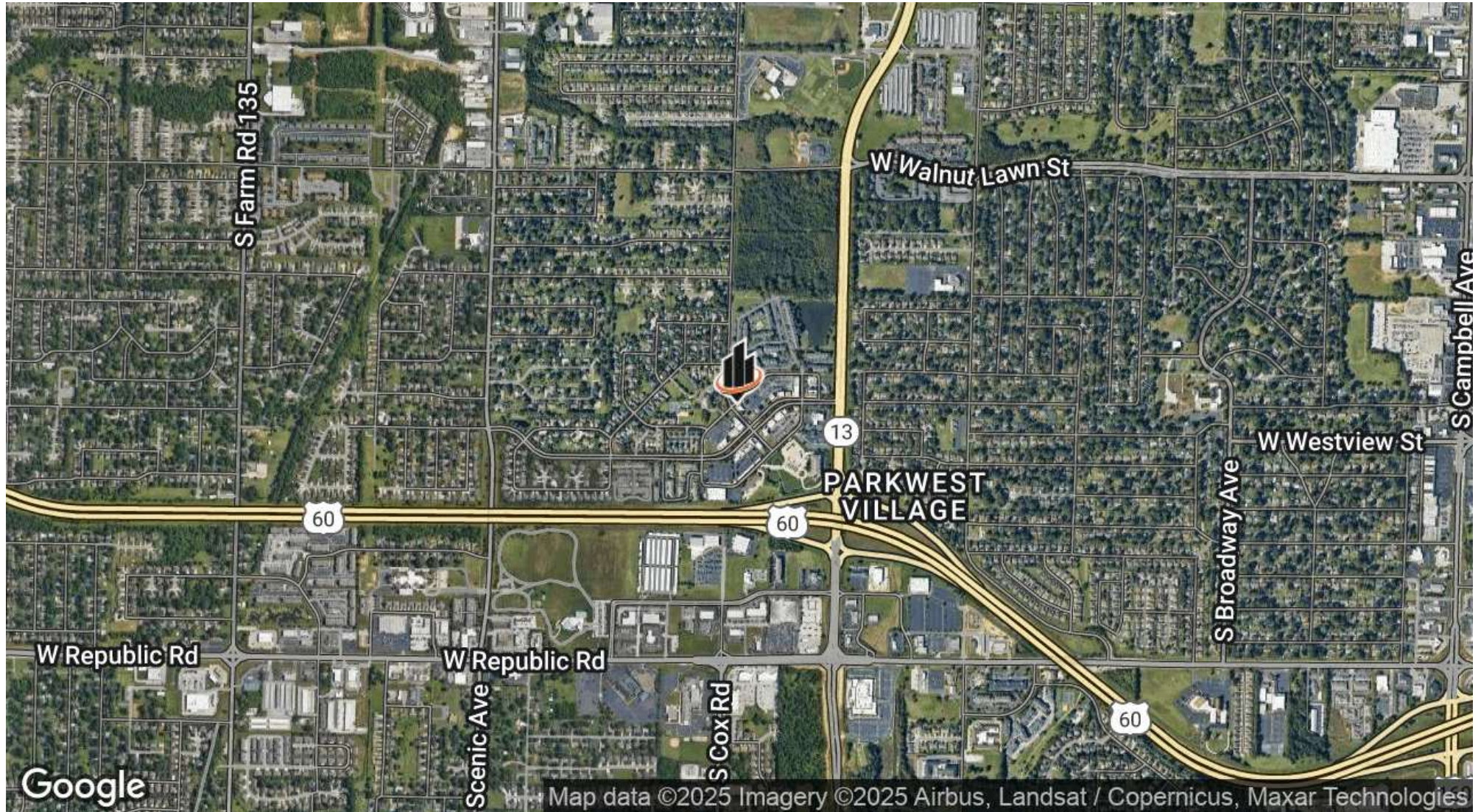
FLOOR PLAN

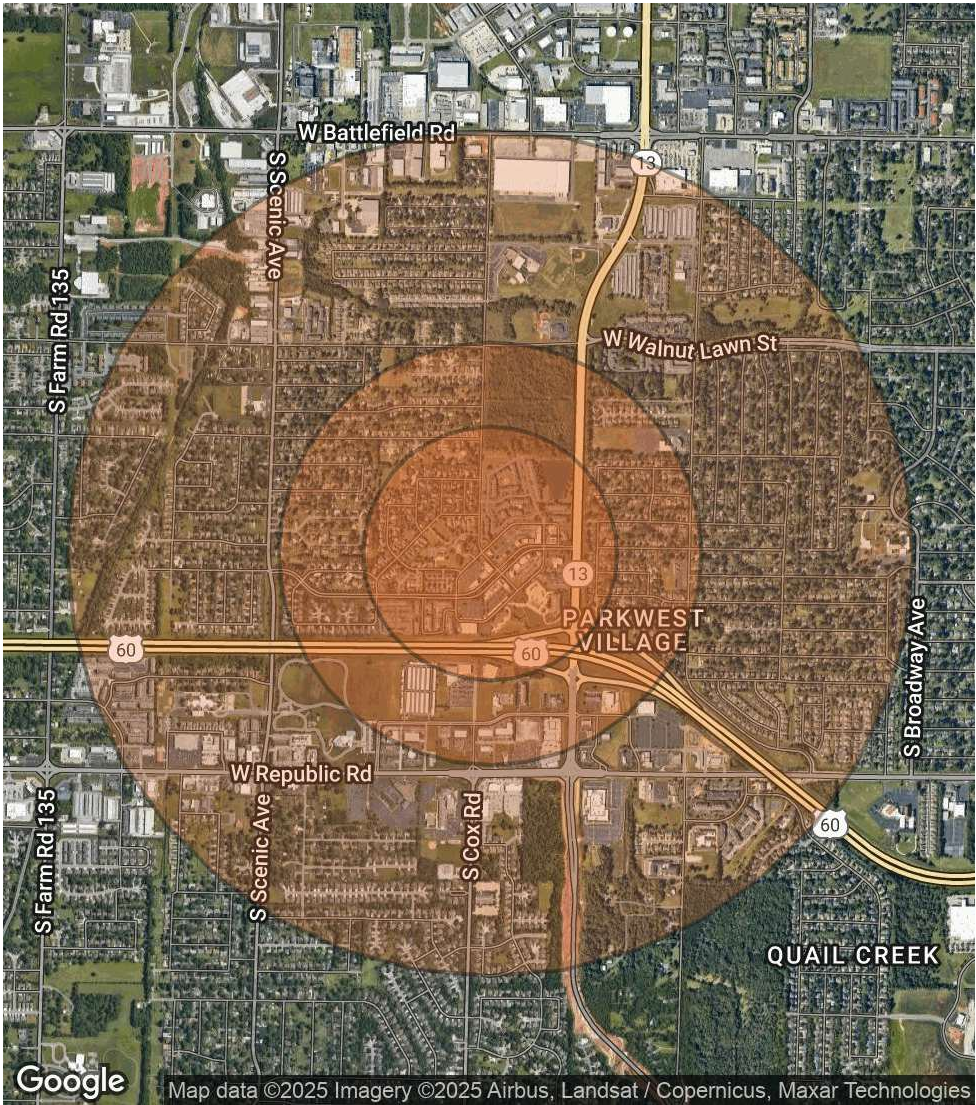
