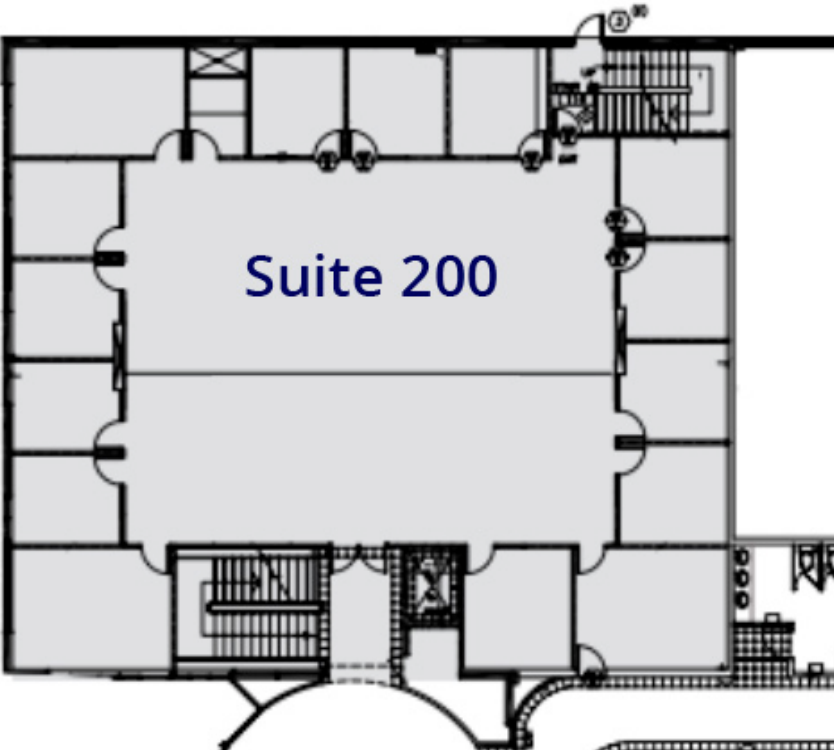

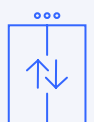

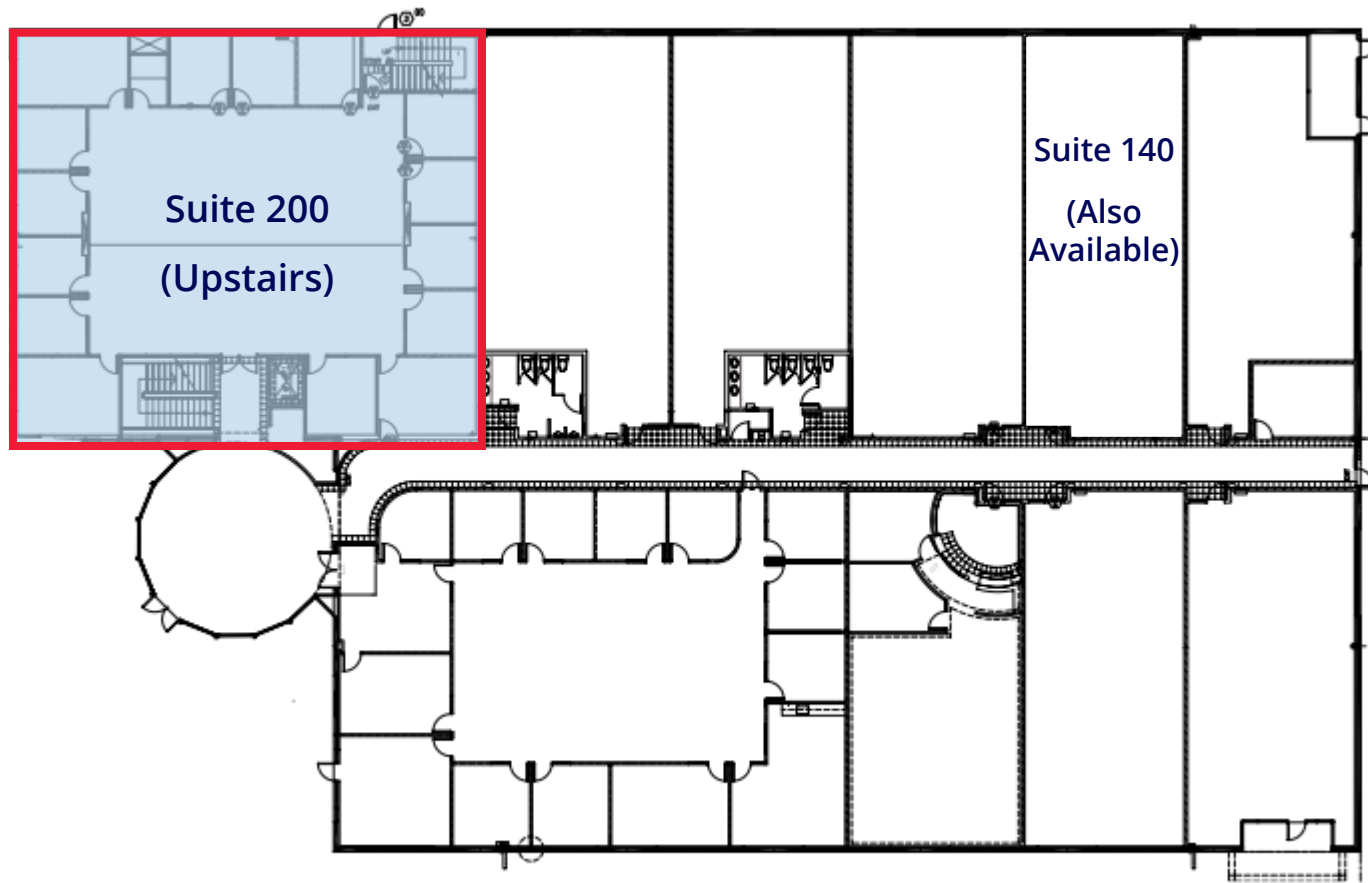


Grand Rotunda Entrance with Dome Skylight

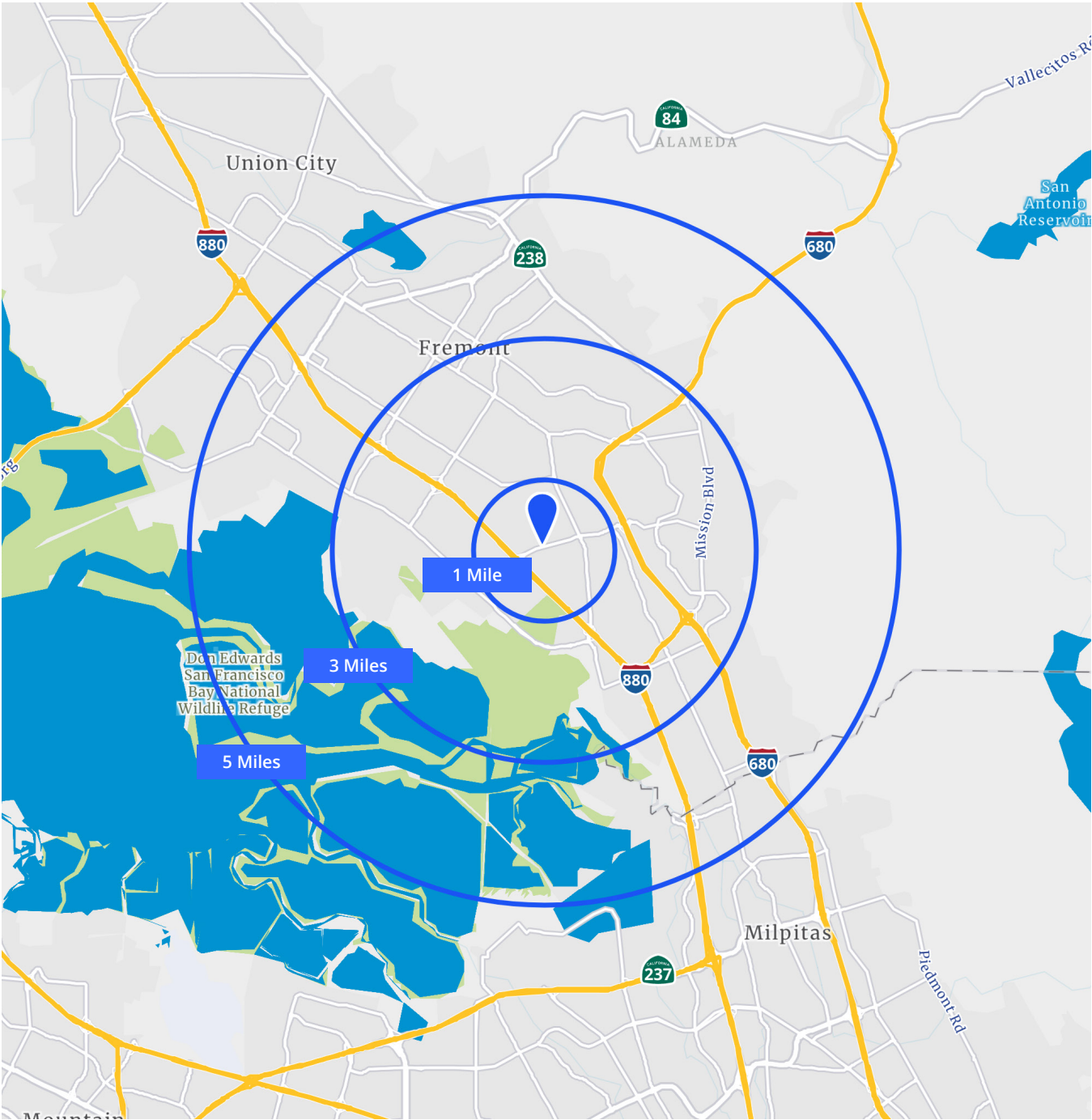

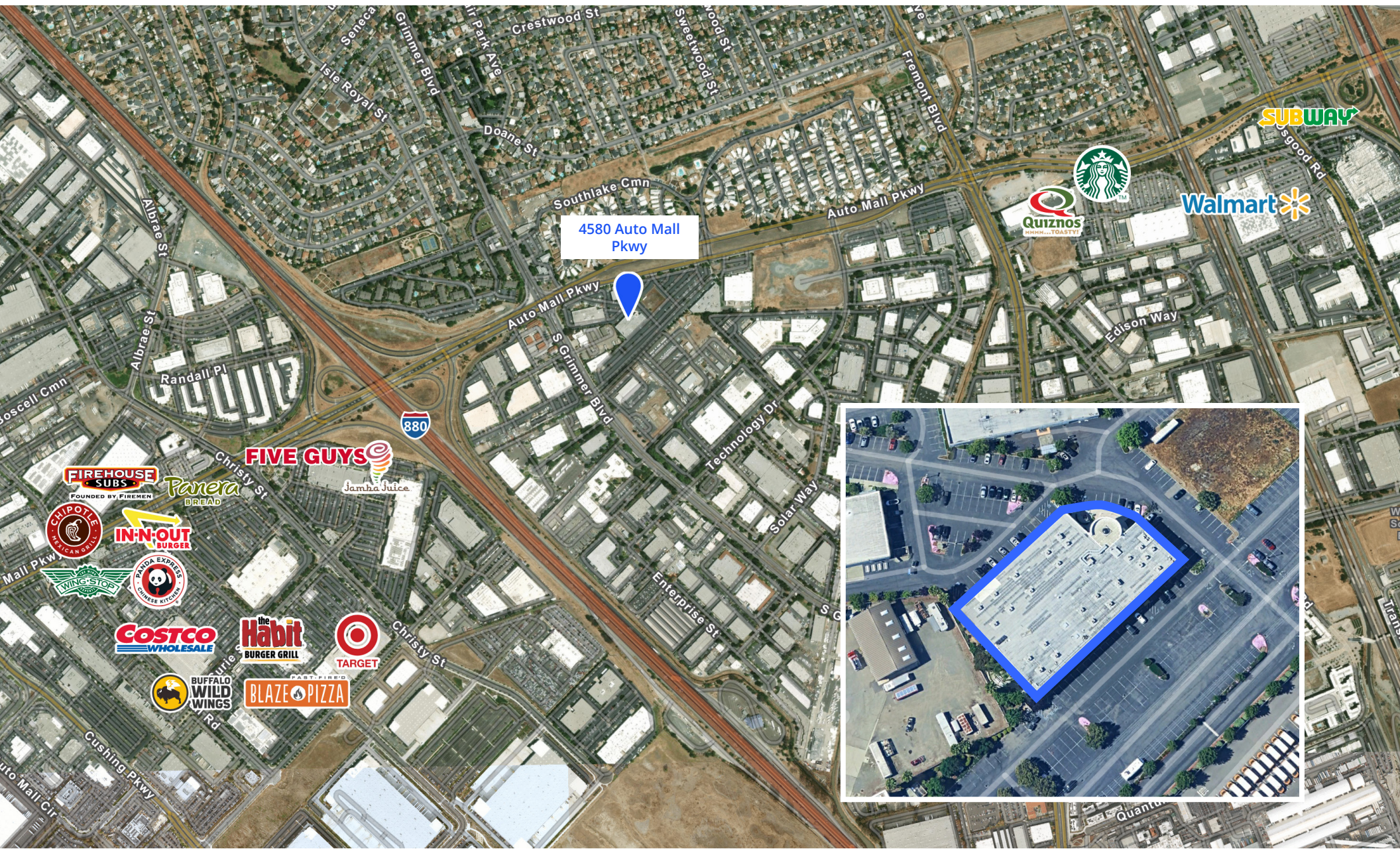
