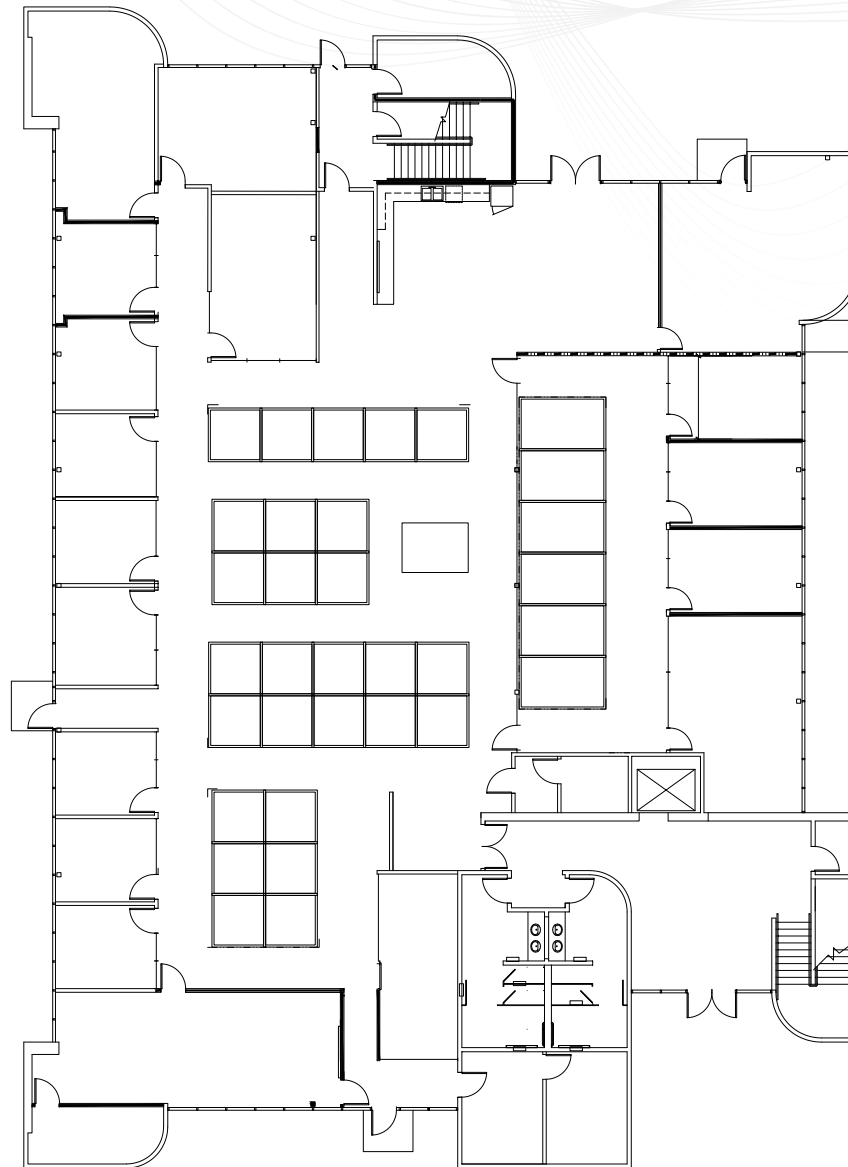

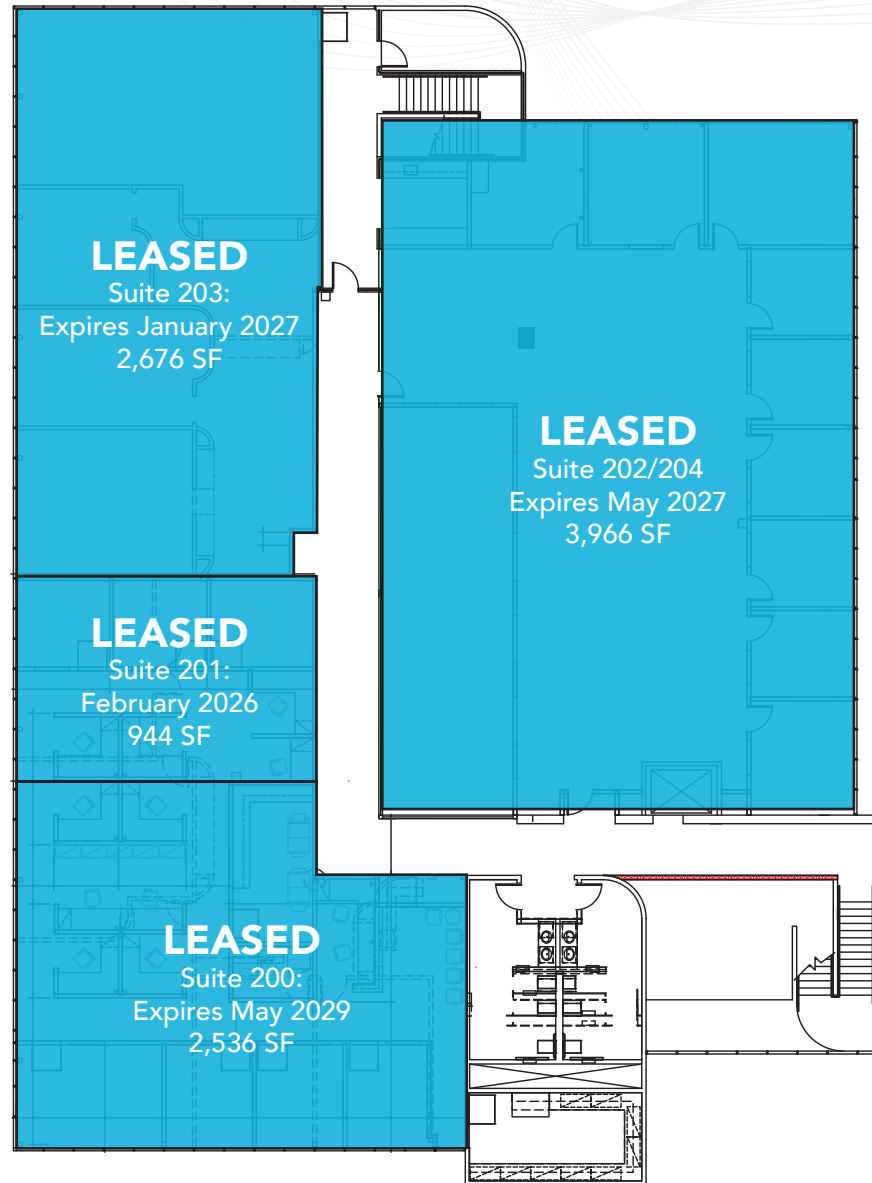


FIRST FLOOR FLOORPLAN
