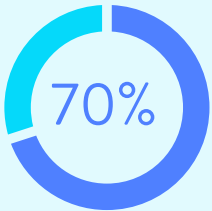

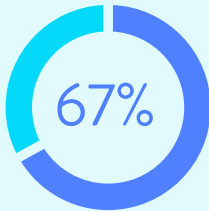

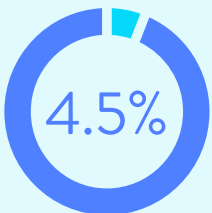
Estimated Average Household Income (2025)



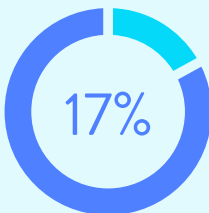
