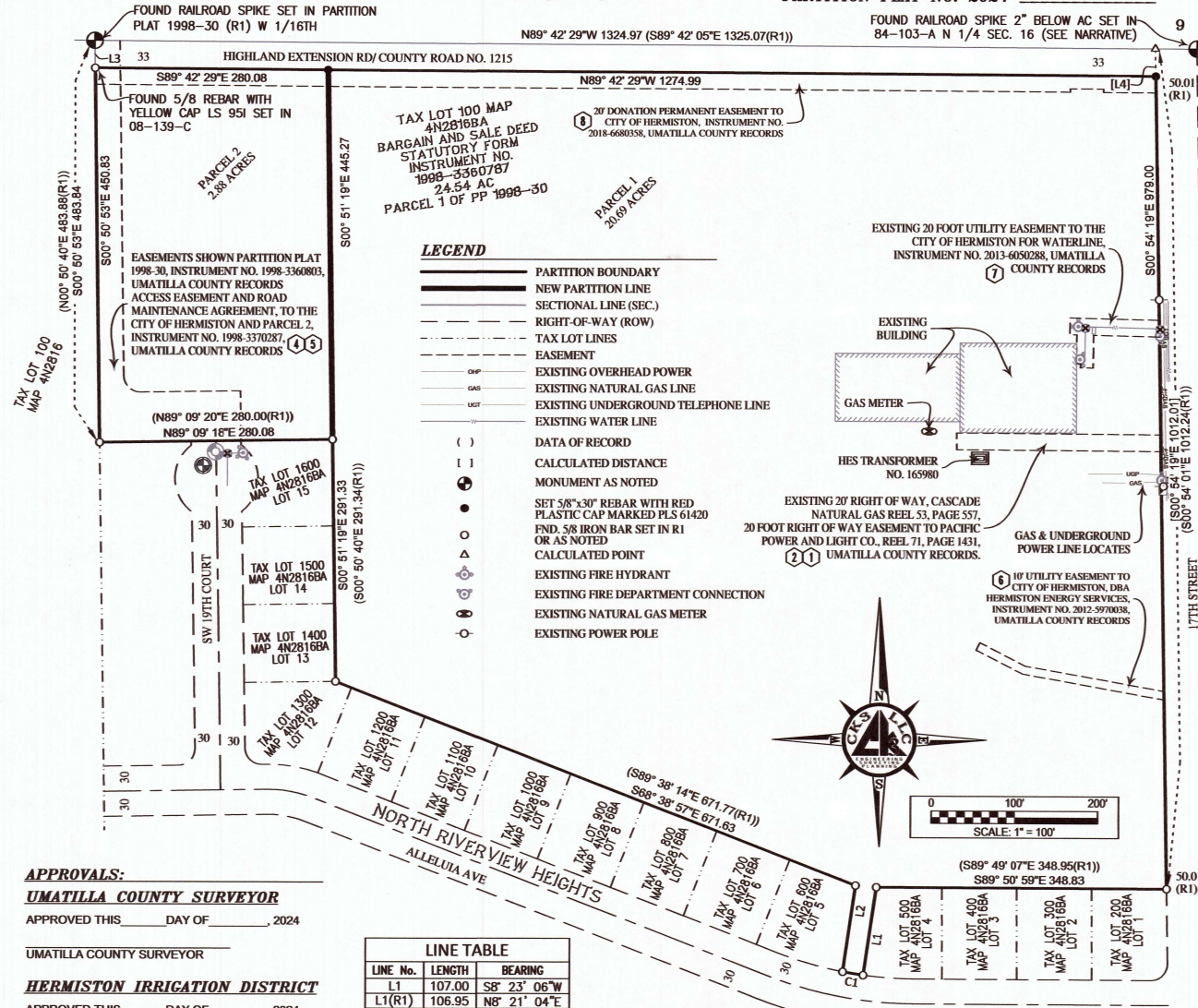


TENTATIVE PARTITION PLAT of PARCEL 1 OF PARTITION PLAT NO. 1998-30

SURVEYOR'S NARRATIVE & CERTIFICATE

THIS SURVEY WAS MADE AT THE REQUEST OF COREY GRIGGS OF HERMISTON CHRISTIAN CHURCH, FOR THE PURPOSE OF PARTITIONING A PARCEL OF LAND AS DESCRIBED AS PARCEL 1 IN PARTITION PLAT 1998-30, CREATING A 20.69 ACRE PARCEL, AND A 2.88 ACRE PARCEL, AS APPROVED BY HERMISTON CITY PLANNING DEPARTMENT.

CONTROL FOR THIS SURVEY IS BASED ON FOUND MONUMENTS FROM R1 & R2. THE BASIS OF BEARINGS FOR THIS SURVEY IS BASED ON THE OREGON COORDINATE REFERENCE SYSTEM:

THIS PARCEL WAS ORIGINALLY SURVEYED IN MARCH OF 1998 BY FERGUSON SURVEYING ENGINEERING, FOR FOR SANTIAM PROPERTIES, LLC, AS SHOWN ON (R1) THE BOUNDARY LINES WERE ESTABLISHED IN SAID SURVEY AND RECOVERED HERE, CURVE C1 BETWEEN FOUND PINS IS NOT A TANGENT CURVE.

REGARDING THE N1/4 SECTION 16 (J-11) AND SURVEY NO. 22-006-C. ON 8/29/2024 MR. KRUMBEIN WAS CONTACTED REGARDING SAID CORNER ADDITIONALLY MR. PRIMM WAS AS WELL BUT NEVER RESPONDED. THIS IS A DUAL STAMPED DOCUMENTS AS OUTLINED IN OAR 820-025-025 (LACKING IN WORK PRODUCT SPECIFICITY). MR. KRUMBEIN STATED AS COUNTY SURVEYOR THE RRR SPIKE AS NOTED IN SAID SURVEY IS THE CORNER AND RECOGNIZED AS THE OFFICIAL CORNER MONUMENTS. MR. KRUMBEIN ALSO STATED THAT FOR FUTURE REFERENCE THE TABLE LABELED "CORNER VISITED" ON SAID SURVEY PROVIDING COORDINATES ARE THE CORNERS/MONUMENTS ACCEPTED AND RECOGNIZED AS OFFICIAL BY THE COUNTY SURVEYORS OFFICE BUT THAT THE COMMENTS COLUMN SHOULD BE IGNORED AS IT CONFUSES THE ISSUE. MR. KRUMBEIN MENTIONED HE PLANS TO ADD SOME NOTES AND EXPLANATIONS TO SAID SURVEY AT SOME POINT.

I LANCE C. KING, A REGISTERED PROFESSIONAL LAND SURVEYOR HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND FOUND THE MONUMENTED THE BOUNDARIES OF PARCELS 1, 2, AND 3 IN ACCORDANCE WITH ORS CHAPTER 92. THAT THE POINT OF BEGINNING IS A SHOWN ON THE MAP AND IS WITHIN THE REQUIREMENTS OF ORS 92.060(1). I CERTIFY THAT THE FIRST MONUMENT ESTABLISHING OR REESTABLISHING A BOUNDARY MONUMENT WAS PLACED ON 7/7/77/77. THAT THE ADJOINING PROPERTY AND ALL PROPERTY ACCESSED IN THIS SURVEY WAS DONE IN ACCORDANCE WITH ORS 672.047, THAT THE SURVEY WAS MADE BY ME OR UNDER MY DIRECTION, THAT THE MONUMENTS ARE AS SHOWN AND THAT THIS MAP IS A TRUE AND ACCURATE REPRESENTATION OF SAID SURVEY.
