The property has undergone substantial renovations and improvements and offers a versatile layout featuring 10+ private offices, a former school/day-care classroom, canopied outdoor patio space, ample gated parking for up to 14 vehicles, a full kitchen with gas appliances, and ADA-compliant bathrooms on each floor. The building is currently configured primarily for office use but also presents potential for street-front retail or showroom space.

Additional property highlights include upgraded building systems, fire sprinklers throughout, roll-up gates, updated roofing and power infrastructure, two (2) 50-amp EV electric car chargers, five (5) updated HVAC units, and more.

The property benefits from exceptional surrounding amenities including Sycamore Village, Heimat Fitness Club, Tartine, Gigi's Restaurant, SiriusXM offices, Tesla Diner, and Sprouts Farmers Market.

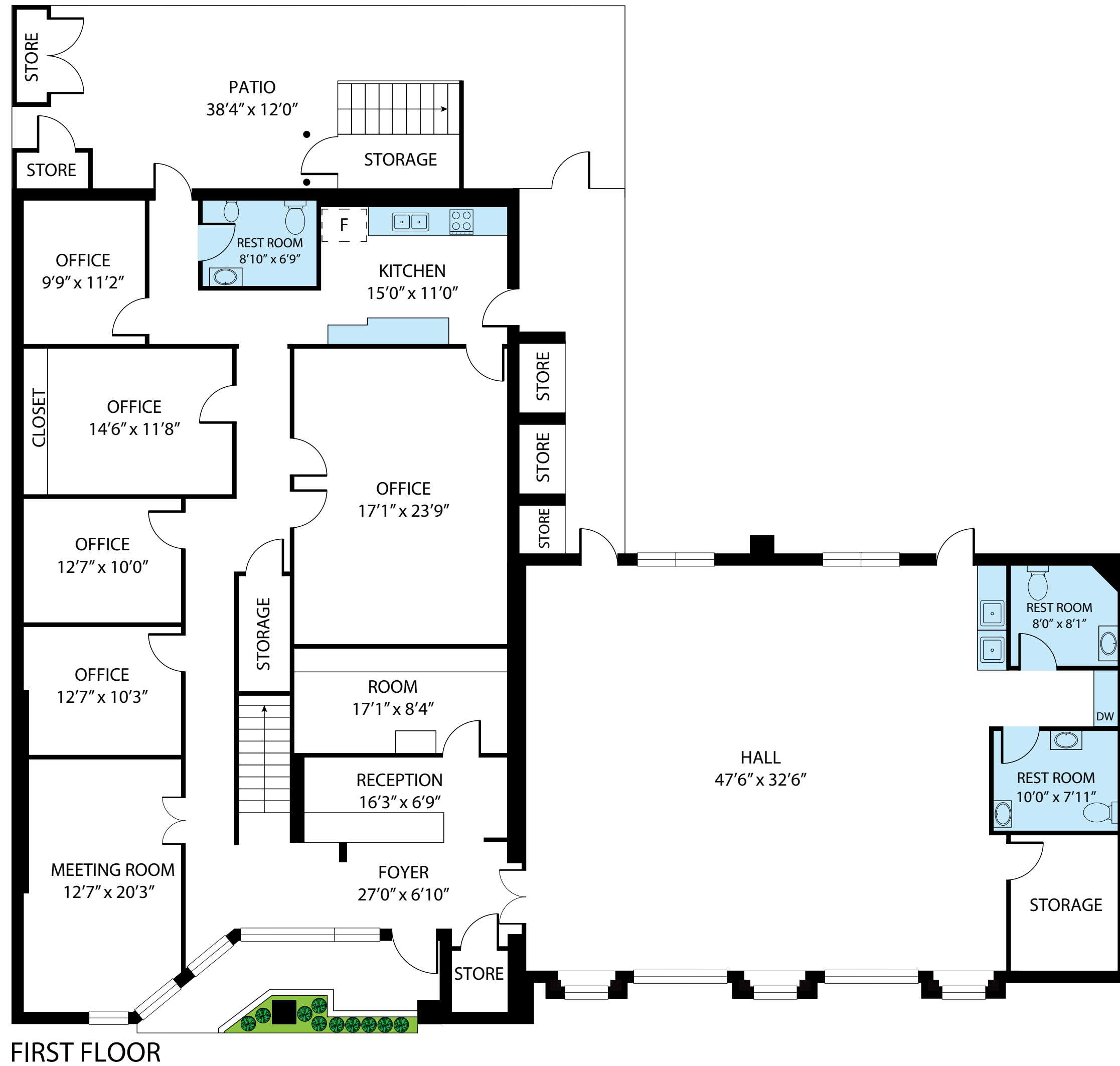

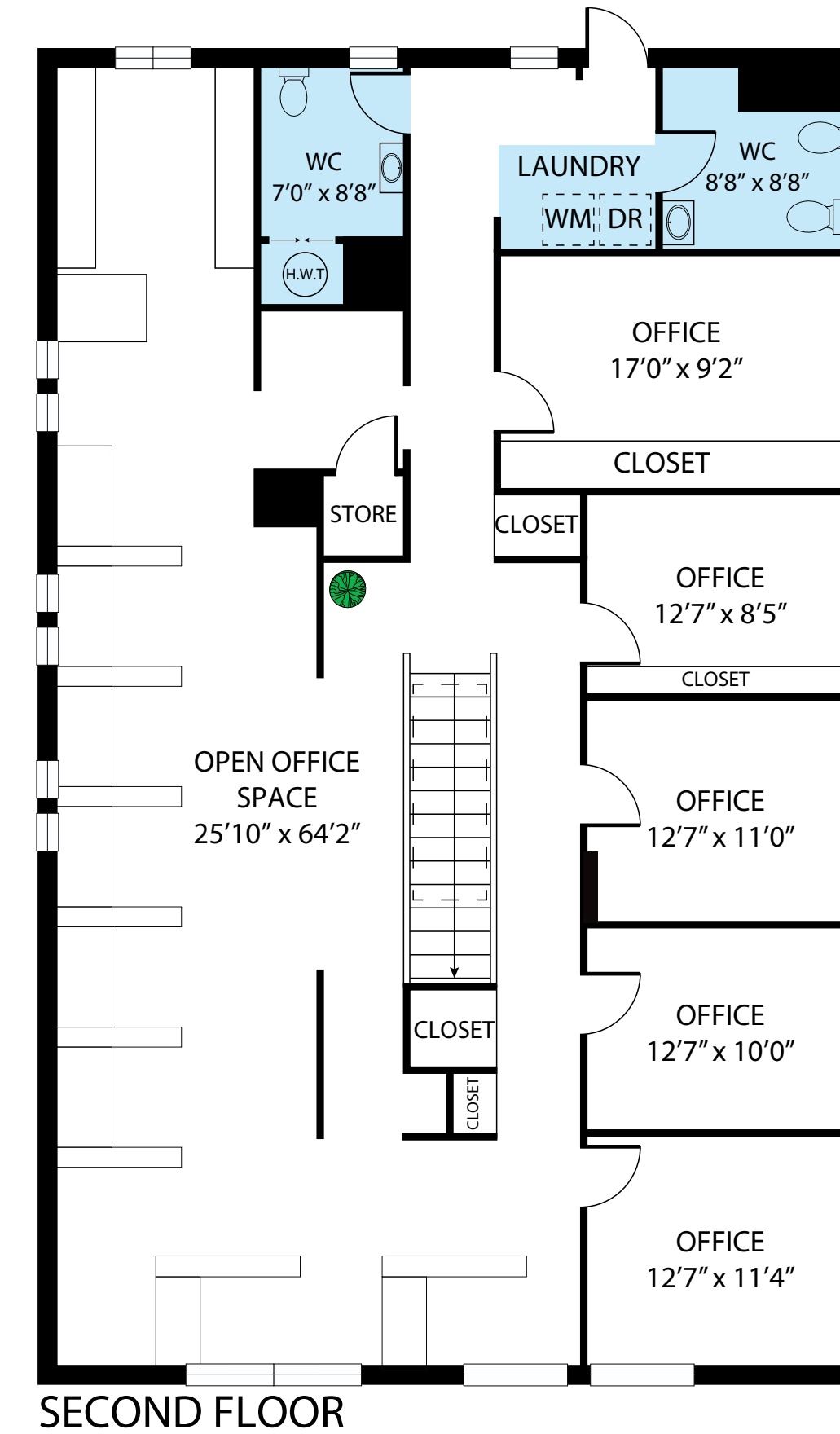
