

## RIVERSIDE LANDMARKS

Riverside is home to the historic Mission Inn, the Beaux-Arts style Riverside County Historic Courthouse (based on the Petit Palais in Paris, France), and the Riverside Fox Theater, where the first showing of the 1939 film *Gone with the Wind* took place. The theater was purchased by the city and refurbished as part of the Riverside Renaissance Initiative. The Fox Theater underwent extensive renovation and restoration, which was completed in 2009, to turn the old cinema into a performing arts theater. The building was expanded to hold 1,600 seats and the stage was enlarged to accommodate Broadway-style performances.
