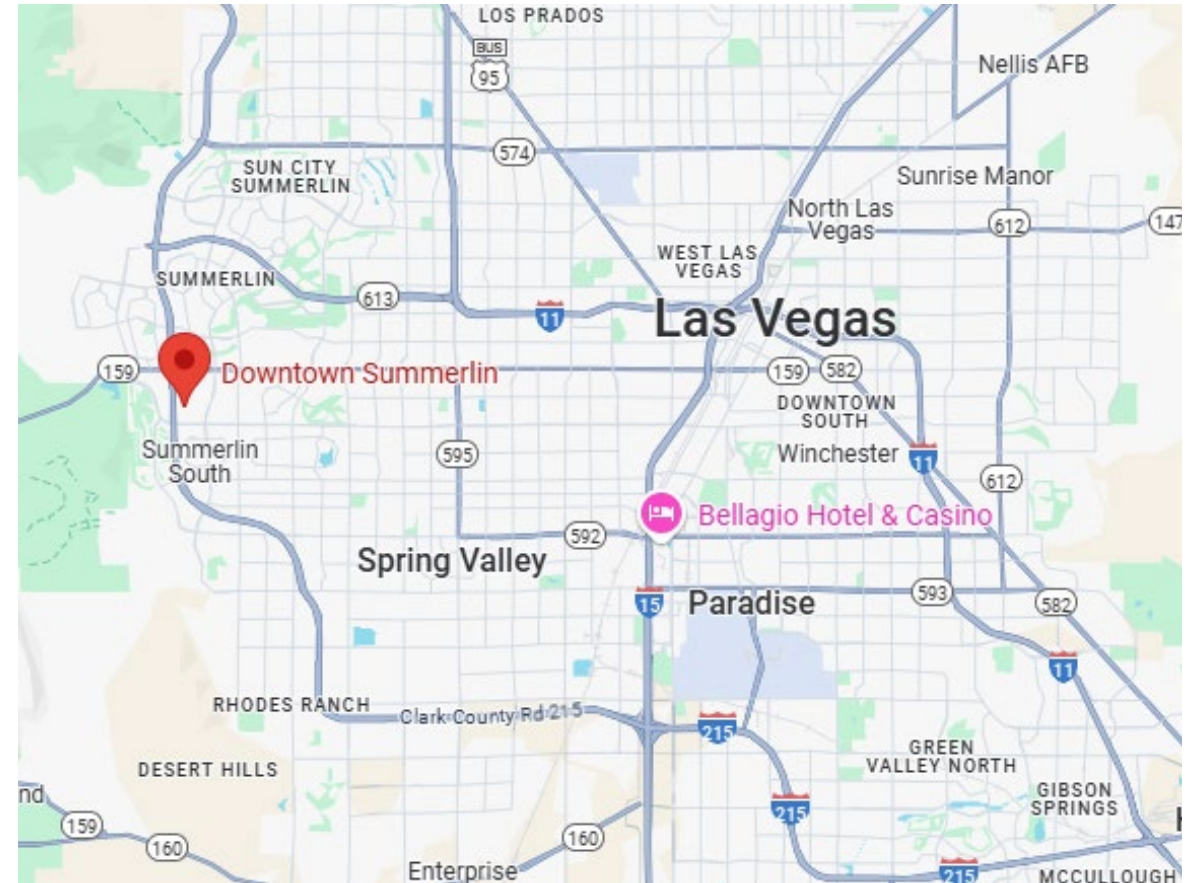

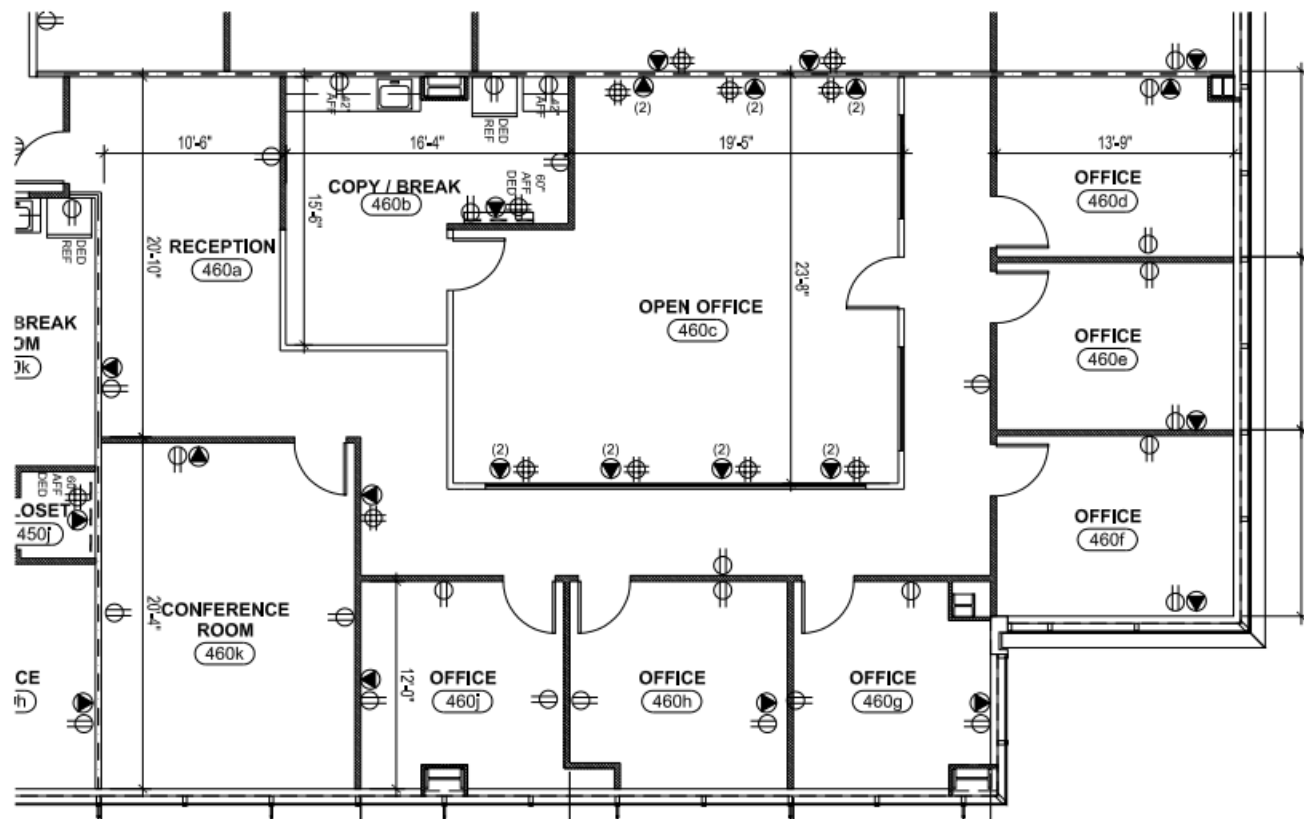
Location Information

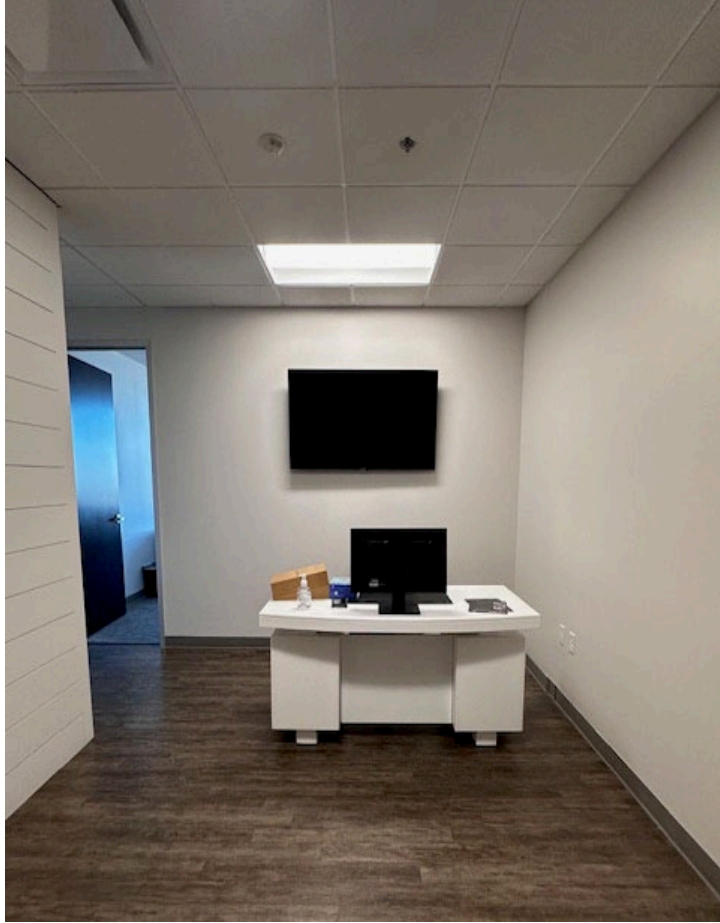

- The office is complemented by a professional reception area, ideal for greeting clients and visitors.

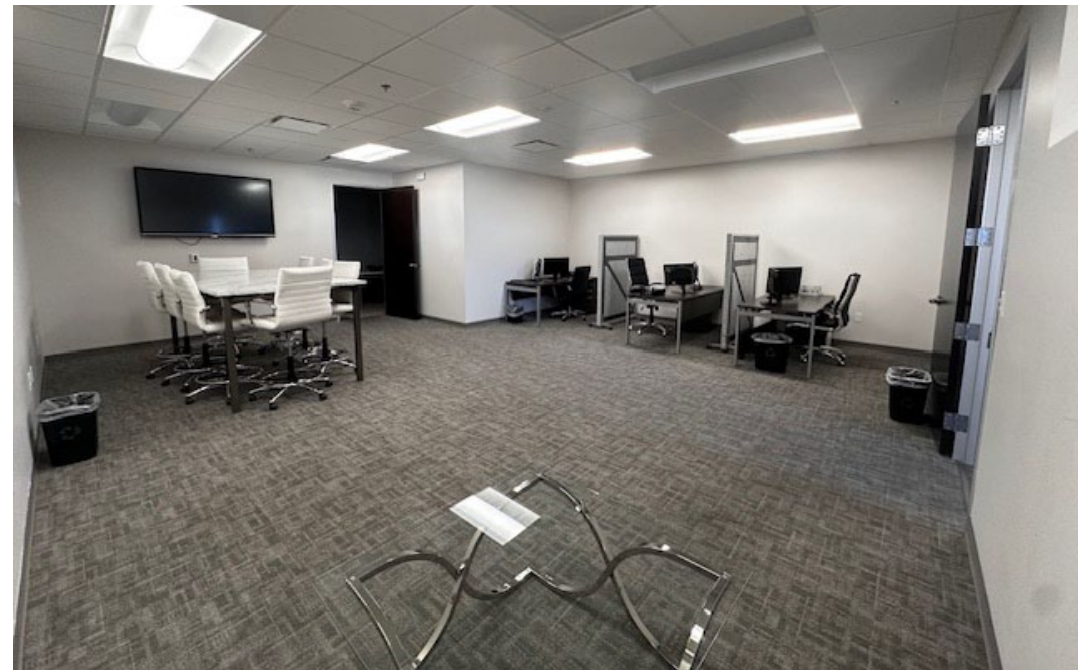


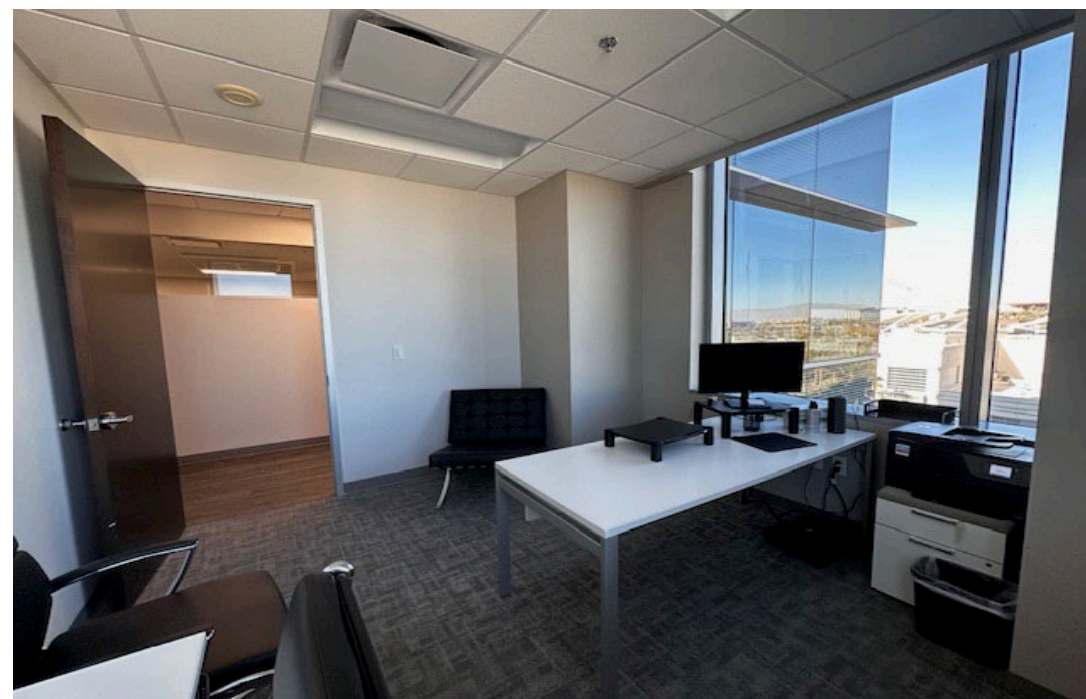
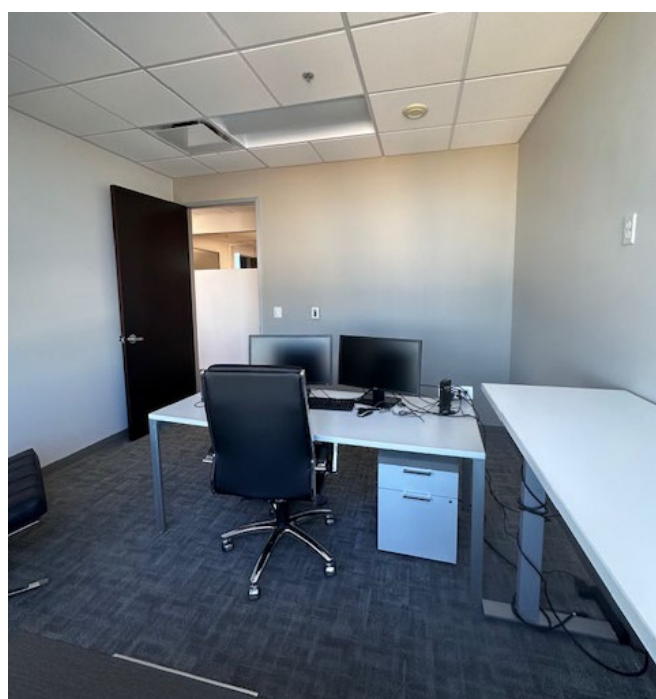
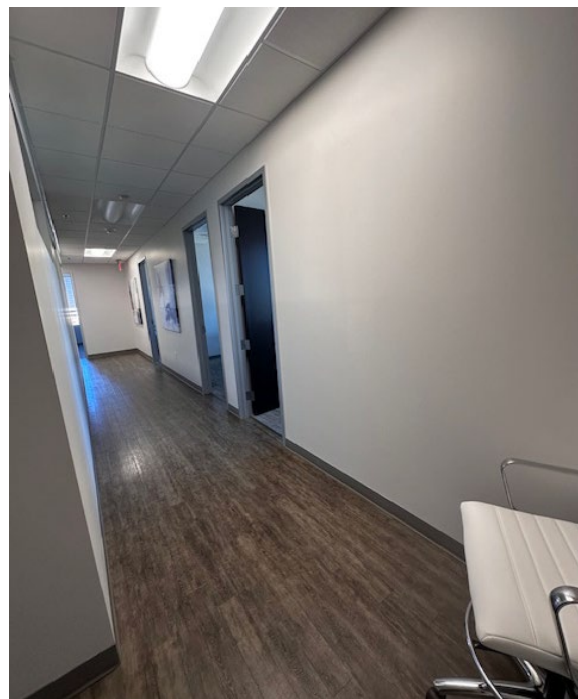
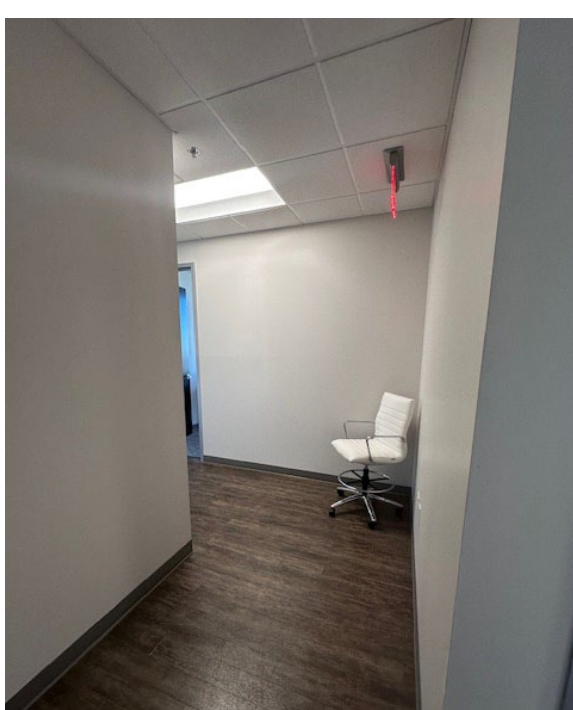
