## PROPERTY HIGHLIGHTS

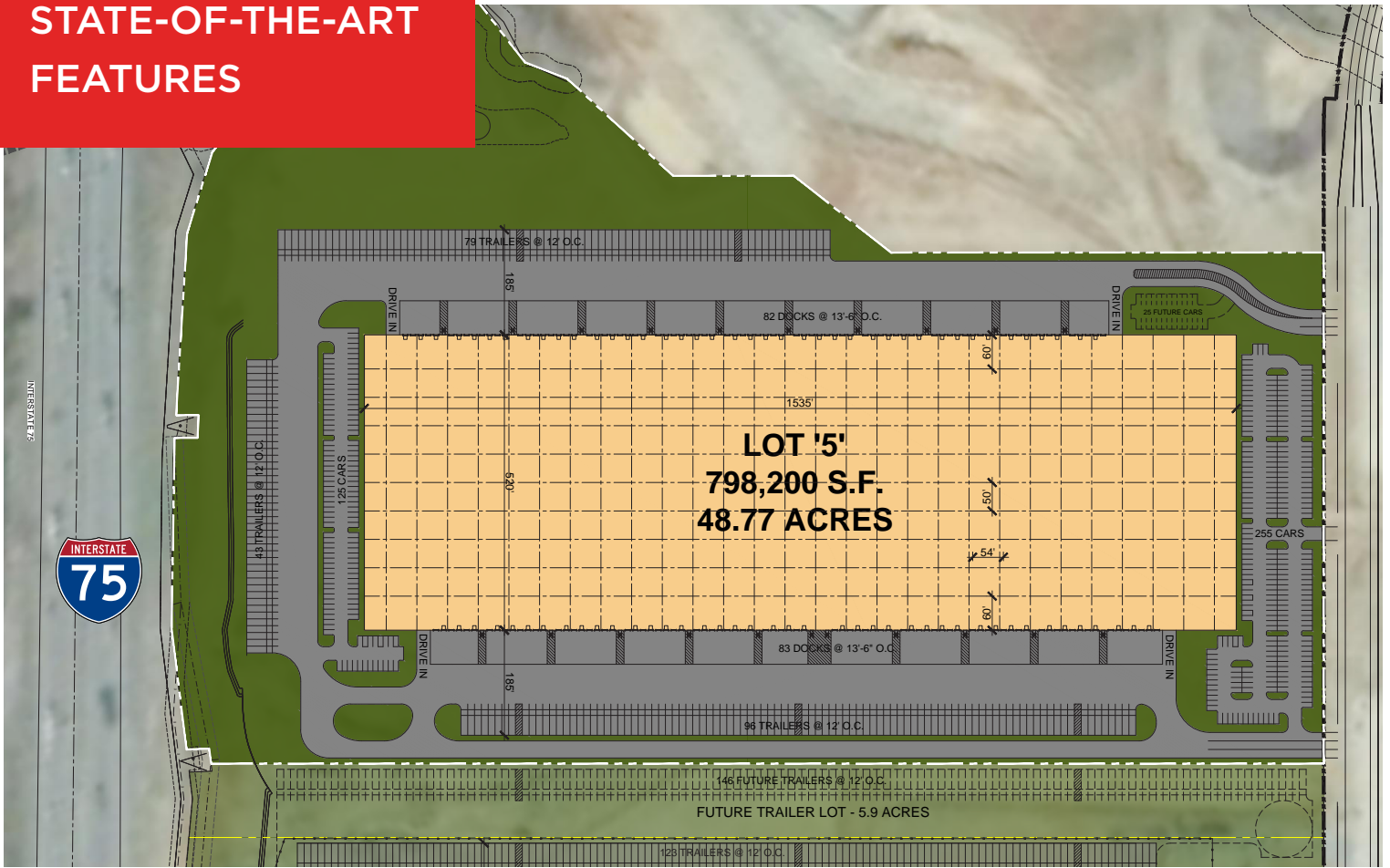
- Immediate access to Interstate 75 (two turns)

## TAX INCENTIVES

- 40' Clear height at first column
- Office: BTS
- Building dimensions: 520' x 1,535'
- Column spacing: 54' x 50' with 60' speed bays
- ESFR sprinkler system
- Spec improvements:
  - Dock equipment: 40,000 lb mechanical levelers, Z-Guards and dock seals on 89 dock doors
  - Lighting: minimum 25 FC LED fixtures on 12' whips
- 165 – 9' x 10' dock doors
- 4 – 14' x 16' drive-in doors
- 185' deep truck courts
- 218 trailer spaces
- 380 auto spaces (25 future spaces)
- 7" unreinforced slab, 4,000 psi

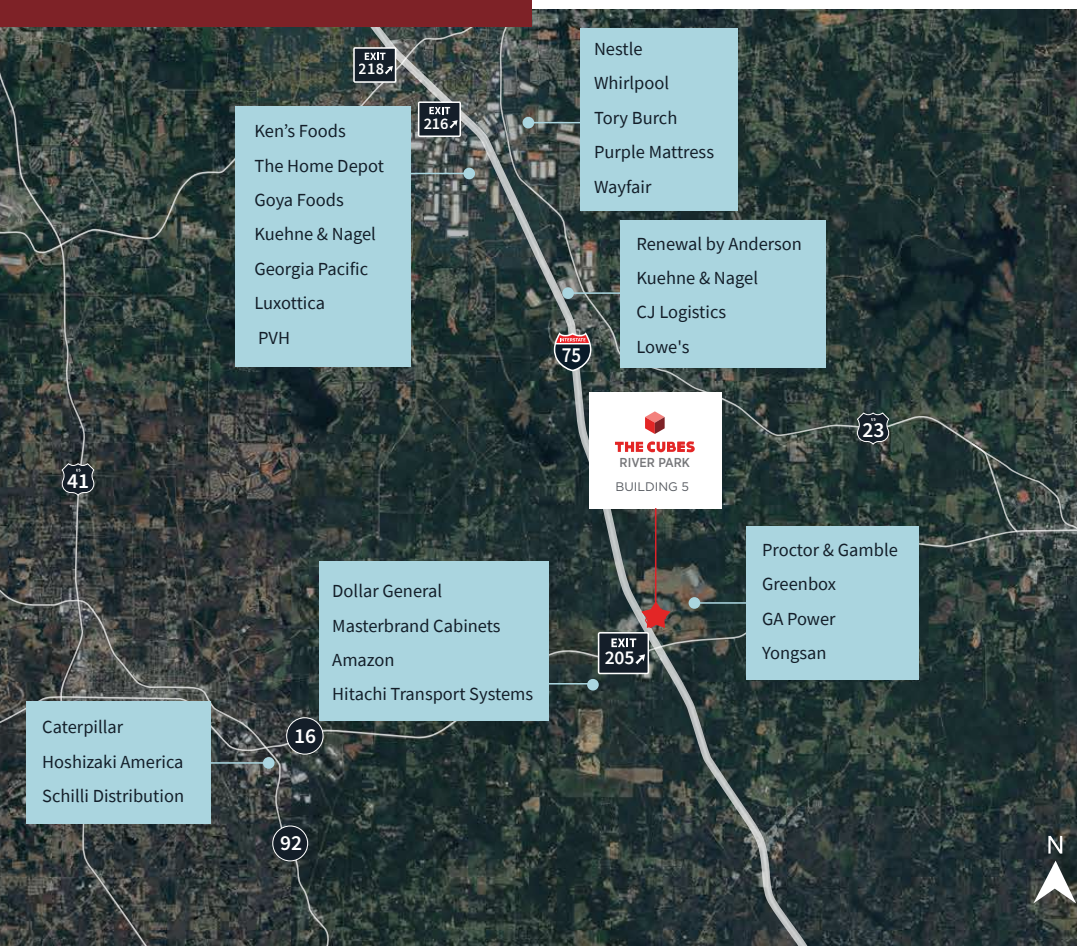

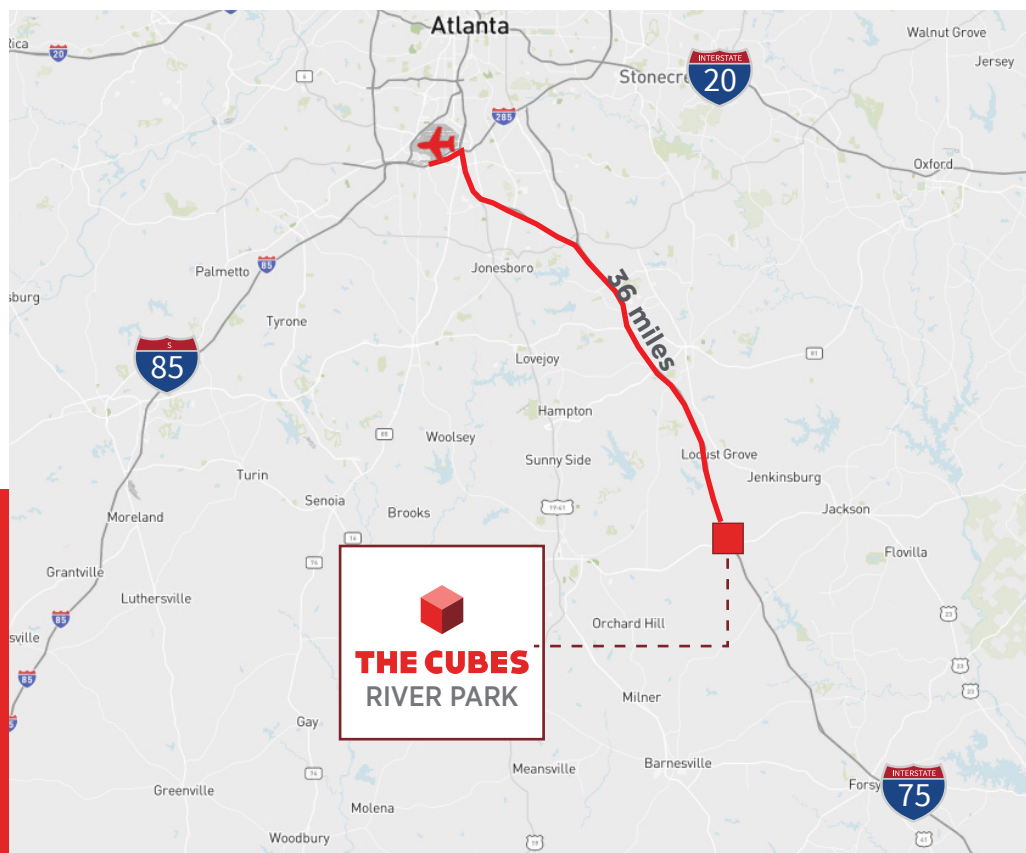
