BEGINNING at a 1" steel pipe found on the intersection of the South right of way line of a dedicated road named Wespark Circle and the East right of way line of a dedicated road named Wespark Drive; said 1" steel pipe being the Northwest corner of said Lot 1 and the Northwest corner of the herein described tract; having a State Plane Coordinate of N: 13944439.14, E: 3492524.17;

THENCE, South 48 deg., 49 min., 01 sec., East (Called South 46 deg., 19 min., 30 sec., East), on the South right of way line of said Wespark Circle, a distance of 325.26' (Called 325.24') to a 1" steel pipe found for a common corner of Lots 2 and 3, of said Willow Creek Commercial Park; said 1" steel pipe being the Northeast corner of the herein described tract; having a State Plane Coordinate of N: 13944224.96, E: 3492768.97;

West), on the common line of said Lots 2 and 3, a distance of 213.05' (Called 212.95') to a ½" steel rod found for a common corner of Lots 2 and 3 on the North line of Lot 4, Block 1, Willow Creek Commercial Park, recorded in Volume 12, Page 79, Map Records, Jefferson County, Texas; said ½" steel rod being the Southeast corner of the herein described tract;

THENCE, South 39 deg., 04 min., 47 sec., West (Called South 41 deg., 33 min., 31 sec.,

THENCE, North 50 deg., 56 min., 17 sec., West (Called North 48 deg., 26 min., 46 sec., West), on the North line of said Lot 4, a distance of 325.03' (Called 325.00') to a 1" steel pipe found for a common corner of said Lots 1 and 4 on the East right of way line of said Wespark Drive; said 1" steel pipe being the Southeast corner of the herein described tract;

THENCE, North 39 deg., 04 min., 31 sec., East (Called North 41 deg., 33 min., 14 sec., East), on the East right of way line of said Wespark Drive, a distance of 225.08' (Called 224.985') to the POINT OF BEGINNING and containing 1.634 acres of land, more or less.

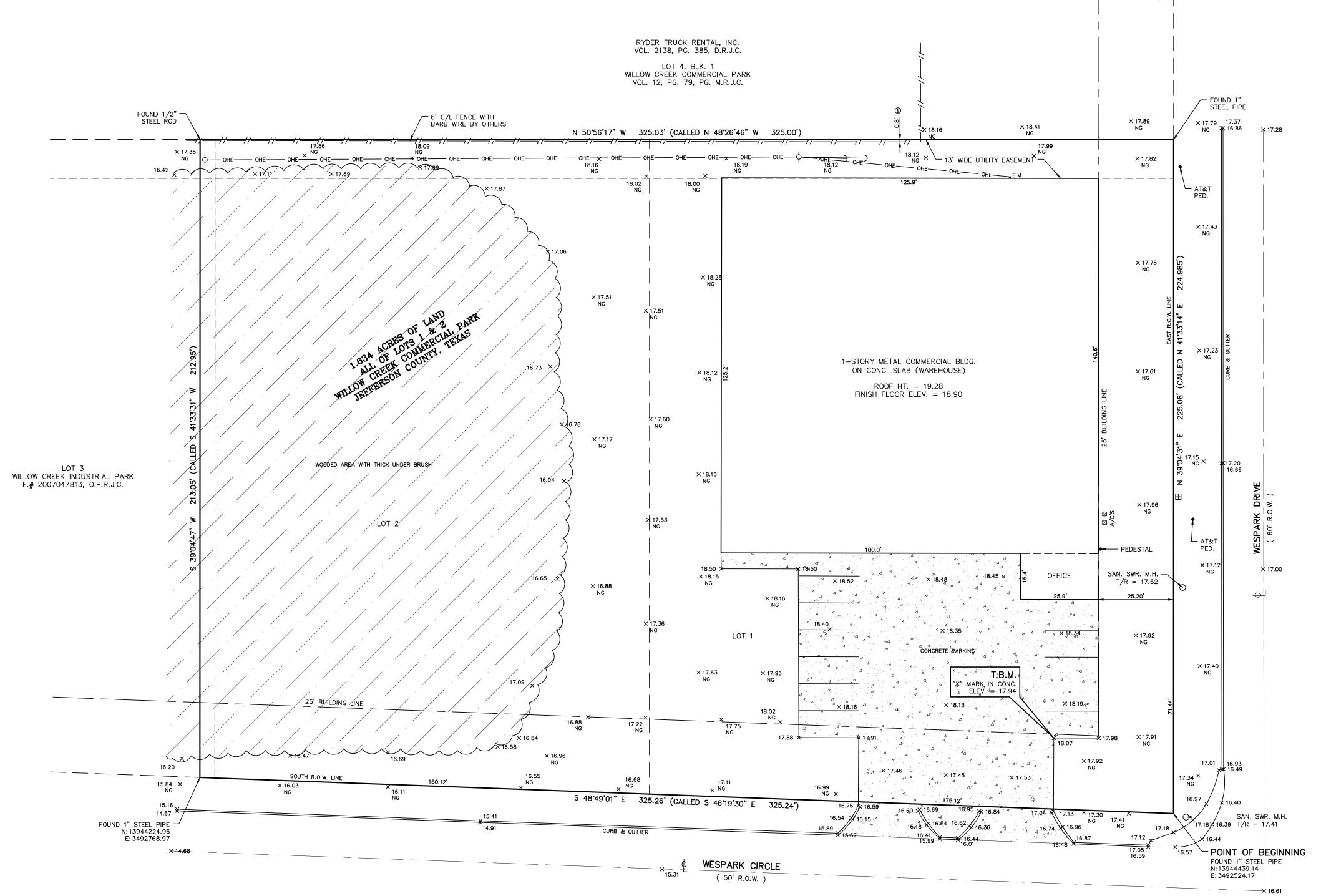
