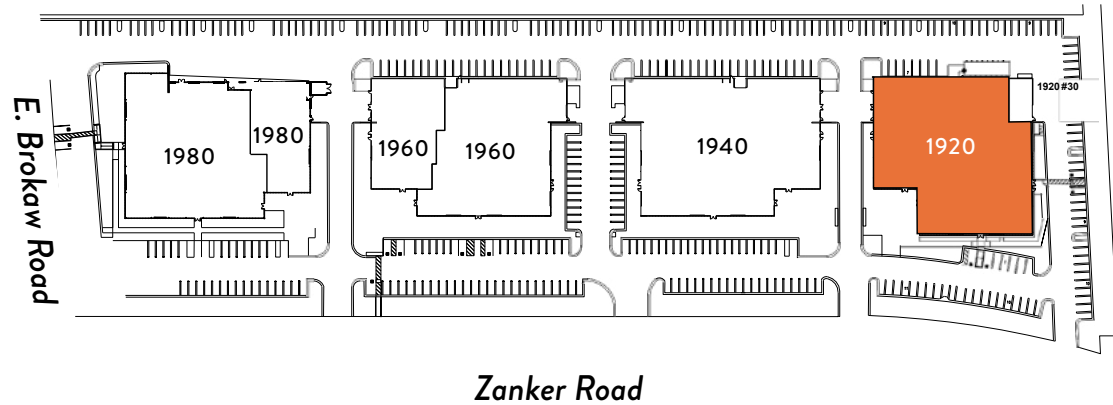

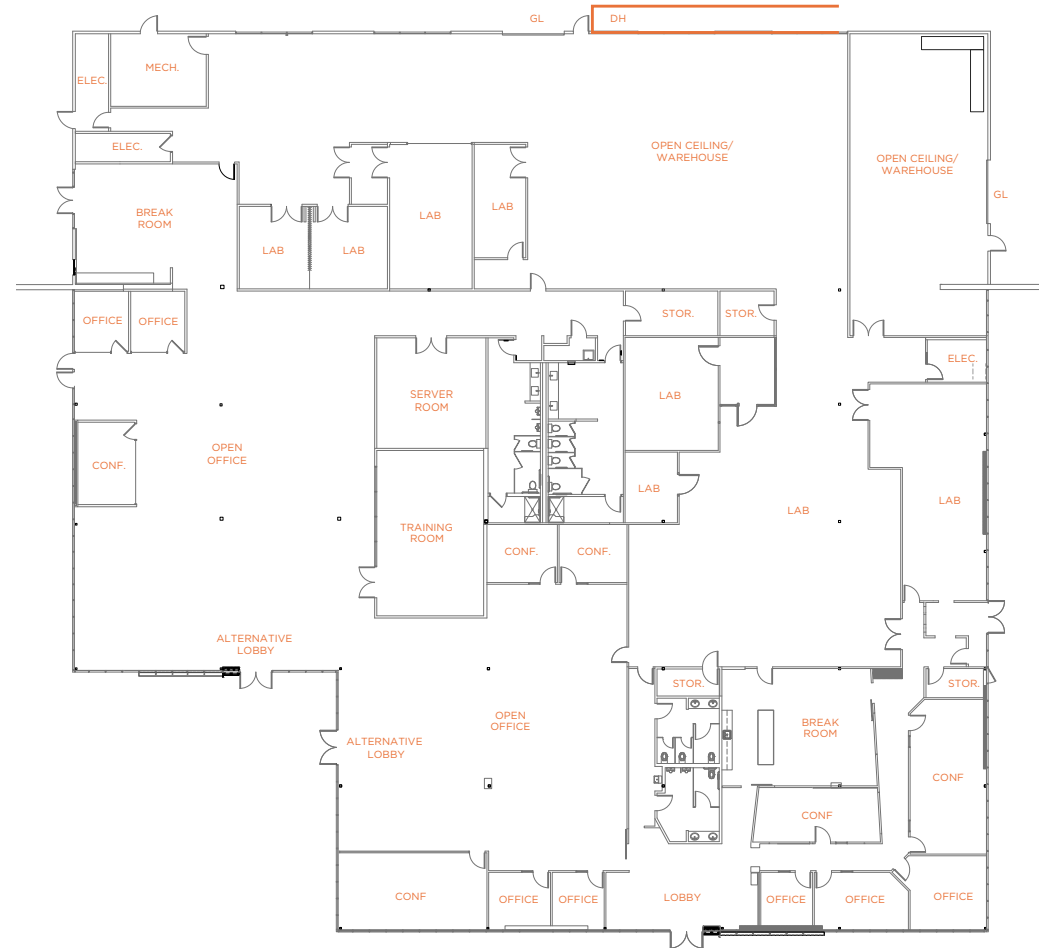

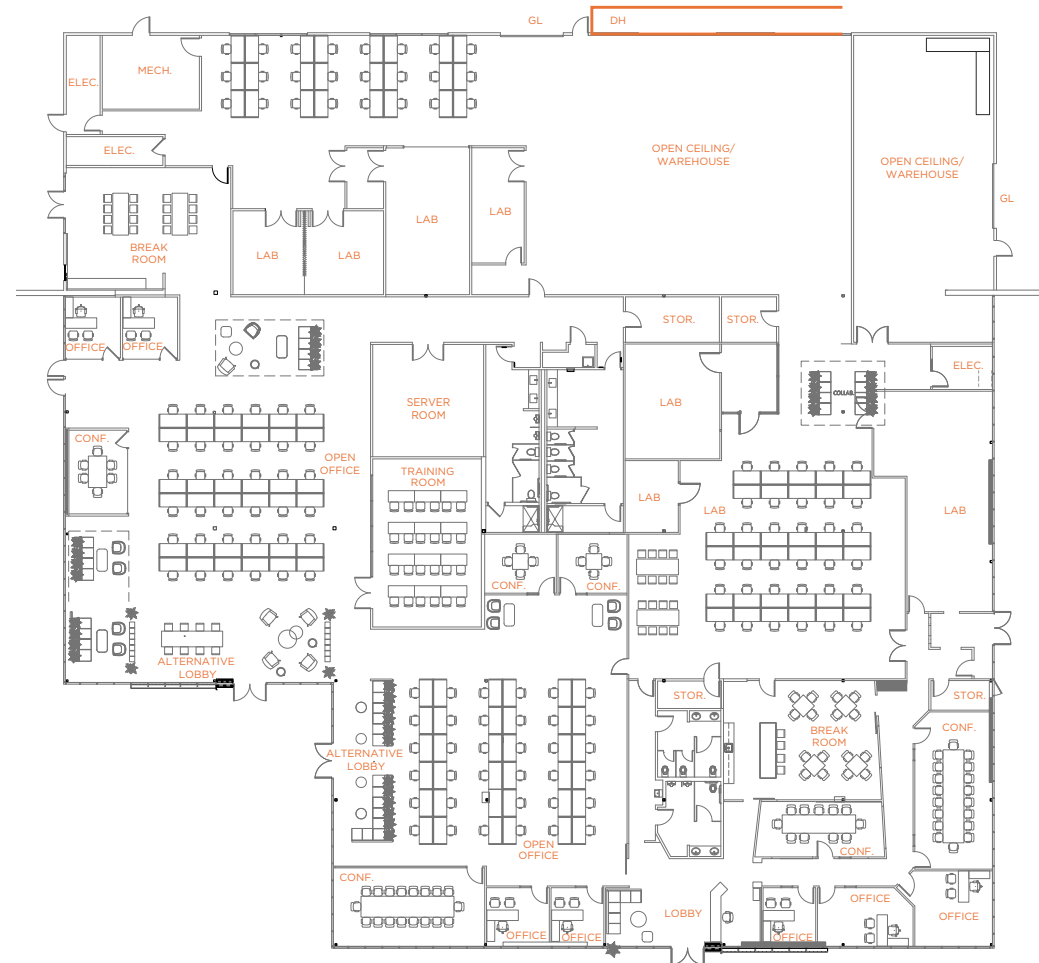
HYPOTHETICAL PLAN
