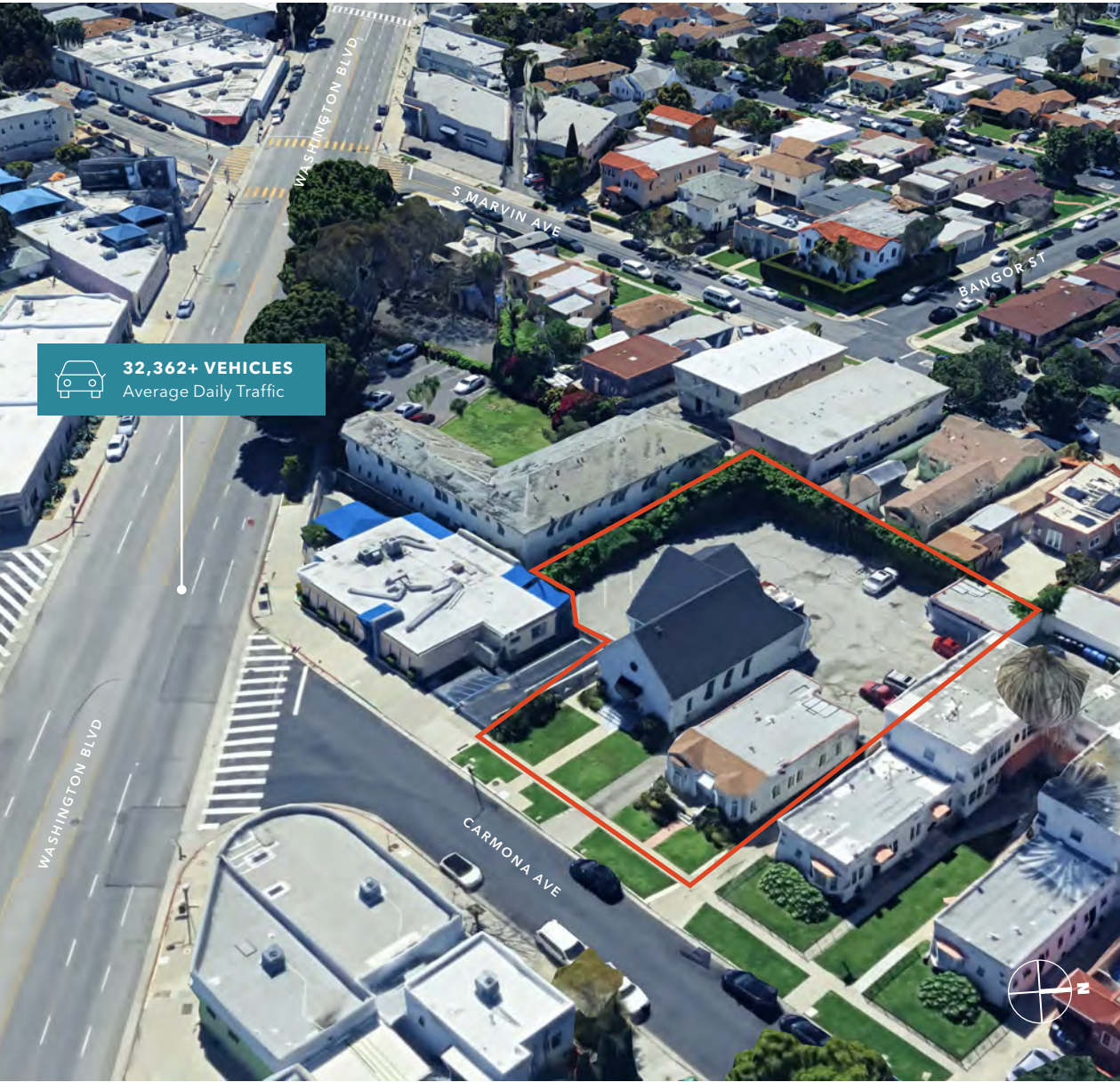

- Educational Institutions

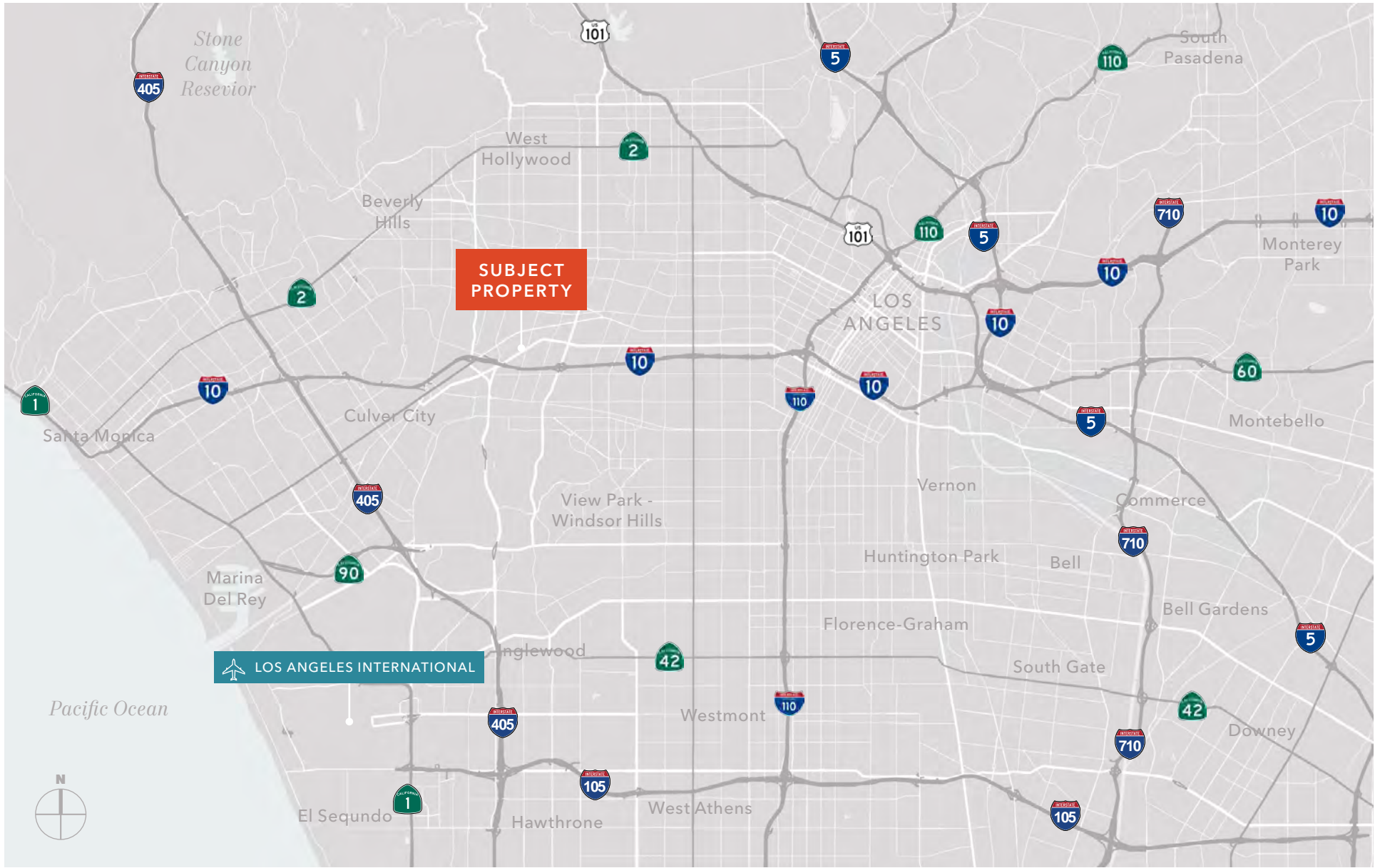
GENERAL PLAN LAND USES

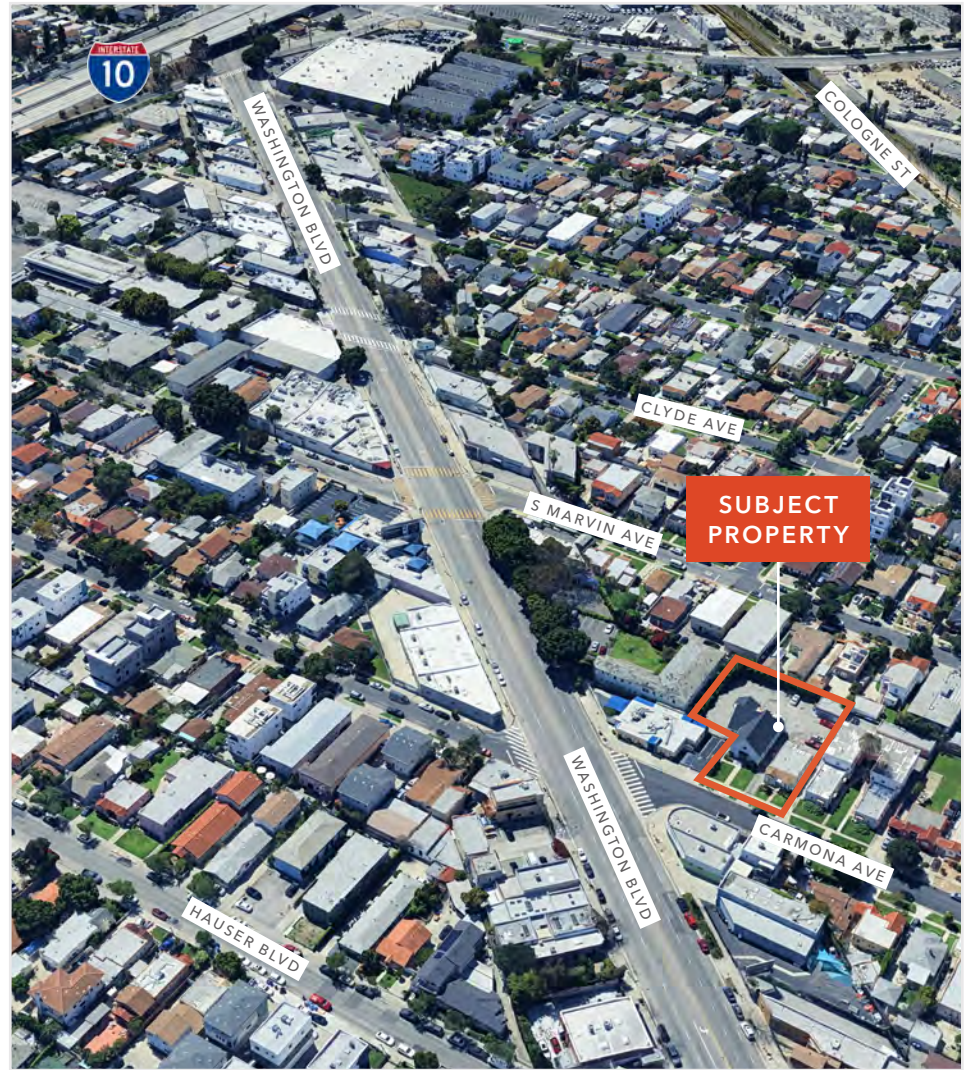


1941 & 1945 CARMONA AVE
