SUMMARY

Extremely well-updated restaurant building currently home to The Copper House. The property was originally remodeled around 2010-2011 and opened as Tin Man Brewery in 2012. Following its closure, the building underwent another extensive renovation in 2019–2020 before reopening as The Copper House.

The building is thoughtfully designed for a large, open-concept restaurant with multiple dining areas and a dedicated second-floor event space. The second floor includes its own kitchen and could potentially operate as a stand-alone event venue or restaurant concept.

The main level features a spacious bar and dining area upon entry. Toward the rear of the building is a newer, expanded kitchen designed to accommodate the larger restaurant operation and the additional seating in the Garden Room.

Additional features include a large attached warehouse for storage and a sizeable basement, providing significant operational support space.
