The available spaces, which were formerly Petco and Big Lots (Available 2/1/25), features high ceilings and a spacious open interior. The Property features dual-sided monument signage along both Torrence Avenue (22,100 VPD) and River Oaks Road (24,700 VPD) and an on-site parking lot totaling 763 surface level spaces. River Oaks Center, which totals over 1.3 million SF, is directly across the street and is anchored by JCPenney and Macy's. Other neighboring retailers include Sam's Club, ALDI, Home Depot, Forman Mills, Dollar Tree, Men's Wearhouse, Bank of America. Shoe Carnival, Buffalo Wild Wings, Starbucks, Dunkin', McDonald's, White Castle, Taco Bell, Panda Express, and Burger King, among many other national retailers.




