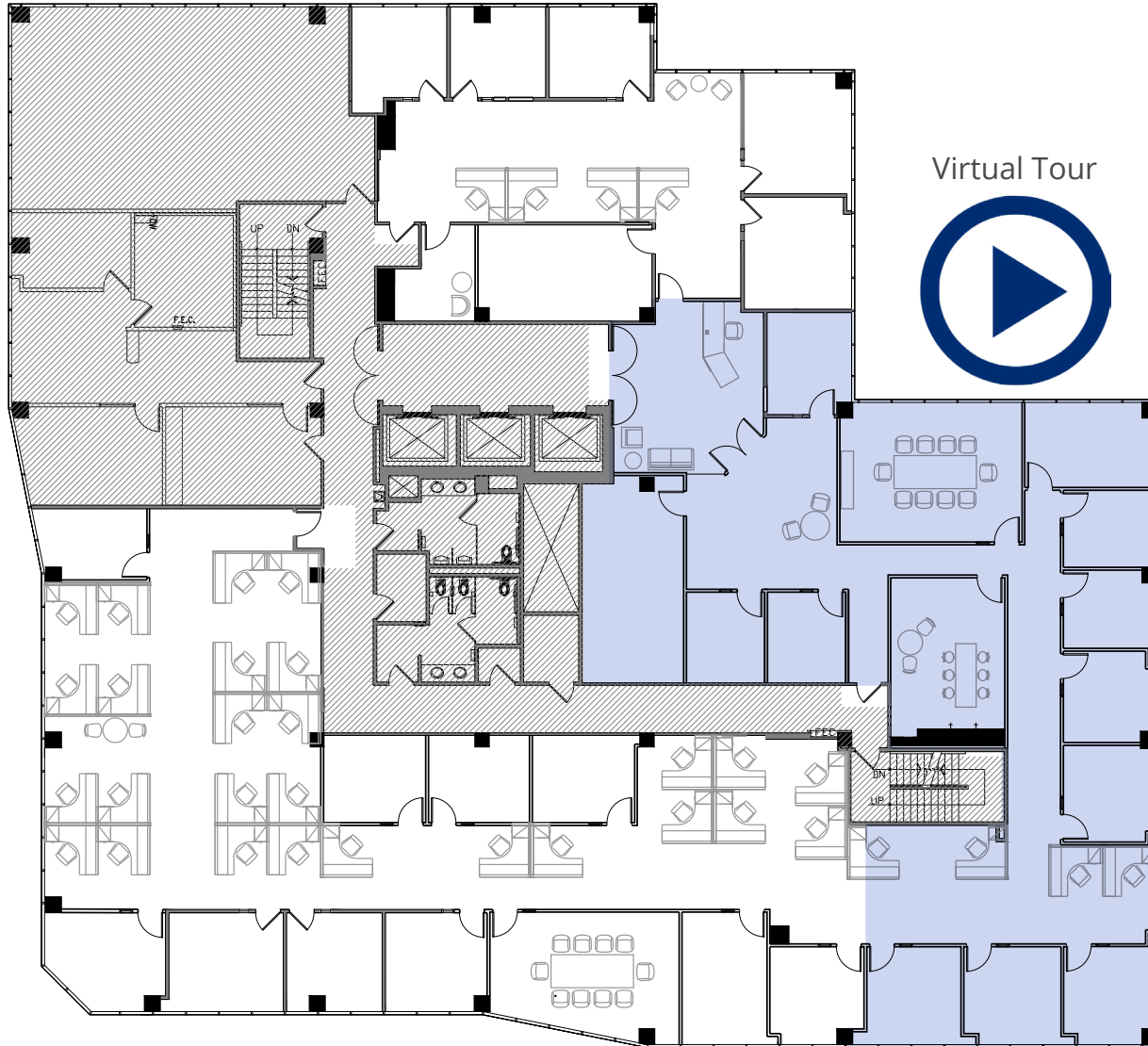

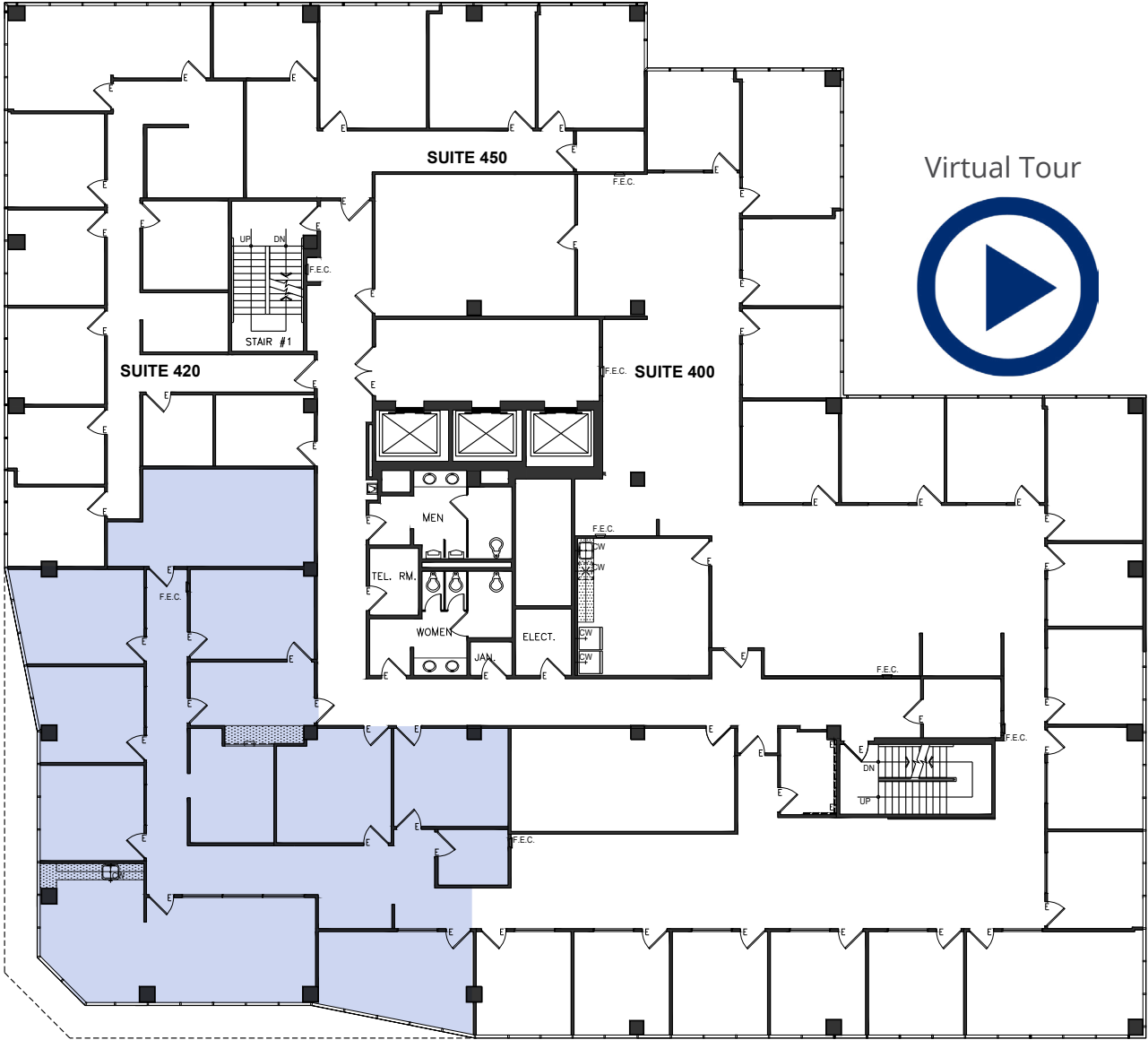
3rd Floor Floor Plans

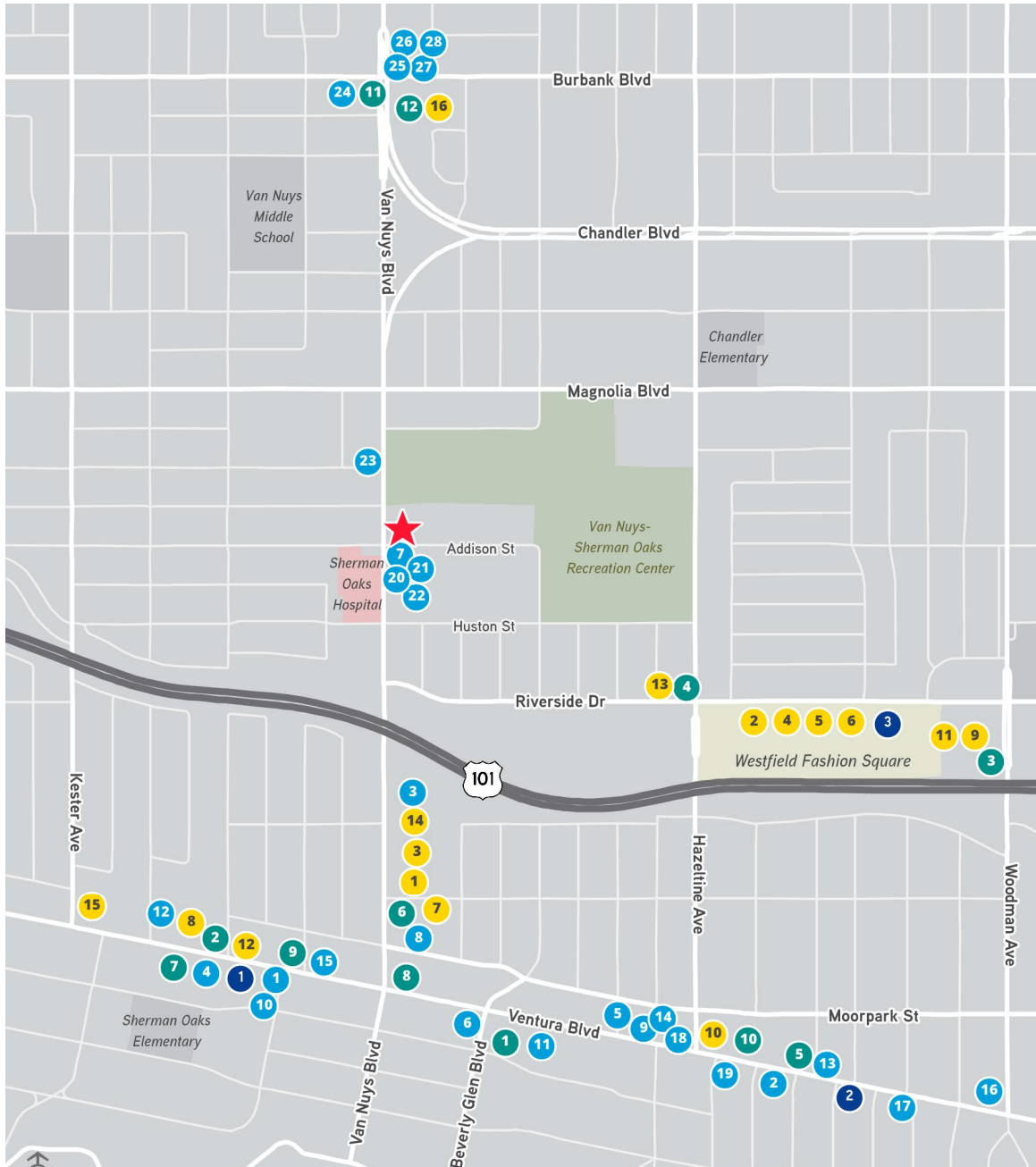

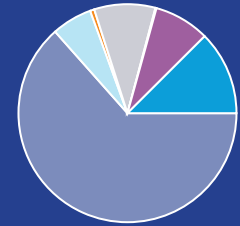
