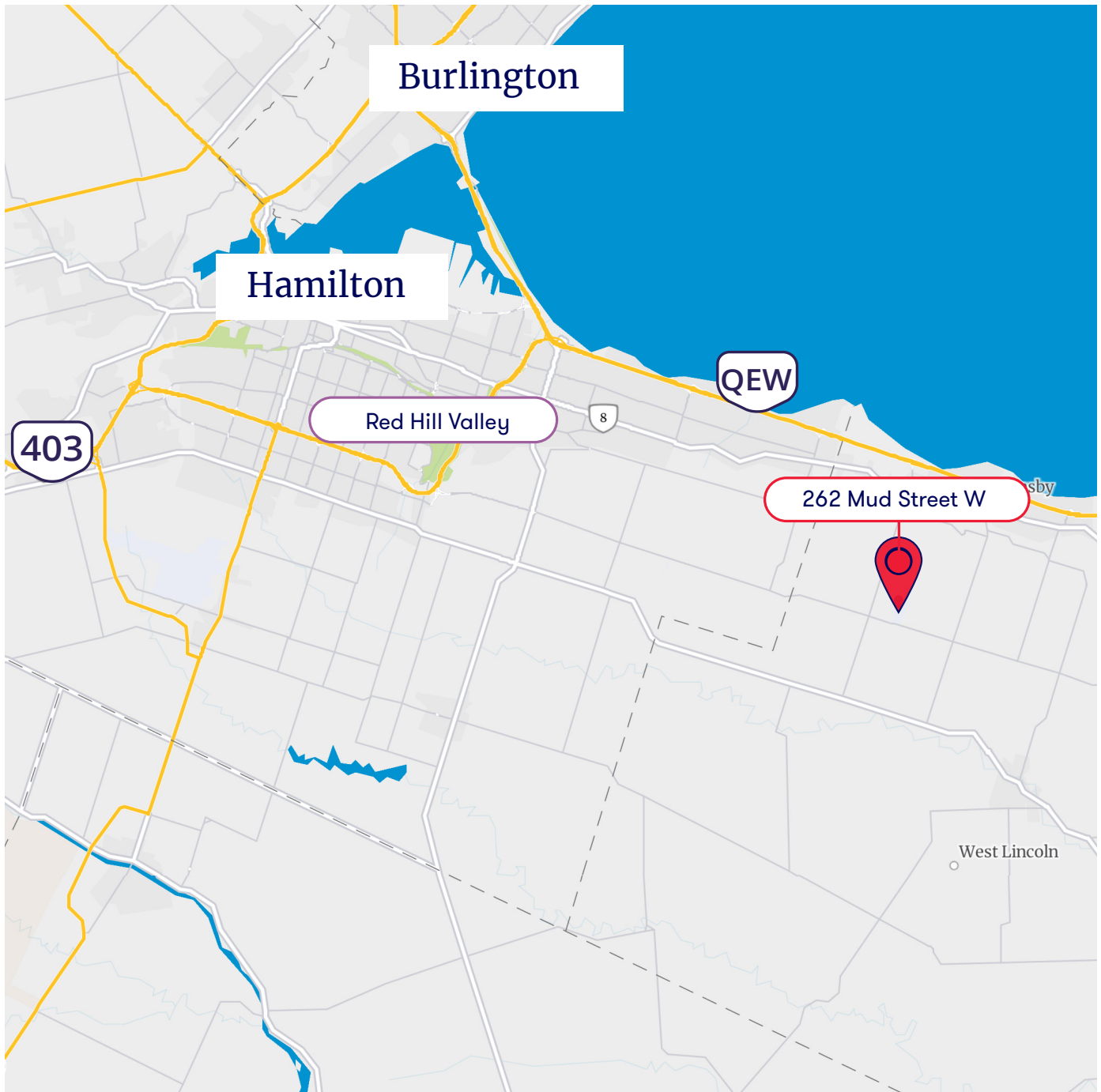

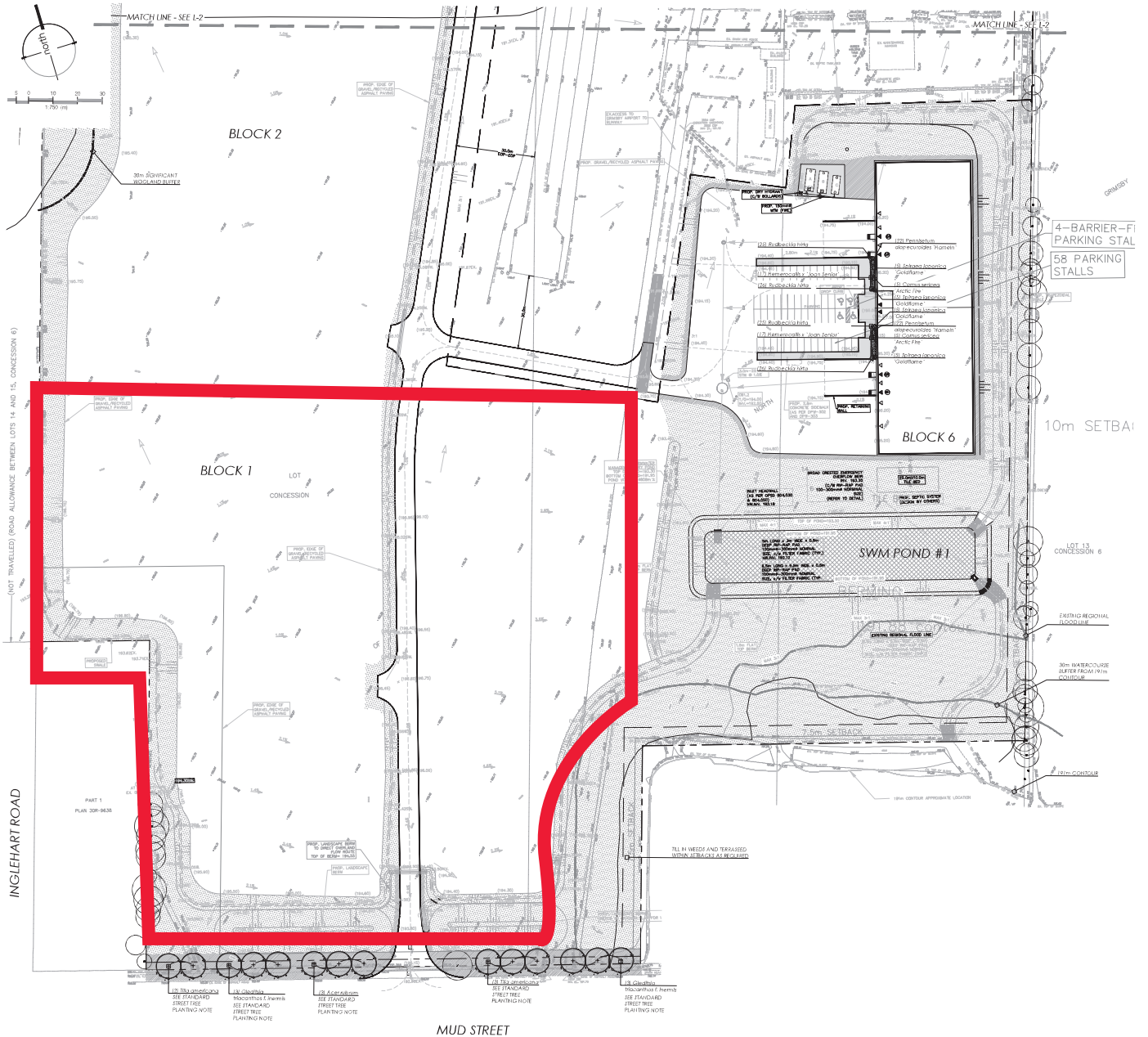
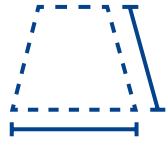

Site Plan

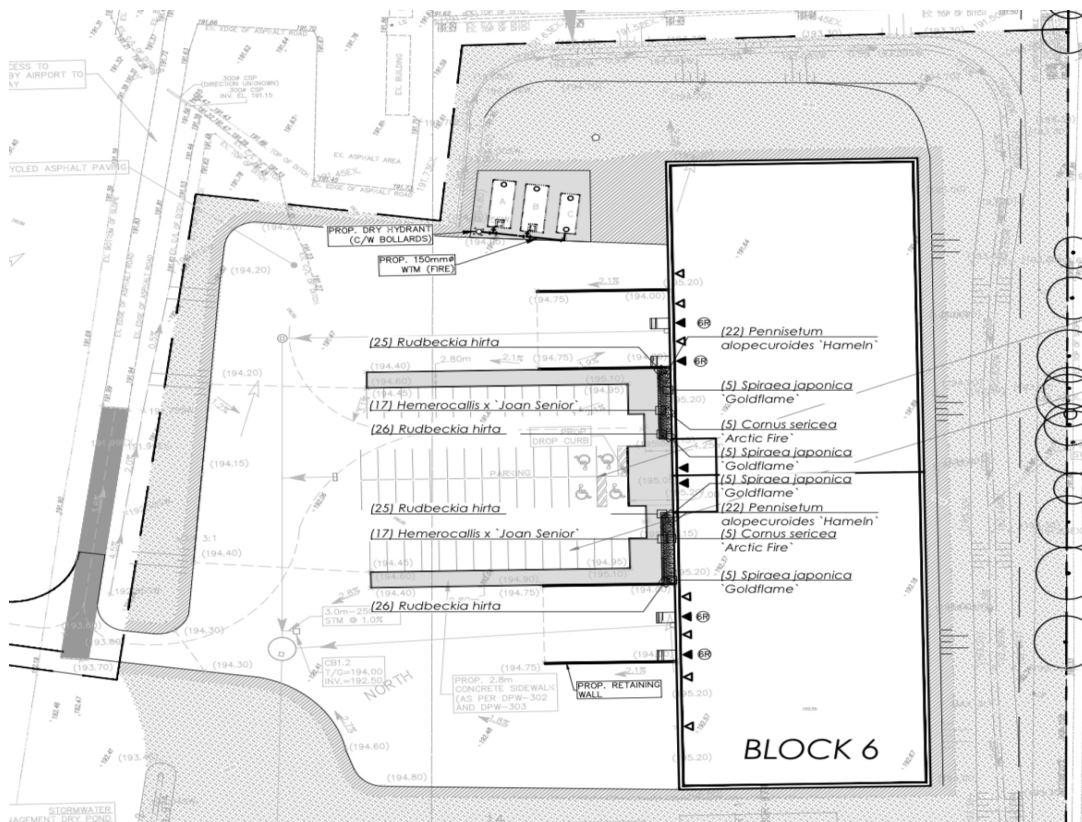
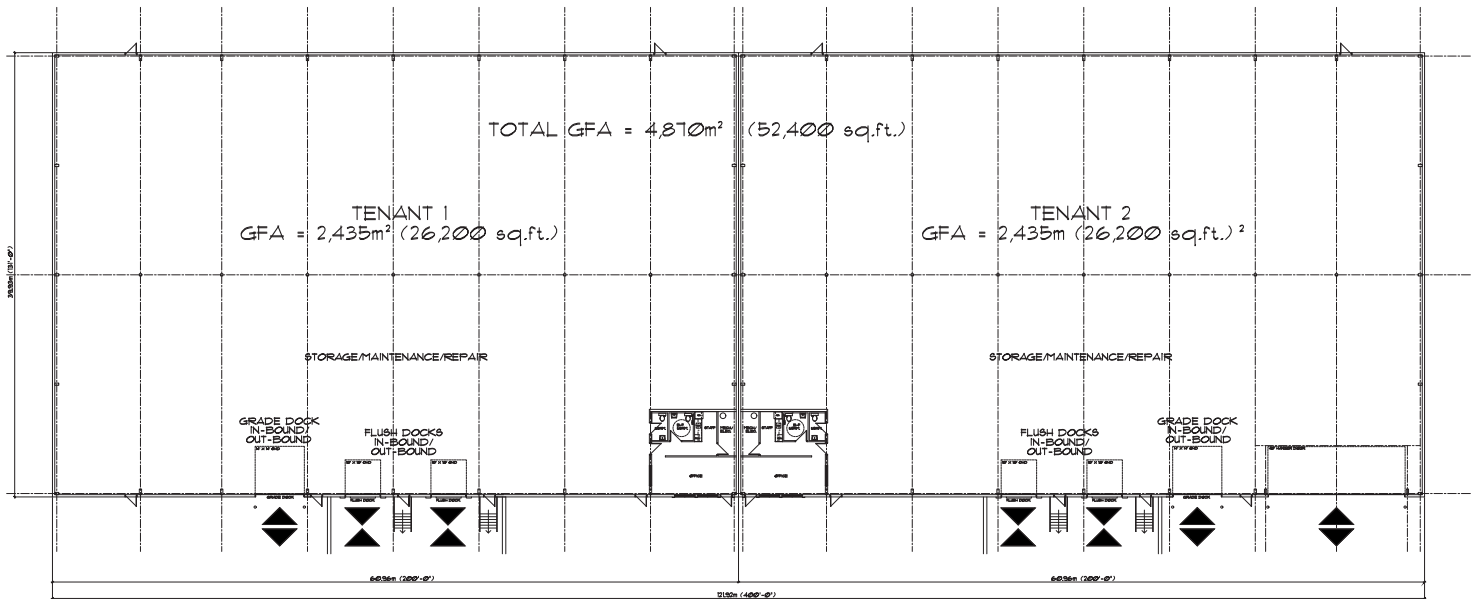
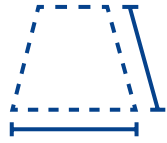
