# A Landmark Project

This 2.2M SF transit-oriented mixed-use project comprises five separate blocks fully entitled for residential, hospitality and 500,000 SF of medical office/healthcare space in two distinct buildings.

Highland Park Miami benefits from high patient density, accessibility and visibility as it is within walking distance of the nation's second largest medical city, the Miami Health District and located adjacent to SR 836. The Project is a prime opportunity for medical operators to relocate and expand their services in a thriving healthcare market.





# Regional Healthcare Landscape

Highland Park Miami is extremely well located within walking distance of the Miami Health District, the second largest medical district of its kind within the U.S. and a major employment center, within Miami-Dade County, which employs roughly 46,000 people. The 153-acre Miami Health District is home to top-ranked hospitals, groundbreaking research institutes and the most advanced medical treatment and educational resources, including Jackson Memorial Hospital, University of Miami Health Center, and the Bascom Palmer Eye Institute.

The area is enhanced by direct access to Miami's Metrorail service. Located immediately adjacent to Culmer Metrorail station, Highland Park offers access to MiamiCentral, the transportation hub where all four train systems in South Florida-Brightline, Metrorail, Tri-Rail and the Metromover-converge.





# Employment Hubs

The 153-acre Miami Health District campus is one of Miami's biggest and densest employment hubs. The District is home to two of the three largest health centers in Miami: Jackson Memorial Hospital and The University of Miami Health Department. Jackson Memorial Hospital, The University of Miami Health Department and the other health centers employ roughly 46,000 people at the Health District.

A major new asset for the region is Converge Miami, formerly known as the University of Miami's Life Science Park, a catalyst that brings faculty, scientists, students and entrepreneurs together to encourage collaboration and innovation.

Home to 1,500 medical school faculty members, 8,200 employees and 1,500 ongoing projects funded by over \$200 million in federal grants.

The nation's second largest hospital by bed count. Jackson is undertaking an \$830 million renovation of its multiple facilities.

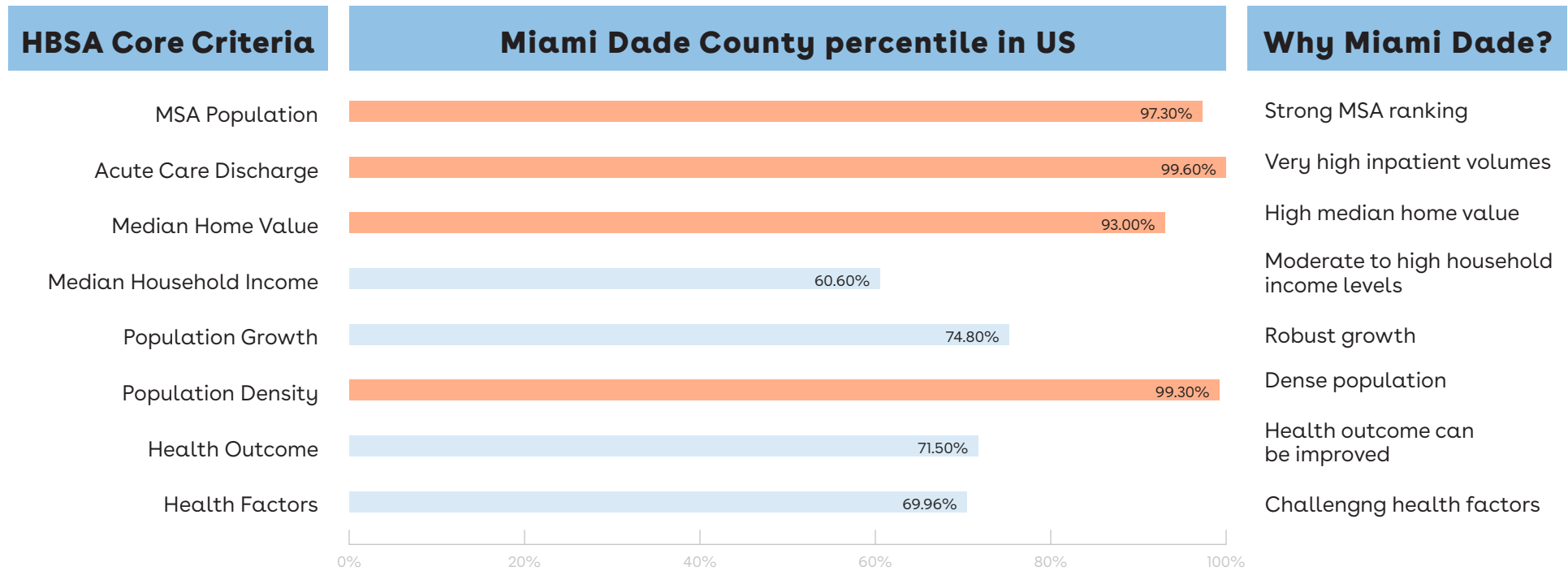


The largest children hospital in the Southeast with 254 beds and leading hospital for treating heart diseases and transplants for children.

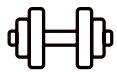
## RESIDENCES AT HIGHLAND PARK
