

General contractor shall verify all existing conditions and dimensions prior to construction

Manufacturer's specifications for the installation of materials shall be followed.

Workmanship throughout shall be of the best quality of the trade involved and the general contractor shall coordinate the work of the various trades to expedite the job in a diligent and continuous process.






