
#### Story of Mariapolis Luminosa

In 1986, at its inauguration, Focolare founder Chiara Lubich wrote: "This city of Mary could be the model of a new humanity where unity has become a reality."





The subject property is situated in a district designated "GB, Greenbelt" by the Zoning Ordinance of the Town of Hyde Park, as amended to the date of appraisal.

#### The "GB" zone permits the following principal uses:

- 1. One-family dwelling.
- 2. Bed-and-breakfast, accessory.
- 3. Agriculture.
- 4. Animal husbandry.
- 5. Camp and day camp.
- 6. Civic facility.
- 7. Forestry use.
- 8. Municipal use.
- 9. Nursery school.
- 10. Photovoltaic system.
- 11. Roadside stand.
- 12. Solar system, freestanding or ground mounted.
- 13. Solar thermal system.

#### The "GB" zone area and bulk schedule is as follows:

Minimum Lot Area: 2.5 acre per dwelling unit

Maximum Floor Area Ratio: 0.4 DU/A

Maximum Lot Coverage: 15% impervious coverage

Minimum Yards:

Front Yard: 50 ft. min.
Rear Yard: 50 ft. min.
Side Yards: 25 ft. min.
Building Height Limit: 35 ft.

The subject property is assumed to be either a legal non-conforming use or may pre-date zoning; this determination is beyond the scope of this assignment. This appraisal is made under the assumption that the existing use is a legal use and that it would be permitted to continue.
