

The Offering

Current performing arts space & recording studio with attached 45 car parking lot comprised of a single 10,328 square feet structure situated 0.56 acres of land. The Linda is located in the Central Avenue neighborhood in the city of Albany, with ~168' of primary frontage on the busy commercial corridor of Central Avenue. The city of Albany has experienced decade long population growth and is the center of a 1.17 million person metropolitan area. Buoyed in part by the jobs provided by state government, Albany Med, St. Peter's Health Partners, and many institutes of higher education (all of which are 5-10 minutes from The Offering), the city perennially sports an unemployment figure at or below 3% and vacancy rates at or under 5%.
