Executive Summary

The Boulder Group is pleased to exclusively market for sale a single tenant net leased United Rentals located in Huntsville, Alabama. United Rentals has been operating at this location since it's construction in 2008. United Rentals has executed several renewals over the years and recently signed an extension through December 2031, demonstrating commitment to the site. The extension features a 12% rent increase in 2028 and 10% every five years after. The extension also established four 5-year renewal options. The subject property is low coverage industrial with outdoor storage across 3 acres.

The 7,529 square-foot building benefits from its proximity to Highway 255 (30,990 VPD) and Highway 53 (31,088 VPD), two of the area's primary thoroughfares into Huntsville. According to CoStar, the surrounding household growth will increase by 12.8% over the next five years. In recent years, Huntsville has become a rapid growing city due to the low cost of living and significant federal investments in defense, aerospace, and R&D. Currently, there are over 100,000 people living within a five-mile radius that earn an average household income of \$94,737. The asset is located in an industrial corridor with established tenants such as Ferguson Plumbing Supply, Axion Corporation, Copart, Mingledorff's, SiteOne Landscape Supply, Beacon Building Products, SRM Concrete, and several others.


