





DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

- (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.

This disclosure is required by section 452.135 of the Wisconsin statutes and is for information only. CONFIDENTIALITY NOTICE TO CUSTOMERS
