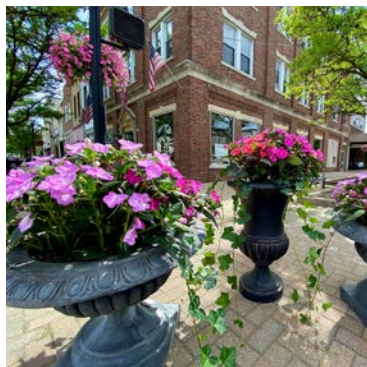
WADSWORTH HISTORY
