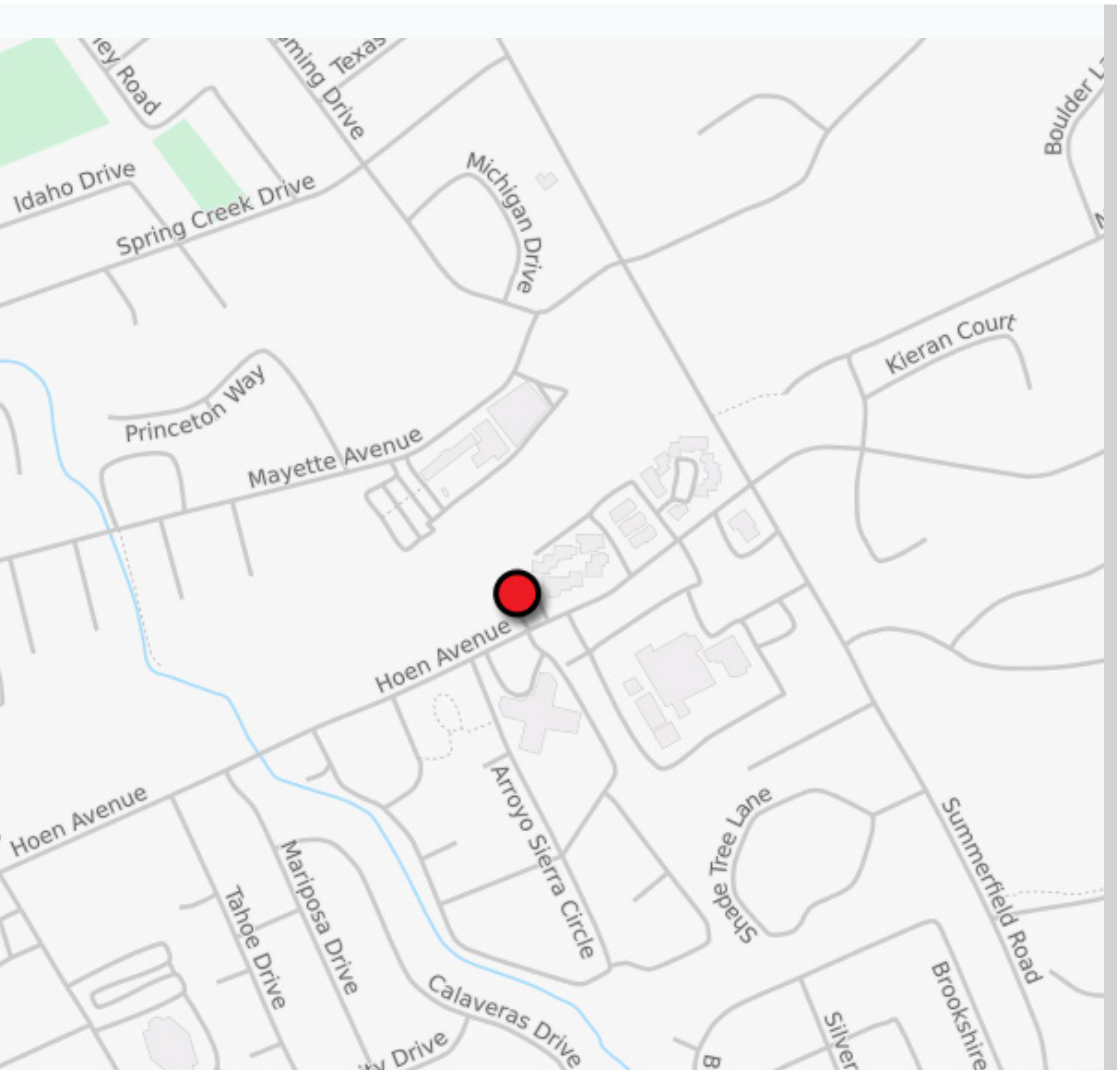

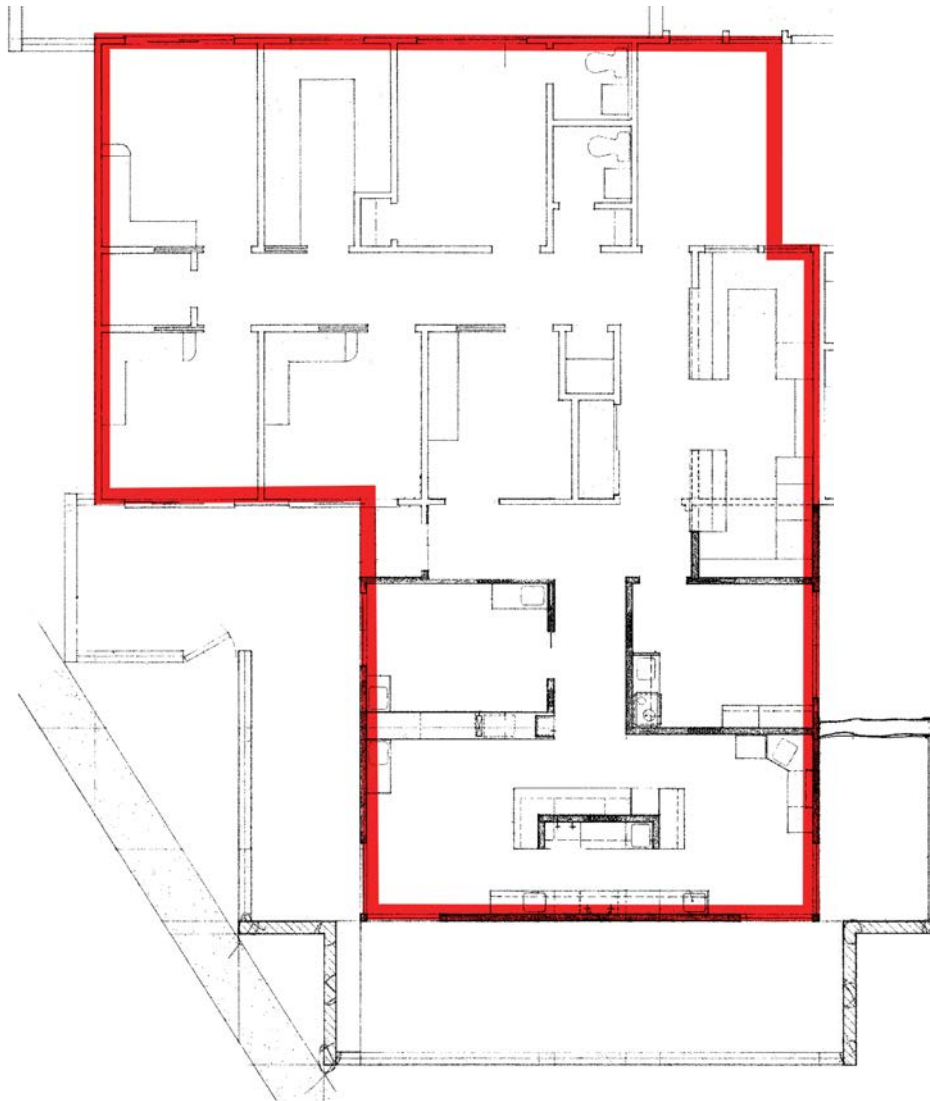

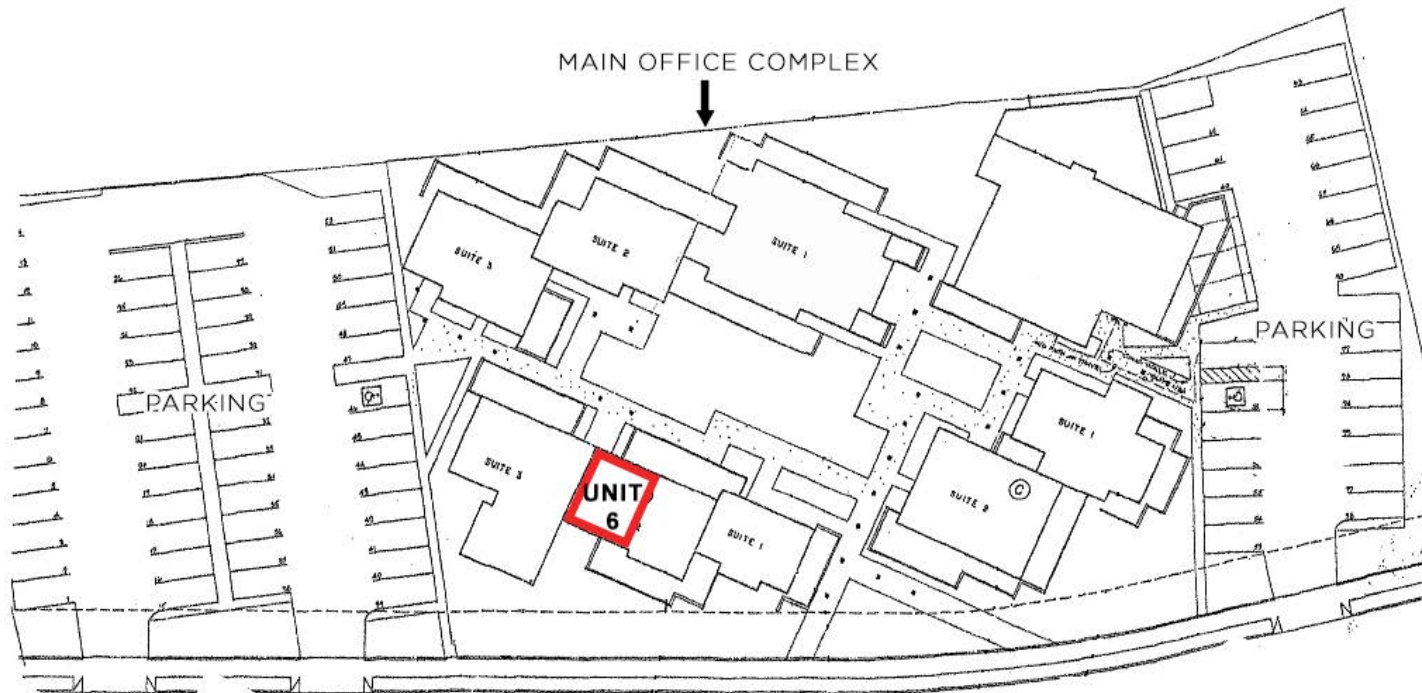


# SITE PLAN
