The Bank Building at 421 Chestnut Street is a prominent historic property located directly across from Independence Mall in Philadelphia's Old City. The office portion benefits from the building's distinguished banking-era architecture, featuring impressive ceiling heights, large window lines, and classic detailing that create a prestigious and professional work environment.

Tenants enjoy a highly visible, central location within one of the city's most walkable districts, with immediate access to transit, dining, and cultural amenities. The property's position directly across from Independence Mall, a nationally recognized park patrolled by federal law enforcement and the National Park Service, adds an additional layer of safety and security to the surrounding area.

The property offers a unique opportunity to occupy office space within a landmark building that combines historic character with modern infrastructure, making it well suited for professional, financial, legal, or boutique office users seeking a distinctive Philadelphia address.

WHERE HISTORY MEETS MODERN LUXURY

The Bank Building was constructed between 1857 and 1859 for the Bank of Pennsylvania and later completed by the Philadelphia Bank after the original institution collapsed.

Designed by John M. Gries, it exemplifies the Italianate Renaissance palazzo style, featuring ornate cast-iron doors and window grills by H. C. Oram & Company. Its elegant proportions and decorative detailing made it one of the finest 19th-century bank buildings in the city, and after extensive restoration in 1983, it was converted into what we now know as "The Bank Building."






