The site features a drive-through lane, 36 onsite parking stalls and is a short walk away from a large public parking lot. Adjacent house & garage are also included.

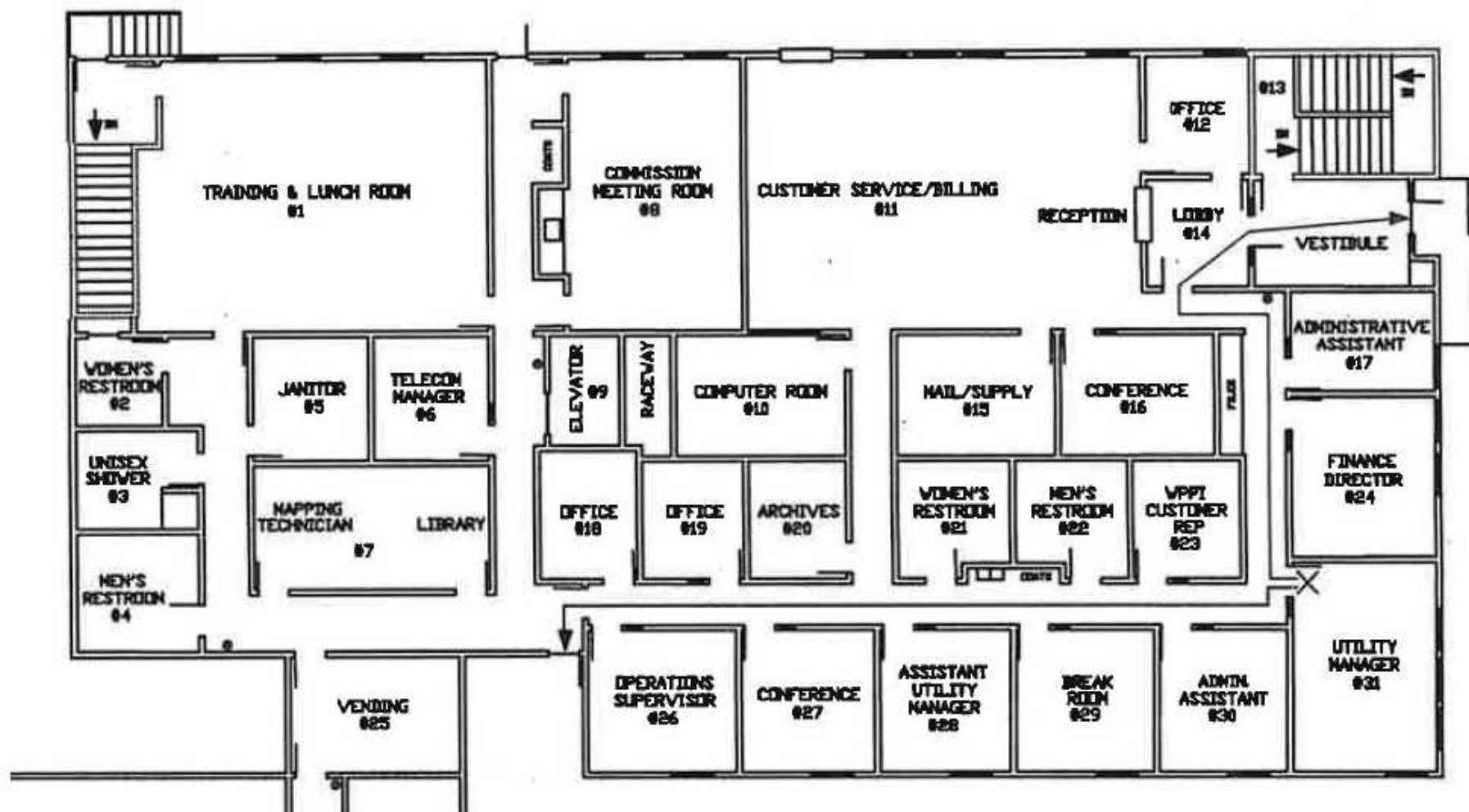

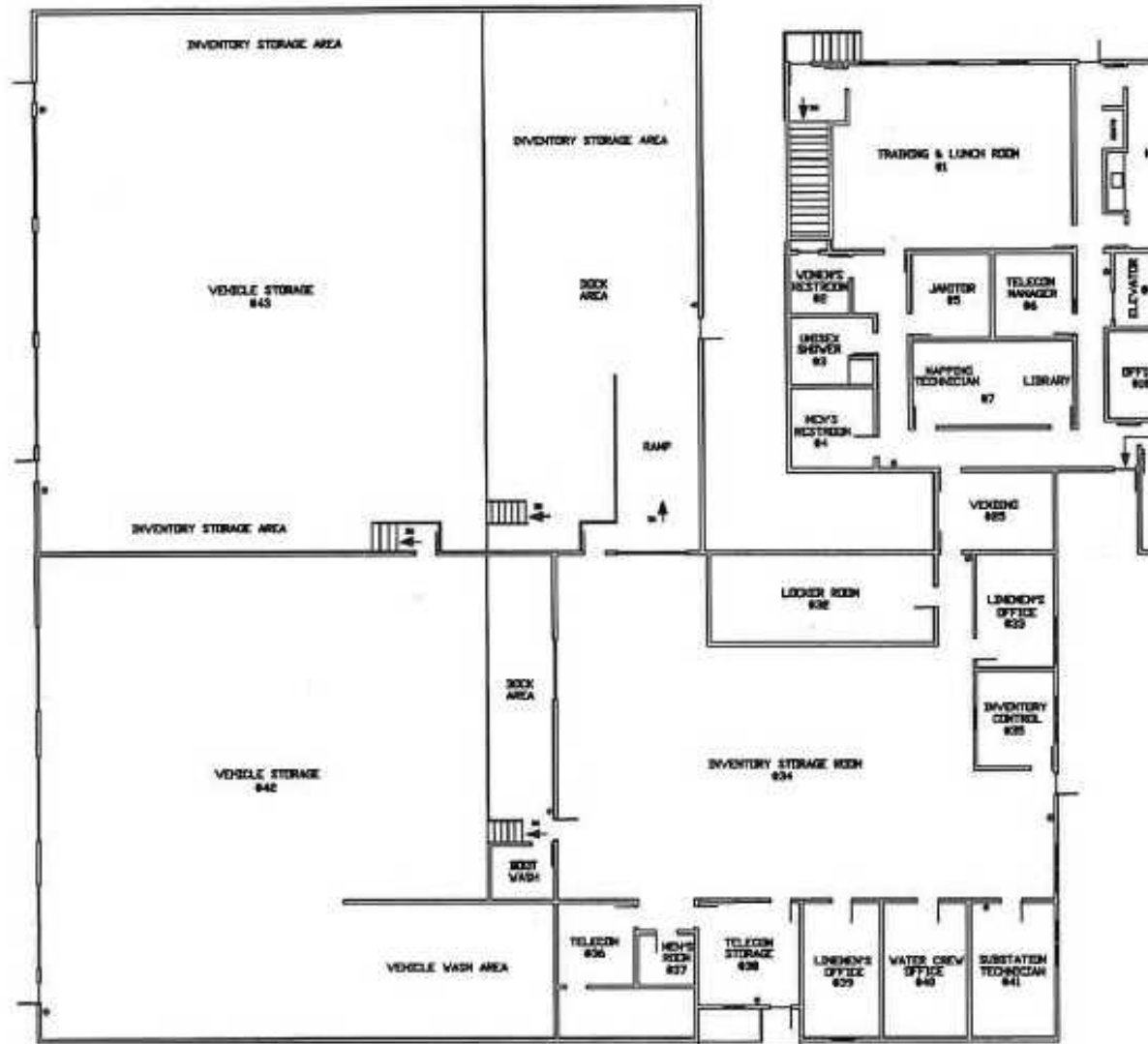

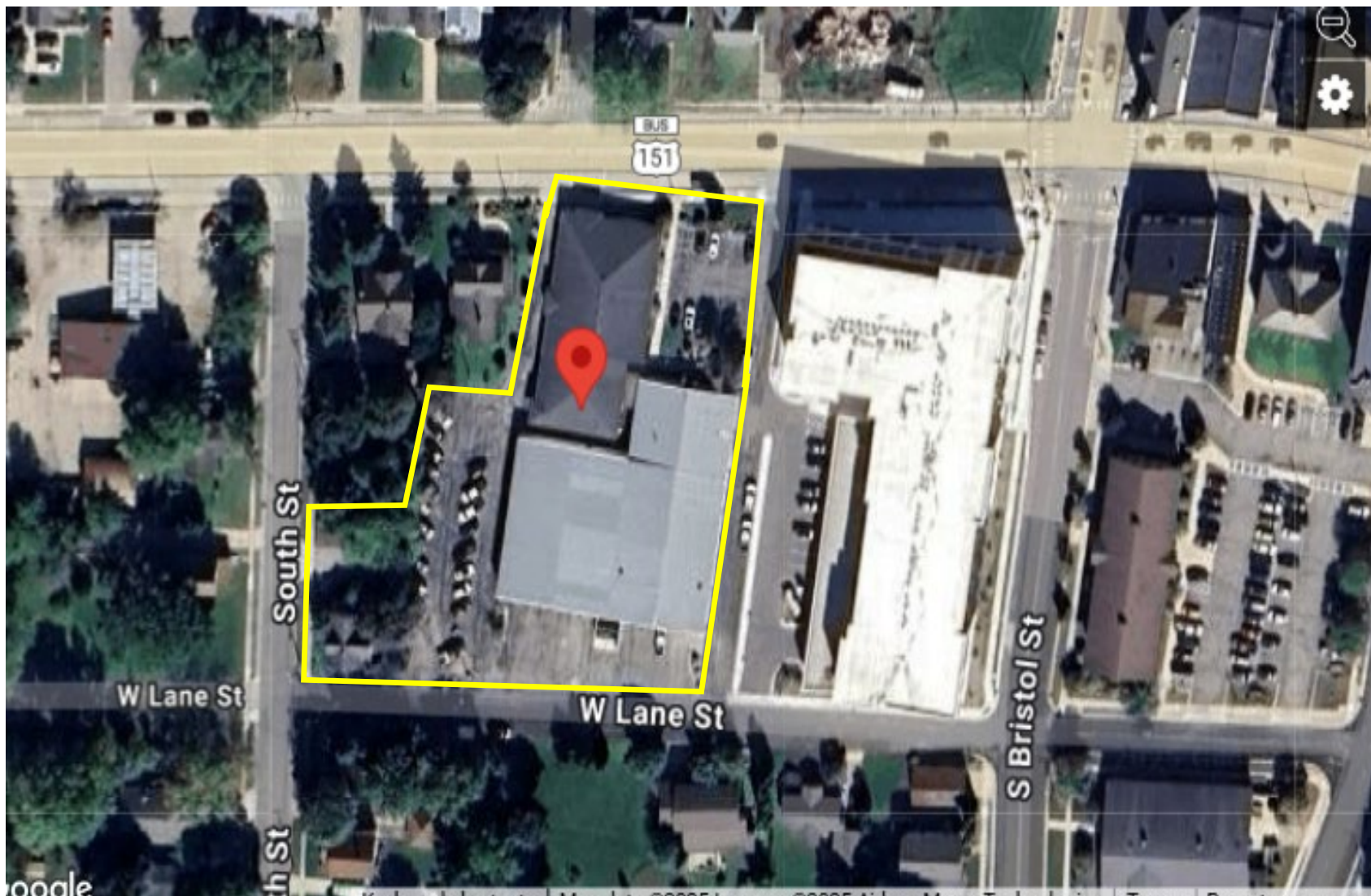

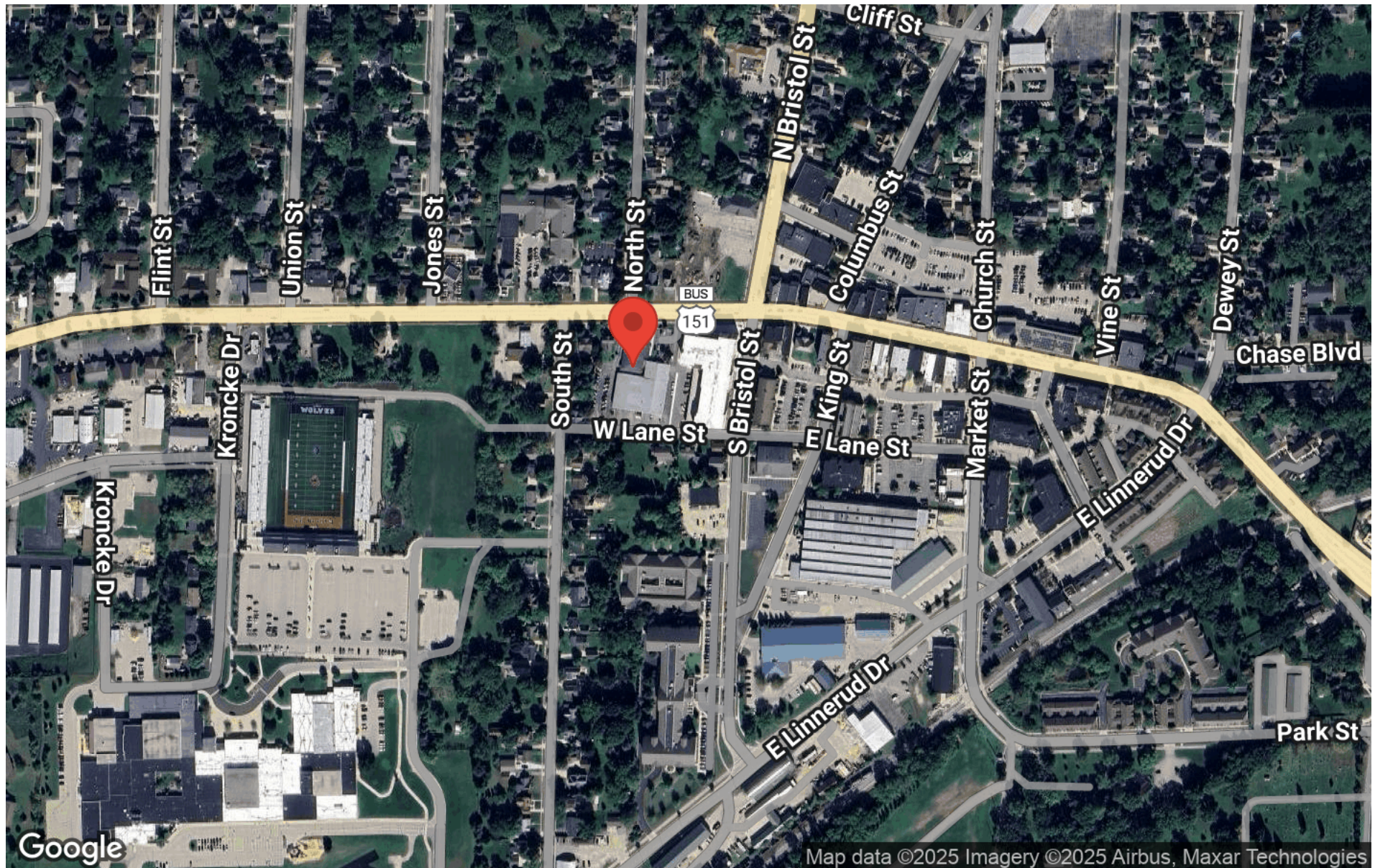

125 WEST MAIN STREET | SUN PRAIRIE, WI 53590



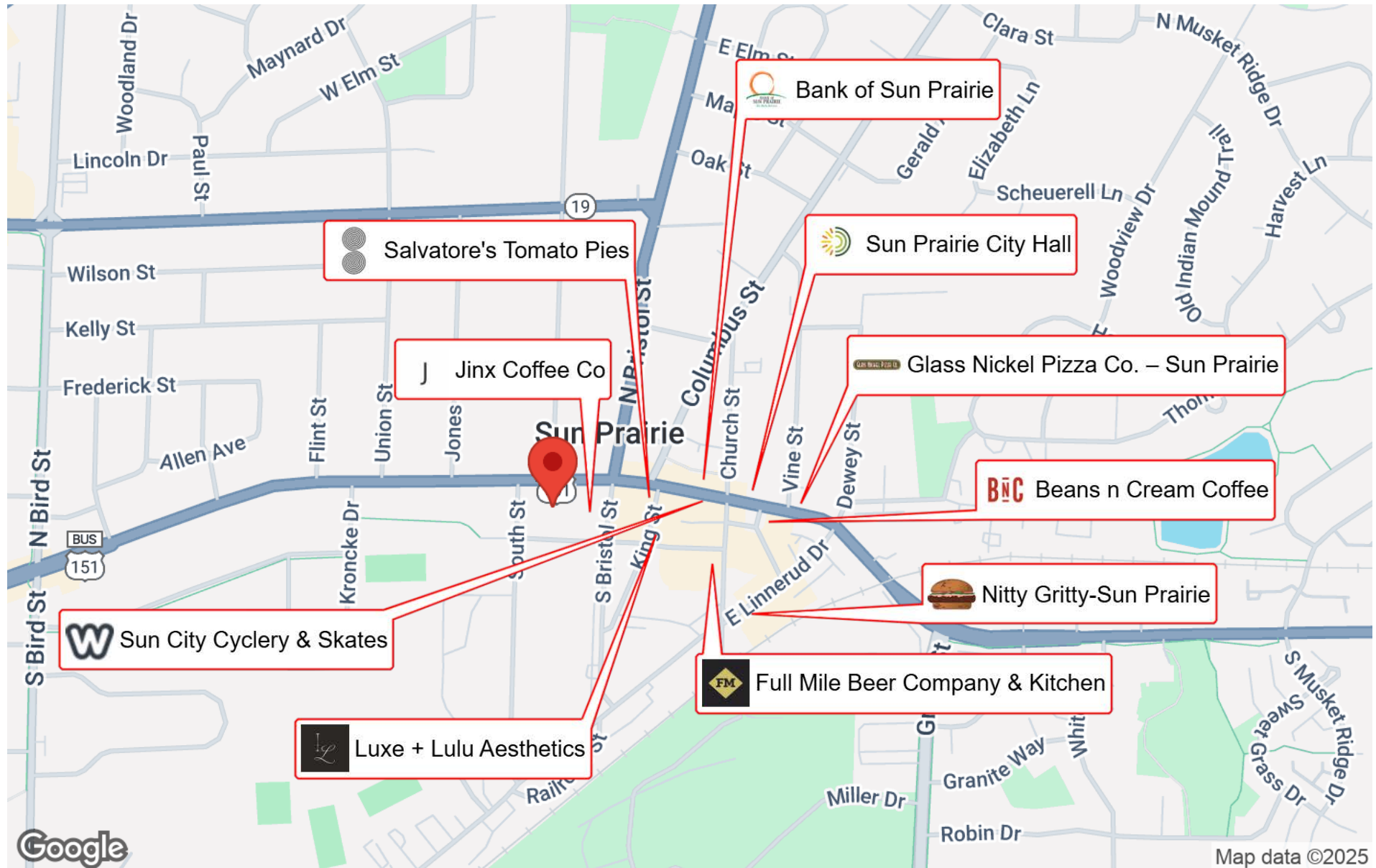

State of Wisconsin - Disclose to Non-Residential Customers

 - (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.
