Property Overview

1,584 SF of retail space available for lease at the Highlands of Lombard, a multi-tenant shopping center located along the east side of Highland Avenue in Lombard, Illinois. The property provides an excellent opportunity to join an established center with co-tenants including Byrd's Hot Chicken, Brick's Pizza, and Beauty Craft among others. The Highlands of Lombard benefits from its location in Lombard, a quarter-mile north of Interstate-88 (I-88) and one (1) mile east of Interstate-355 (I-355), featuring convenient access to and from the property. From a local perspective, the property sits just north of the heavily-trafficked intersection at Butterfield Road (Route 56) and Highland Avenue. The center is part of a larger development including co-tenants The Dump, Potbelly, among others. Additionally, the center sits directly across the street from the Yorktown Center, a 100+ tenant super regional mall serving the western suburbs. Other neighboring retailers include Target, Best Buy, Dollar Tree, Starbucks, Dunkin, Panera Bread, The Patio, Miller's Ale House, Capital Grille, Olive Garden, McDonald's, Portillo's, and Burger King, among others
