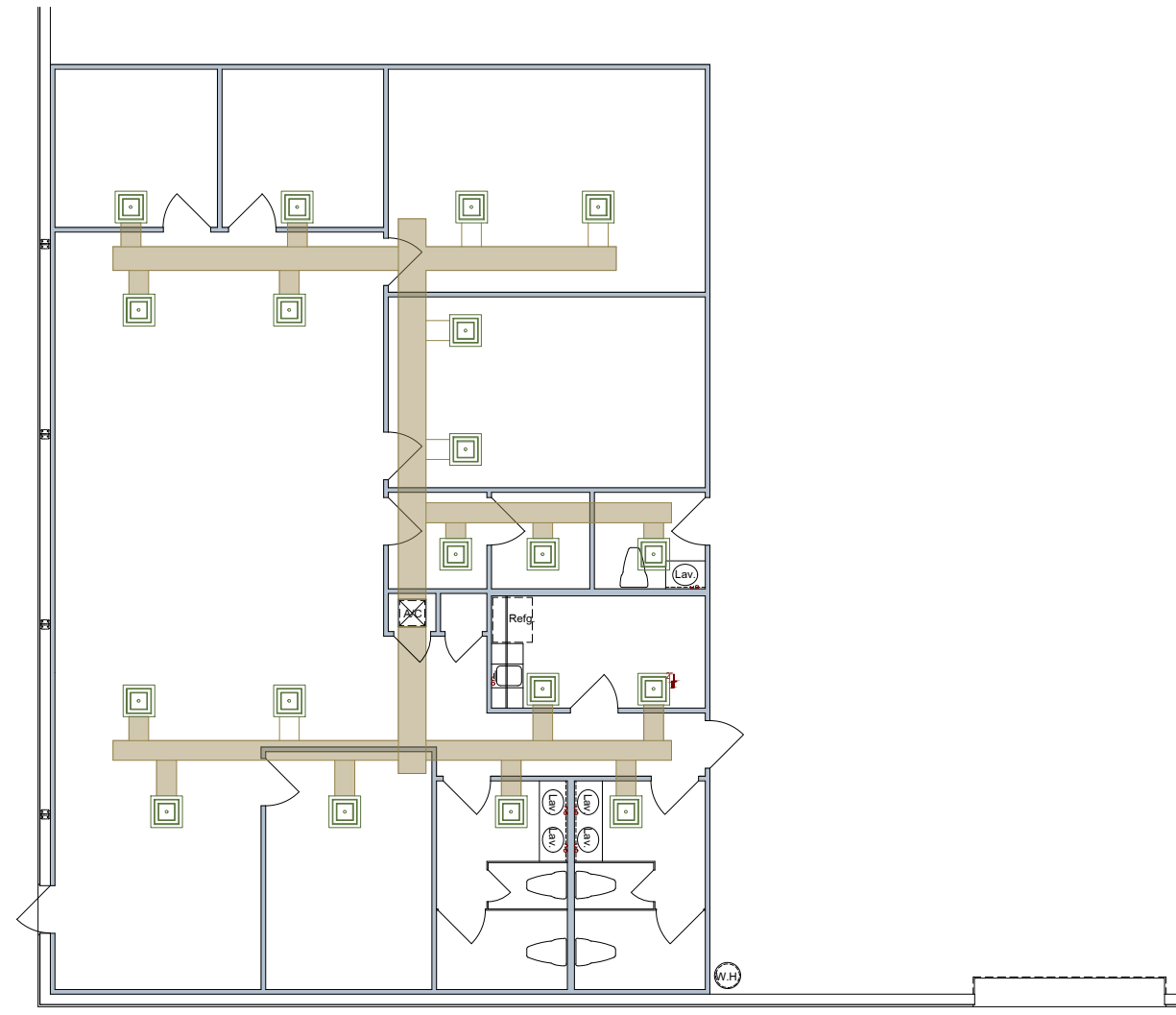
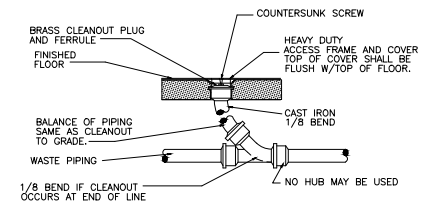


PLUMBING PLAN Scale: 3/16"=1'-0"
