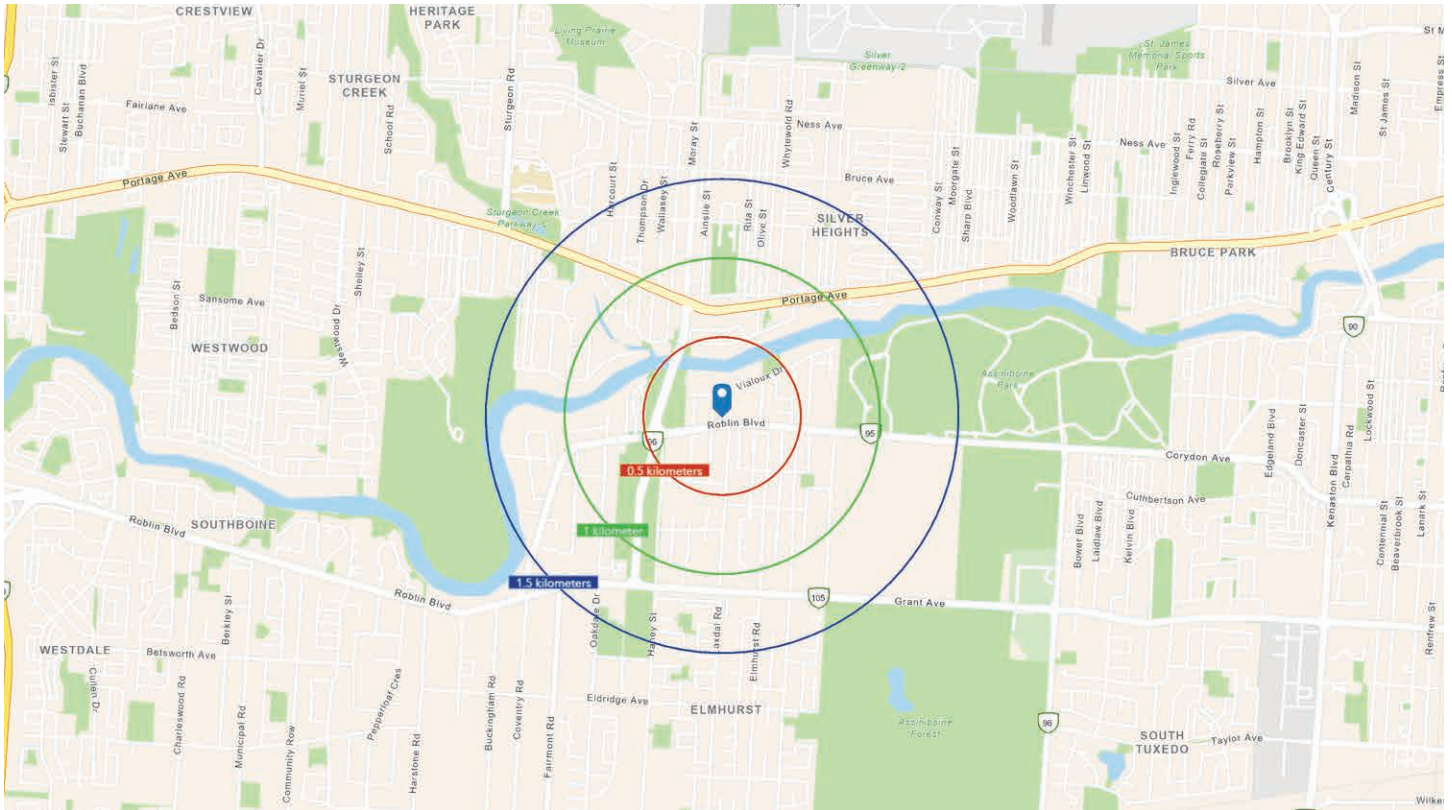


Site Plan
