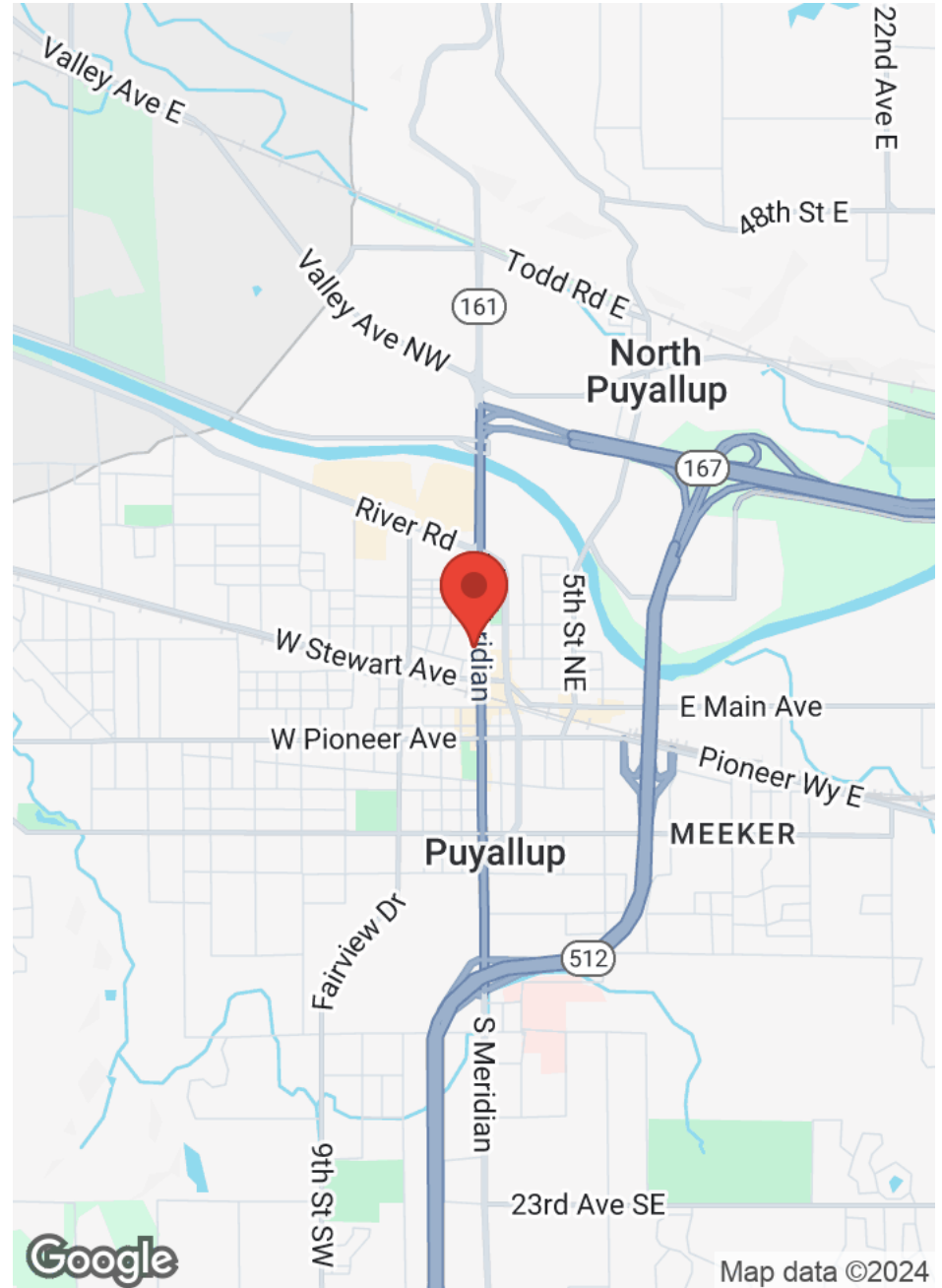
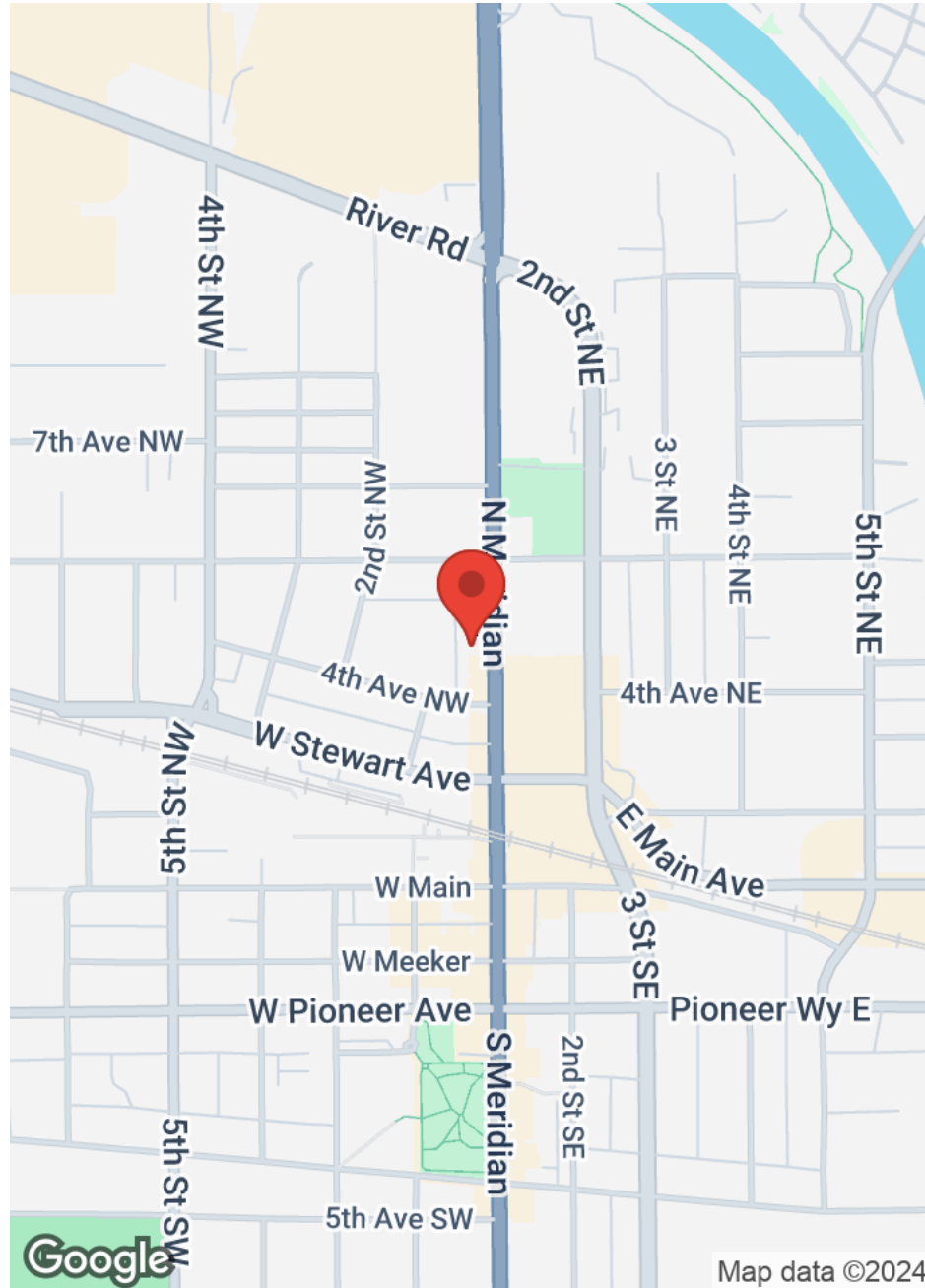
FLOOR PLAN - SUITE A

420 N MERIDIAN



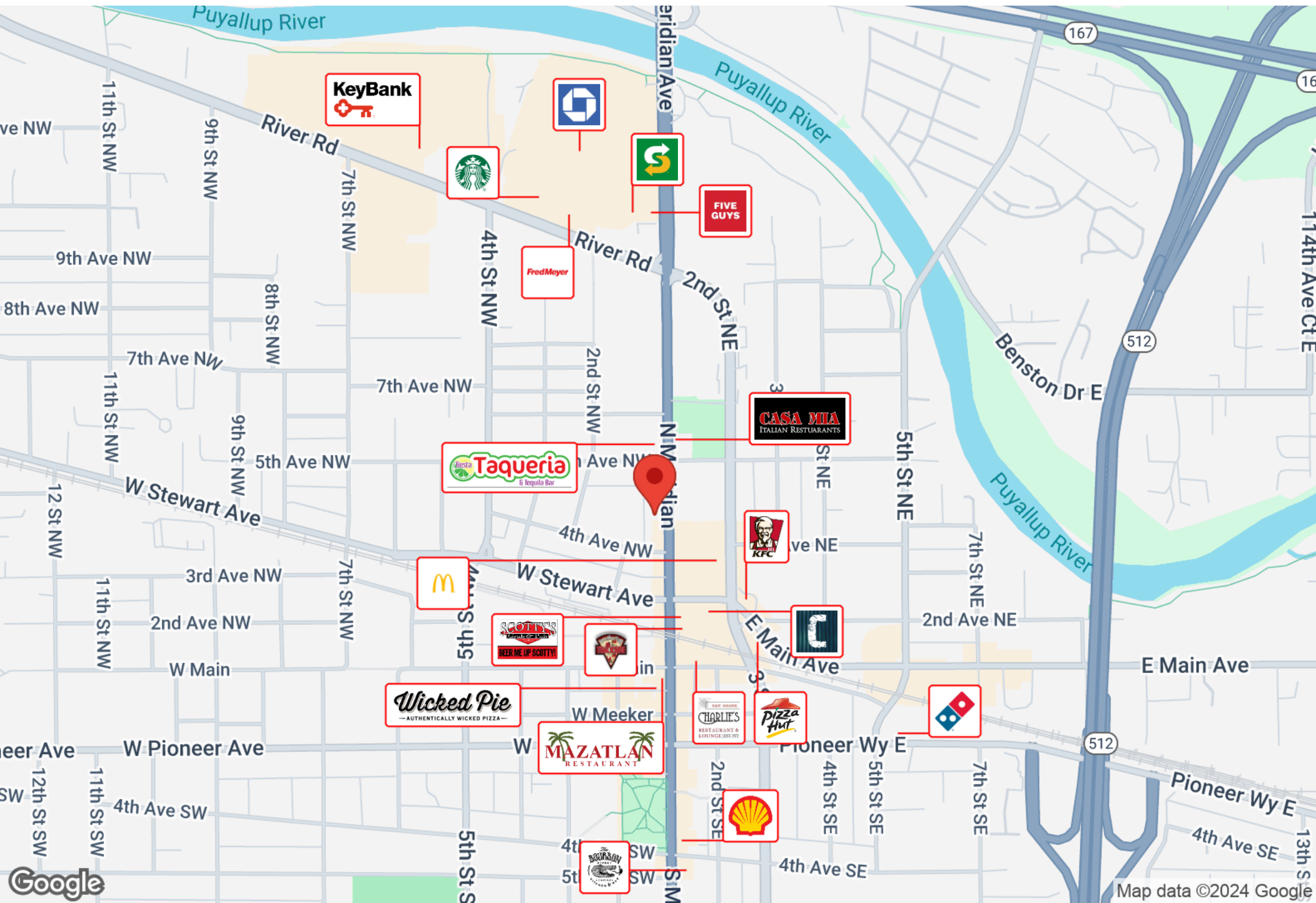
LOCATION MAPS

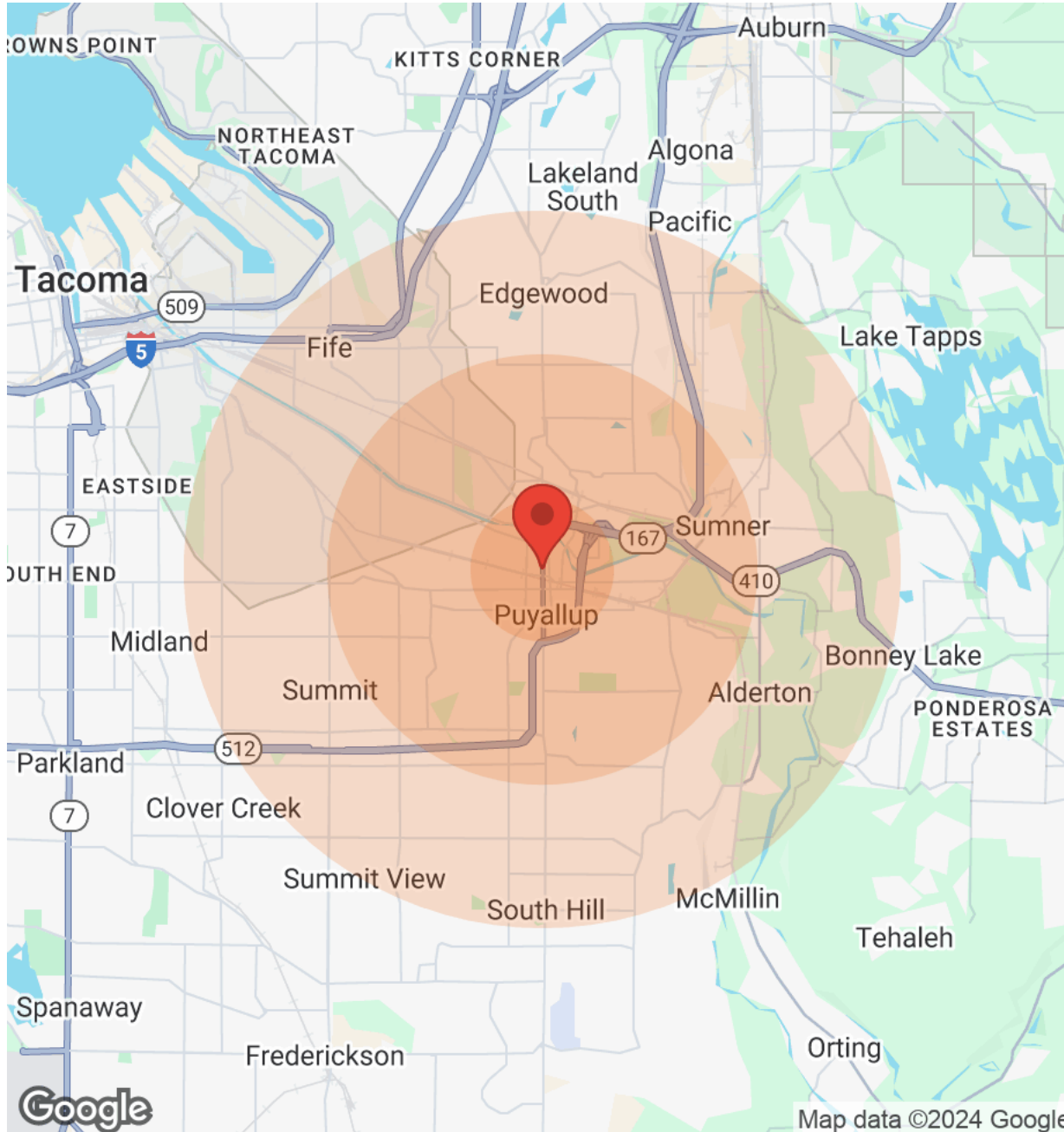
BUSINESS MAP
