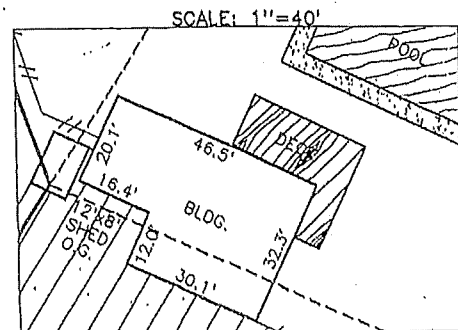


DOGWOOD ROAD
