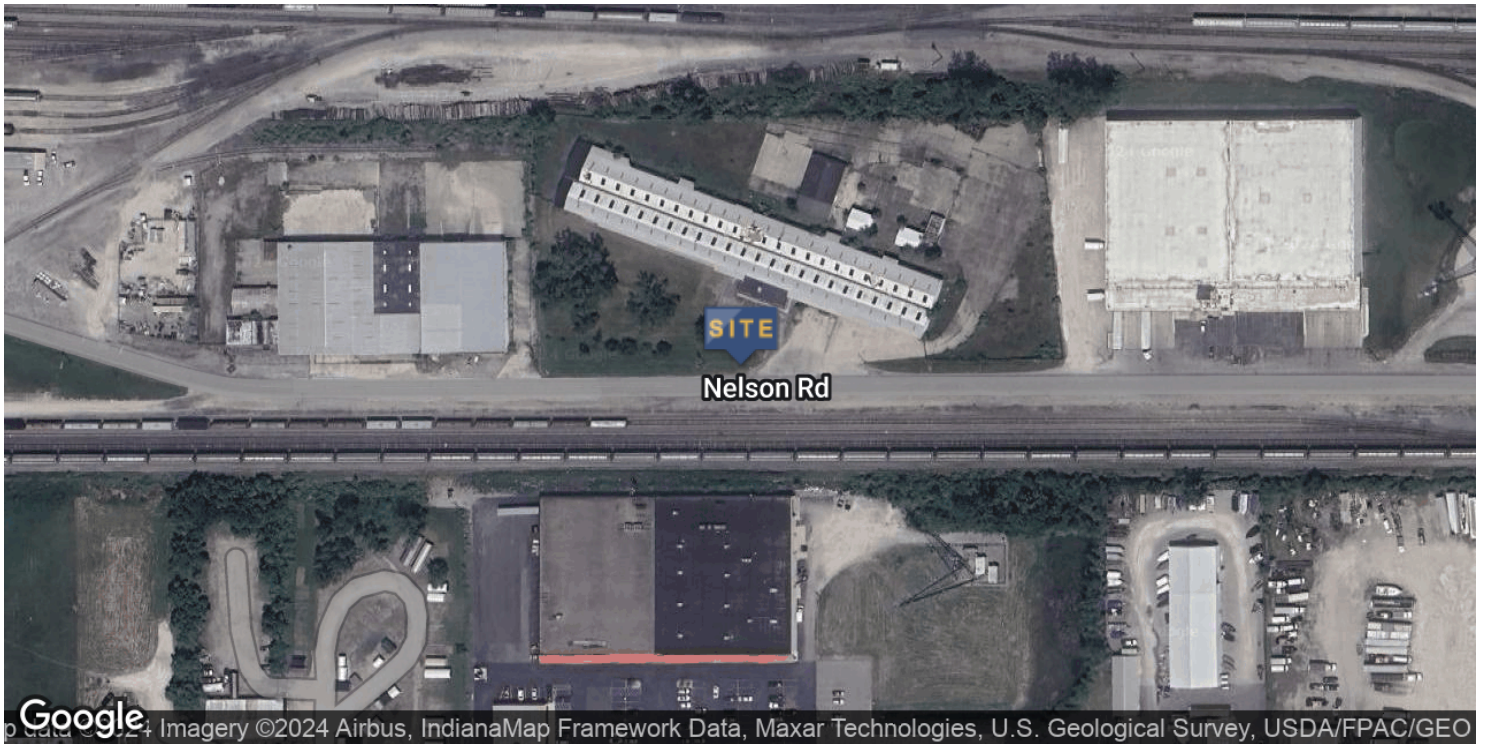

40,240 SF INDUSTRIAL BUILDING



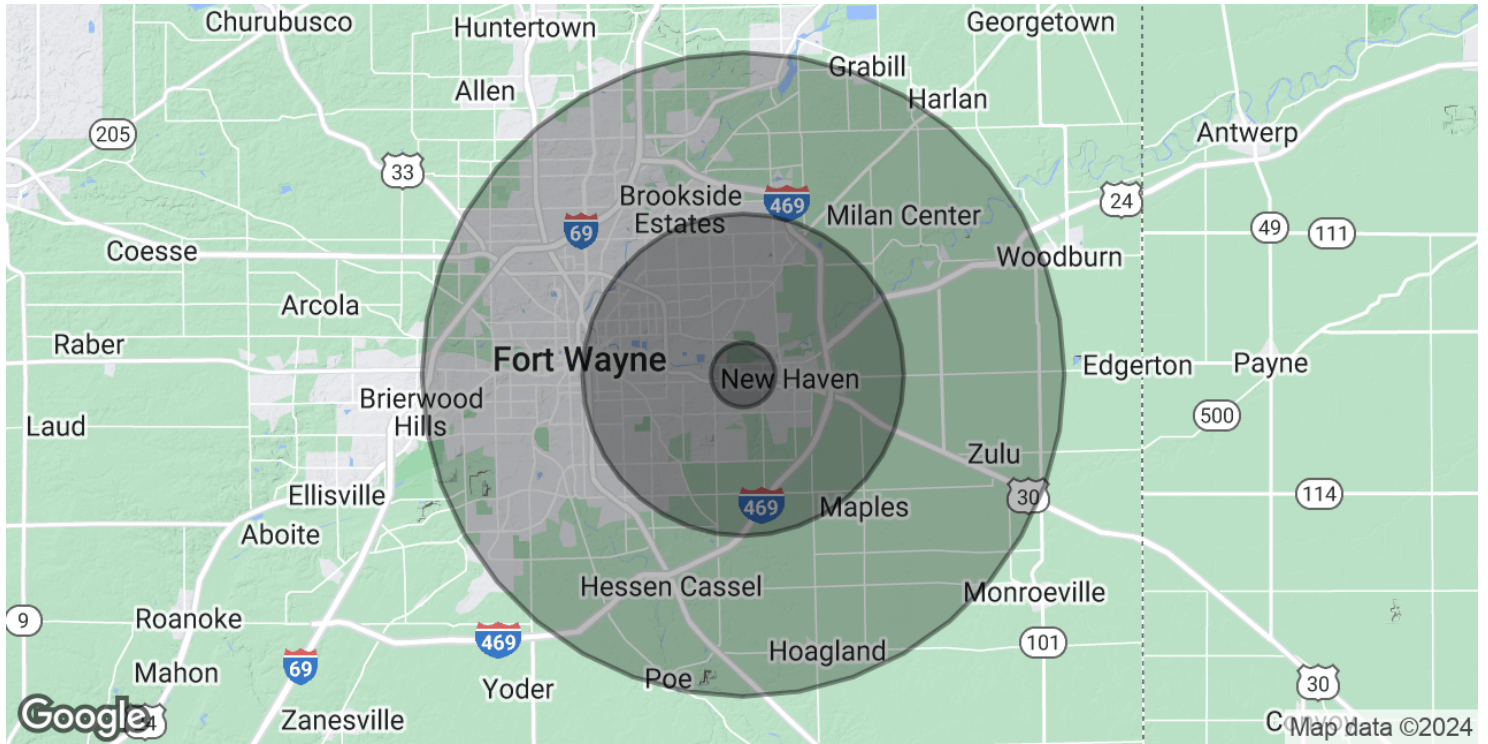
