Housing In Summary

Currently 28.8% of the 6,150 housing units in the area are owner occupied; 71.2% renter occupied; and 5.6% are vacant. 64.6% of the housing units in the US are owner occupied; 35.4% are renter occupied; and 10.0% are vacant. In 2010, there were 5,824 housing units in the area - 27.1% owner occupied, 61.6% renter occupied, and 11.3% vacant. The annual rate of change in housing units since 2020 is 0.1%. Median home value in the area is \$345,511, compared to a median home value of \$308,943 for the U.S. In five years, median home value in the area is projected to change to \$469,089, compared to a median home value of \$350,006 in the US.
