






Information About Brokerage Services

Texas law requires all real estate licensees to ghe the following information about brokerage services to prospective buyers, tenents, seliers and landfords

IVES OF REAL BITATE LICENSE HOLDERS:

- A **ENCVER** is responsible for all trainings activities, including acts performed by asks agents operacised by the broker. A **SALES AGENT** must be apprecised by a broker and works with clients on behalf of the broker.

KONCENTS INFIMIUM DUTTER INCOMPED BY LANY (A client is the person or party that the broken represents) ₹

- Put the Interests of the client stoove all offices, including the broker's own interests;
- inform the client of any material information about the property or transaction received by the broker;
 - Answer the clerits queetions and present any offer to or counter-offer from the clerit, and
 - Treat of parties to a mai actain transaction honeafy and thirty.

AS AGENT FOR OWNER (IELLENA ANDLOND): The broker become the property owner's agent through an agreement with the owner, usually in a written listing to self or property management agreement. An owner's agent must perform the broker's minimum duties above and must infam the owner of any material information about the property or transaction known by the agent, including information declosed to the agent or subagent by the buyer or buyer's agent.

AS AGENT FOR BUYERTEANT: The braker becomes the buyenherent's agent by ageeing to represent the buyer, usually through a writen representation agreement. A buyen's agent must perform the broken's minimum duties above and must inform the buyer of any meterial information about the property or terreaction forown by the agent, including information disclosed to the agent by the eatler or eatlerte agent.

AS AGENT FOR BOTH - BUT BURGUARY: To act as an intermediary between the parties the broken must first obtain the written spreament of each party to the transaction. The written agreement must state who will pay the broken and, in conspicuous bold on underfined print, act tonk the broken's obligations as an intermediary. A broken who acts as an intermediary.

- Must trast all parties to the transaction impartially and faitly. May, with the parties' consent, appoint a different license inciden esercisited with the broker to each party (owner and buyer) to communicate with, provide opinions and advice to, and carry out the hebructions of each party to the transaction.
 - Must not, unless specifically suffortised in writing to do so by the party, disclose:
 - that the owner will accept a price besitten the written colling price; ÷
- that the buyer/tenent will pey a price greater then the price addrifted in a written ofter, and any confidential information or any other information that a party apecifically instructs the broker in writing not to diadoes, unless required to do so by law.

AS SURMENT: A license holder acts as a subegent when siding a bujer in a transaction without an agreement to represent the bujer. A subagent can assets the bujer but does not represent the bujer and must place the interests of the owner that.
