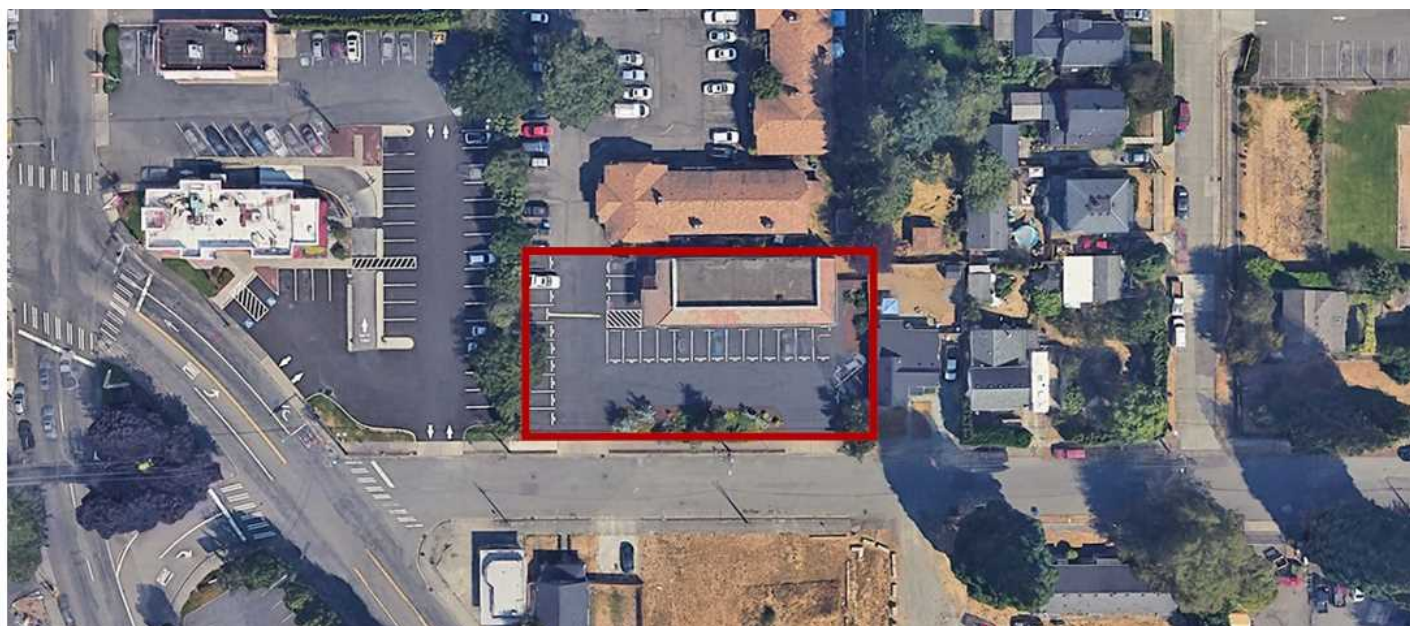

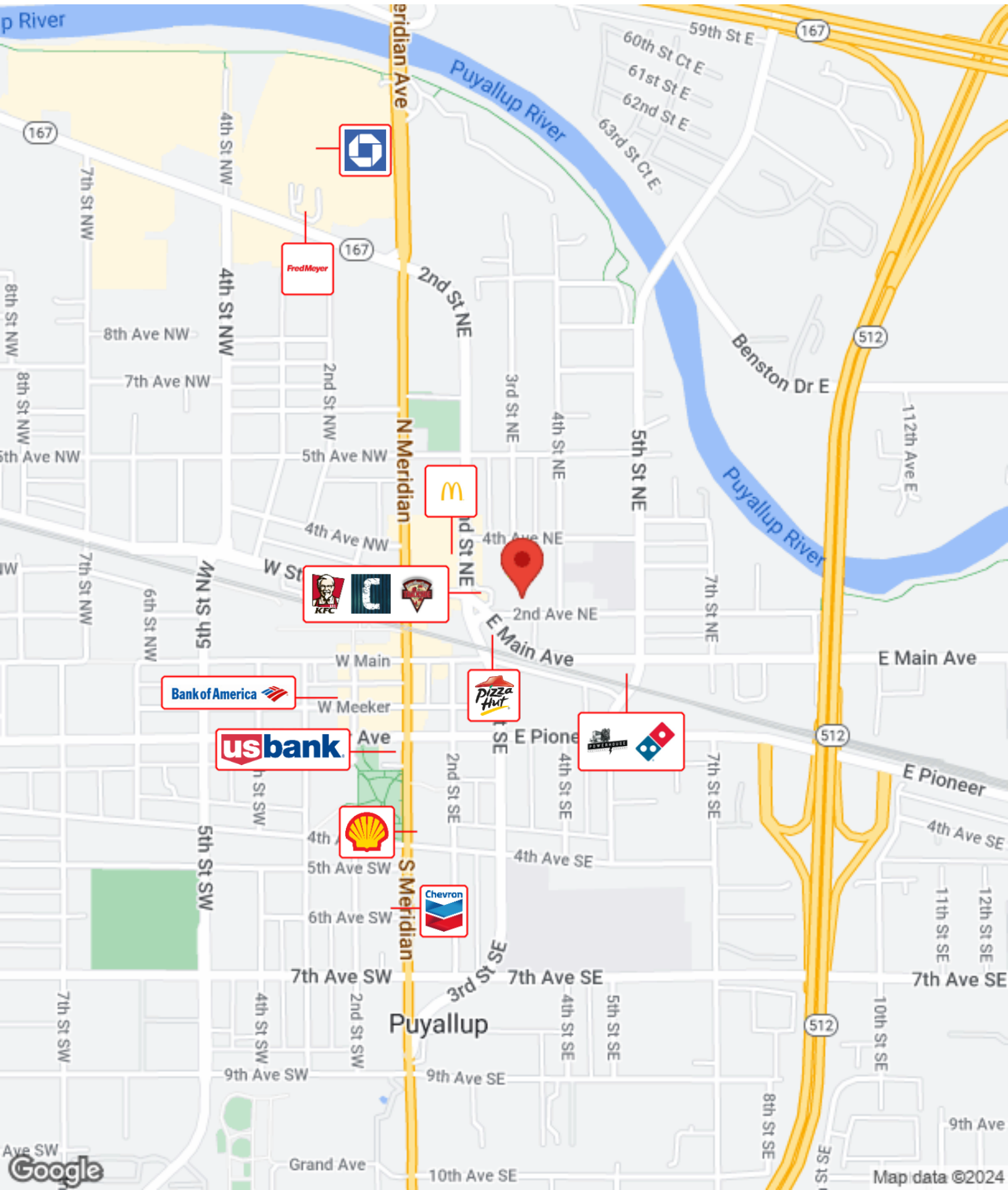

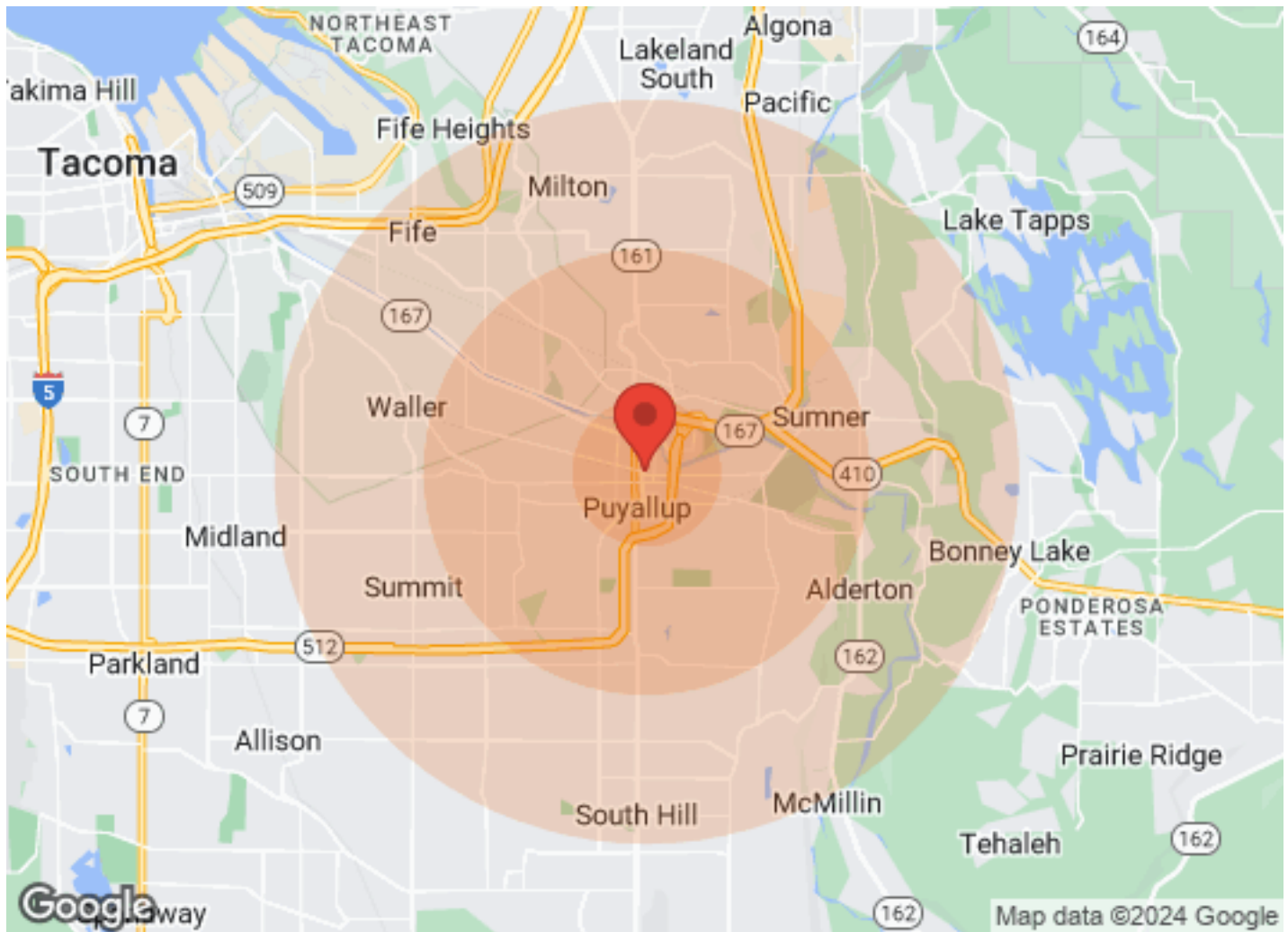
BUSINESS MAP
