Central AC and heating throughout the building. New metal roof in 2024, ozone sterilization in each HVAC system, cameras (interior and exterior), and remote smart capabilities. 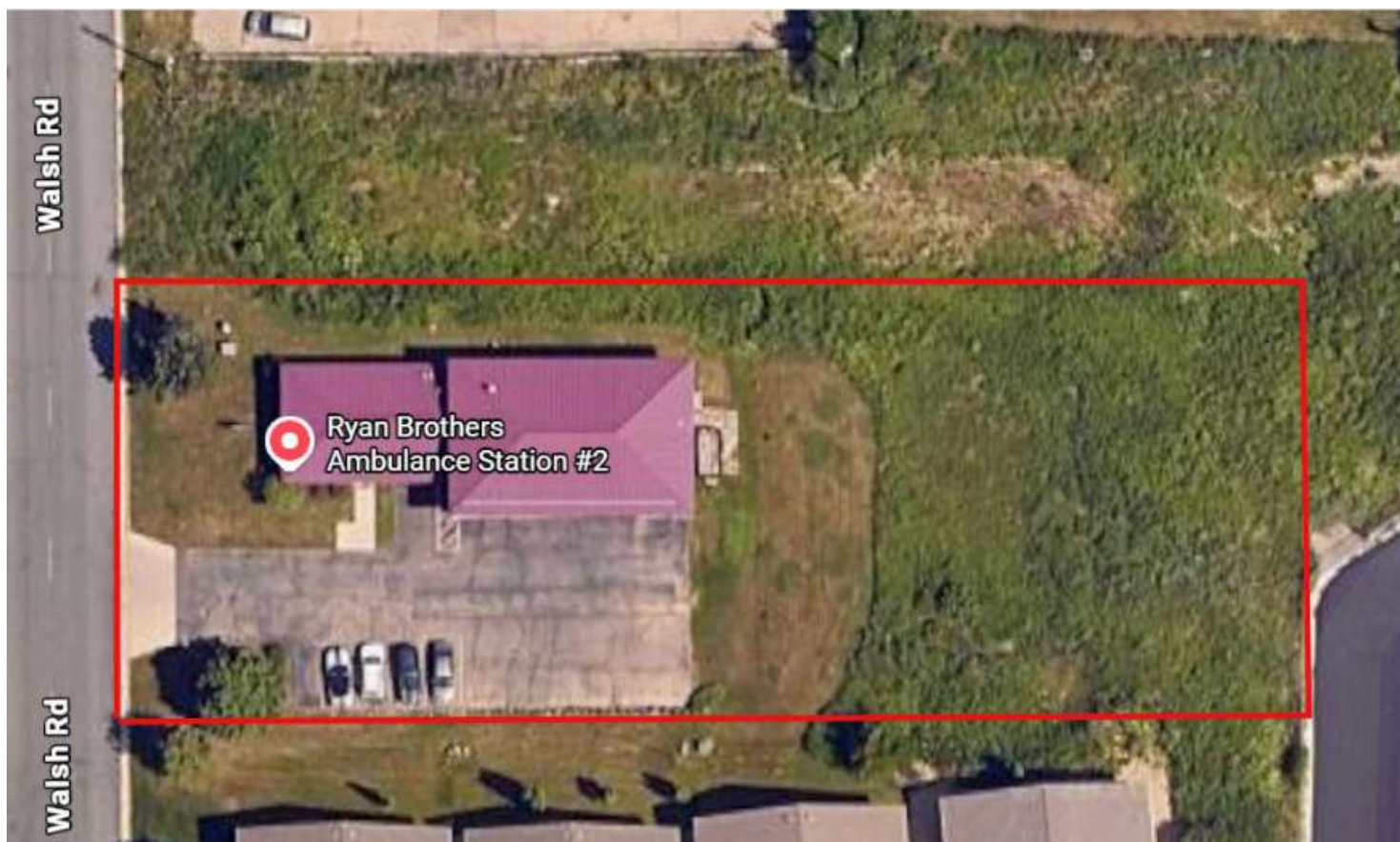

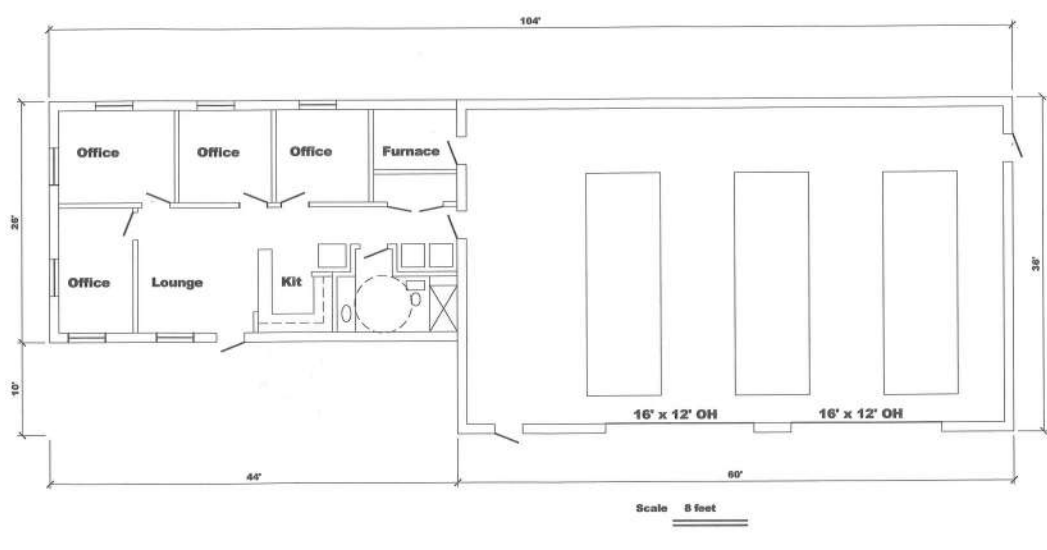

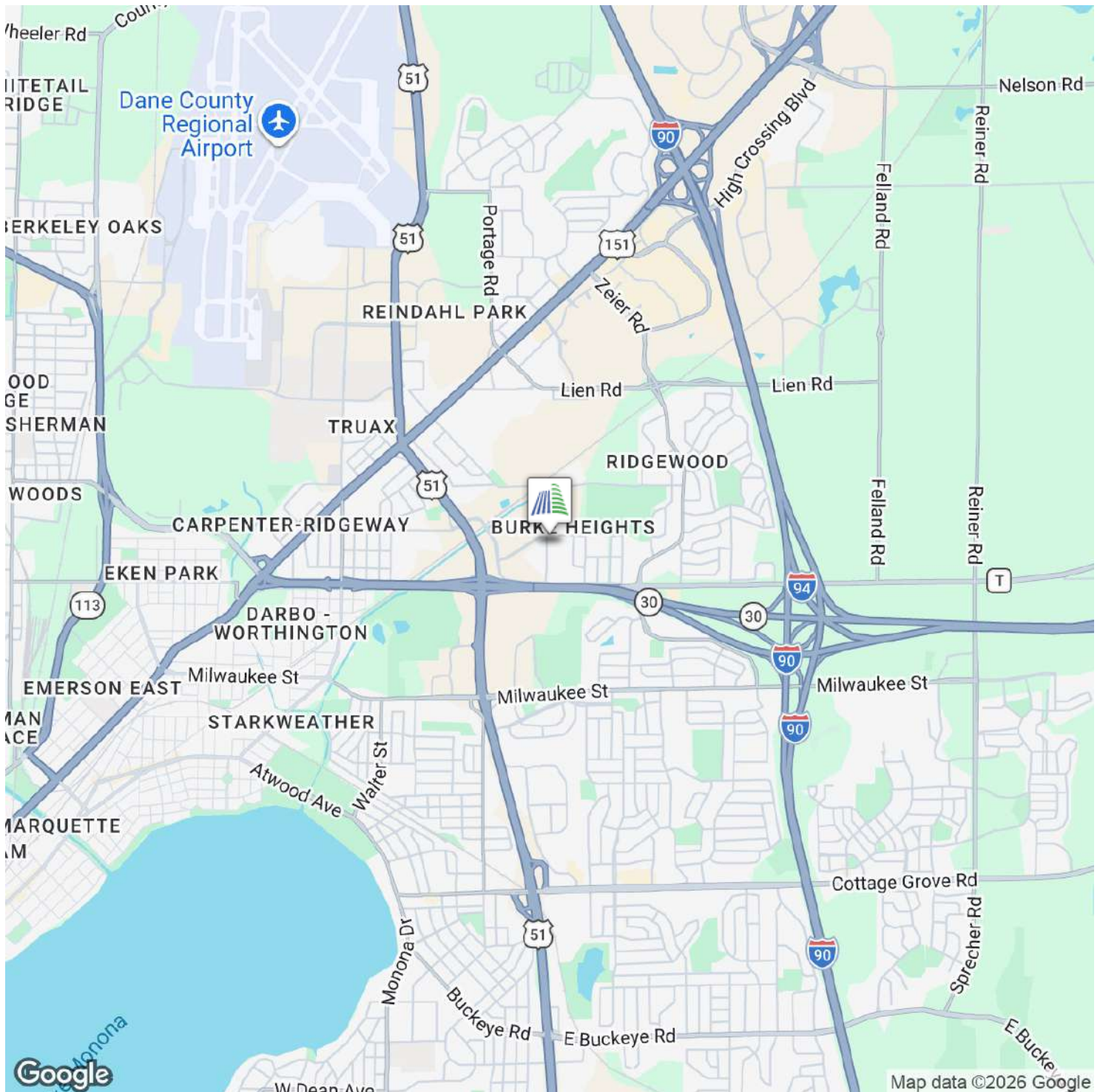
// SITE PLANS
