### HIGHLIGHTS

- AVAILABLE: Anchor space (54,232 SF); up to 30,193 SF anchor space on the front of the
  mall; 6,502 SF restaurant space on the front of the mall; and interior mall space ranging
  from 630 SF up to 9,135 SF at the Cross County Mall with Rural King, Marshalls, Dunham's
  Sports, and more. The Cross County Mall is located within the primary shopping area in
  the Charleston-Mattoon Micropolitan Statistical Area, which has a trade area population
  of 101,319.
- Emerald Acres Sports Connection, a new \$100 million indoor and outdoor sports complex (now open), is located across the street and is projected to draw 580,000 visitors and generate \$23.8 million in direct spending and 59,000 hotel room nights on an annual basis.
- This market and Rural King draw from up to 30 miles in all directions and as far as to cities such as Chicago, Indianapolis, and St. Louis with the draw of Emerald Acres Sports Connection (leasing also by Goodman Real Estate Services Group).


