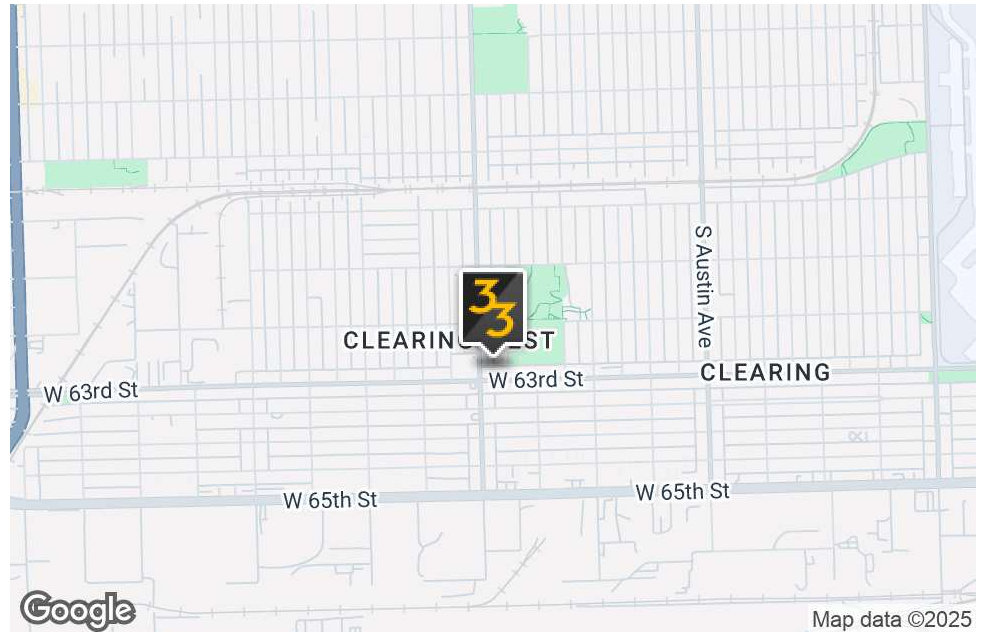
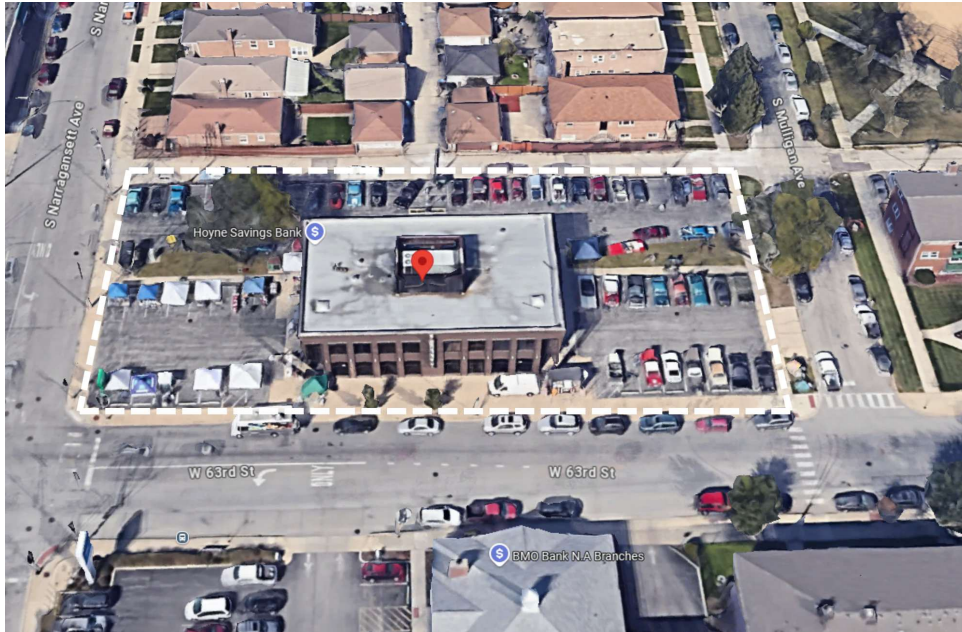

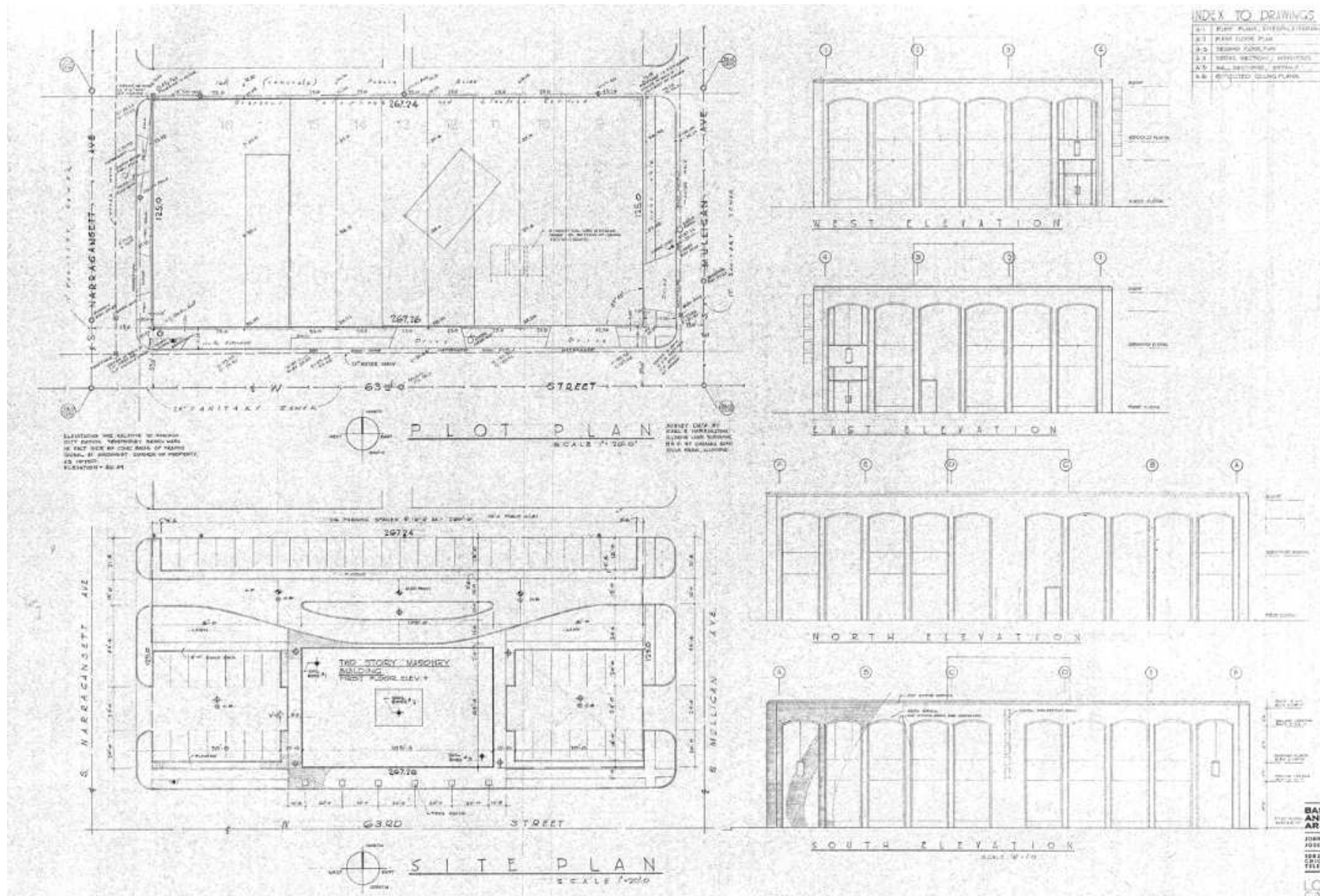
EXECUTIVE SUMMARY OVERVIEW

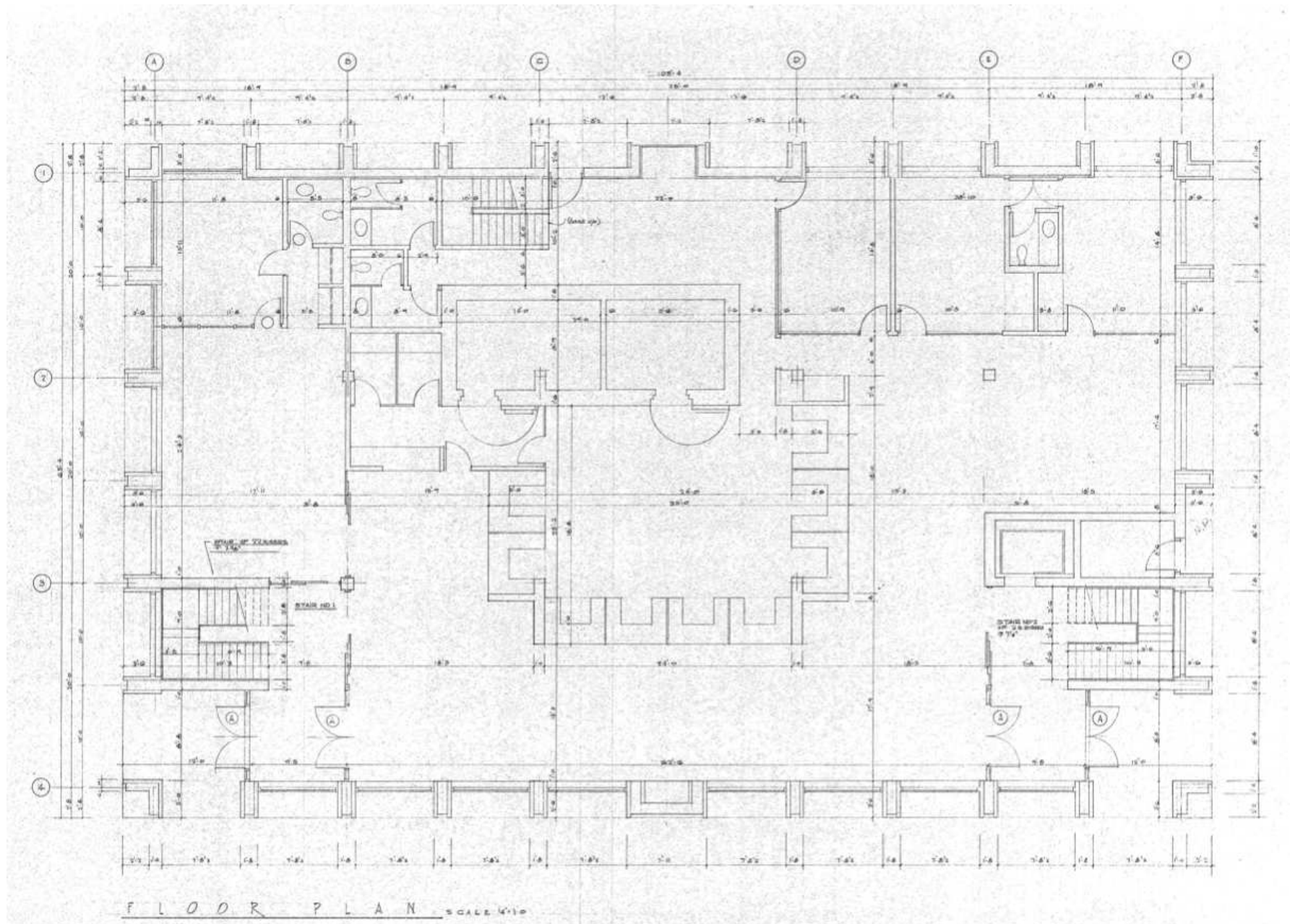
