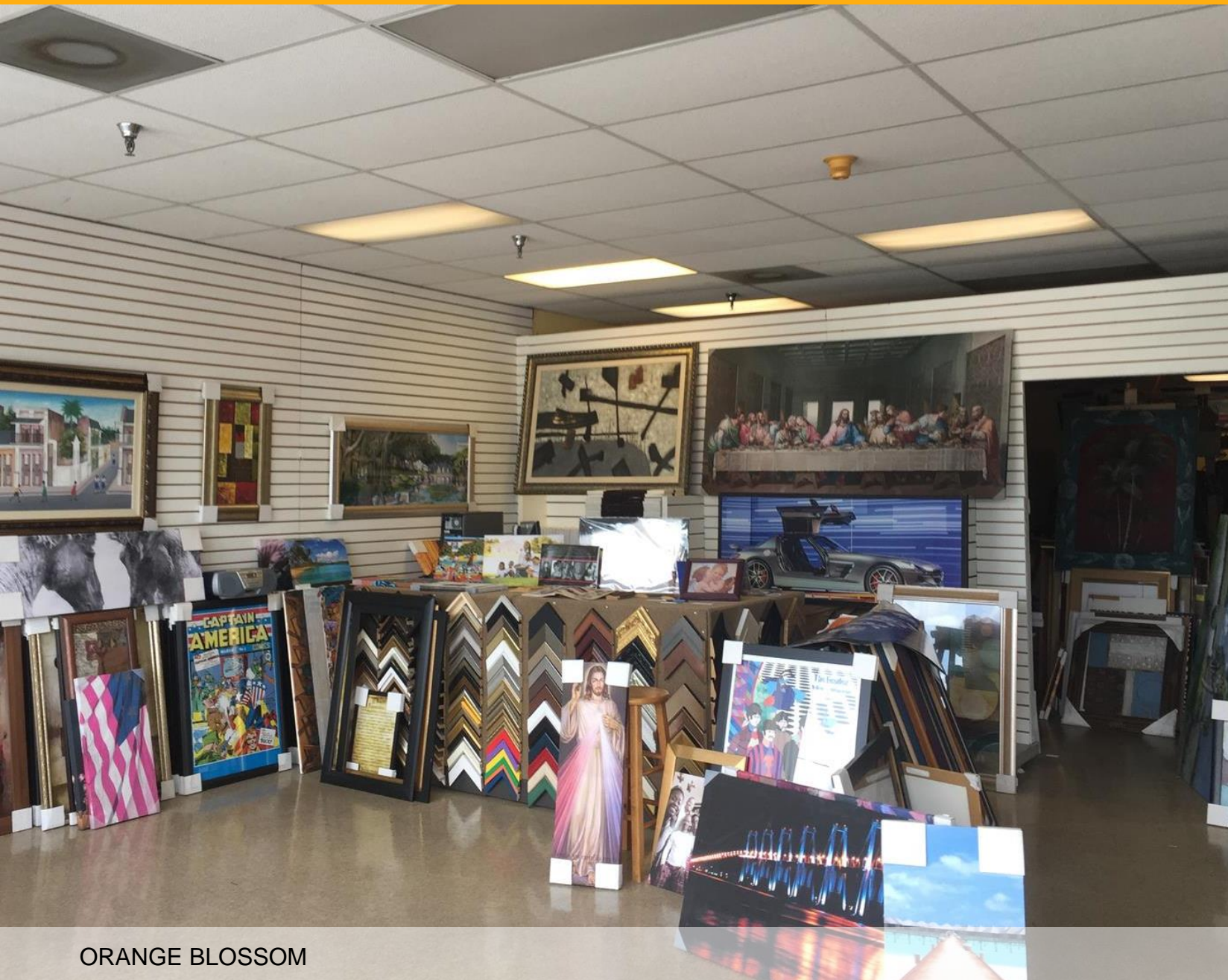
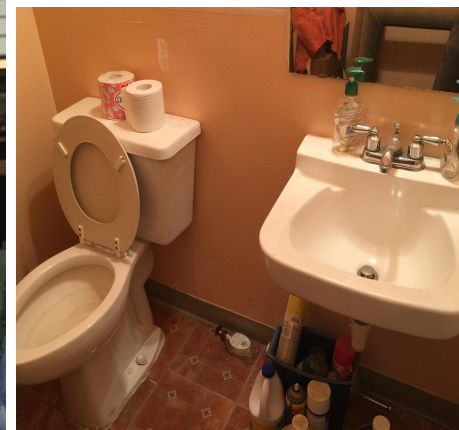

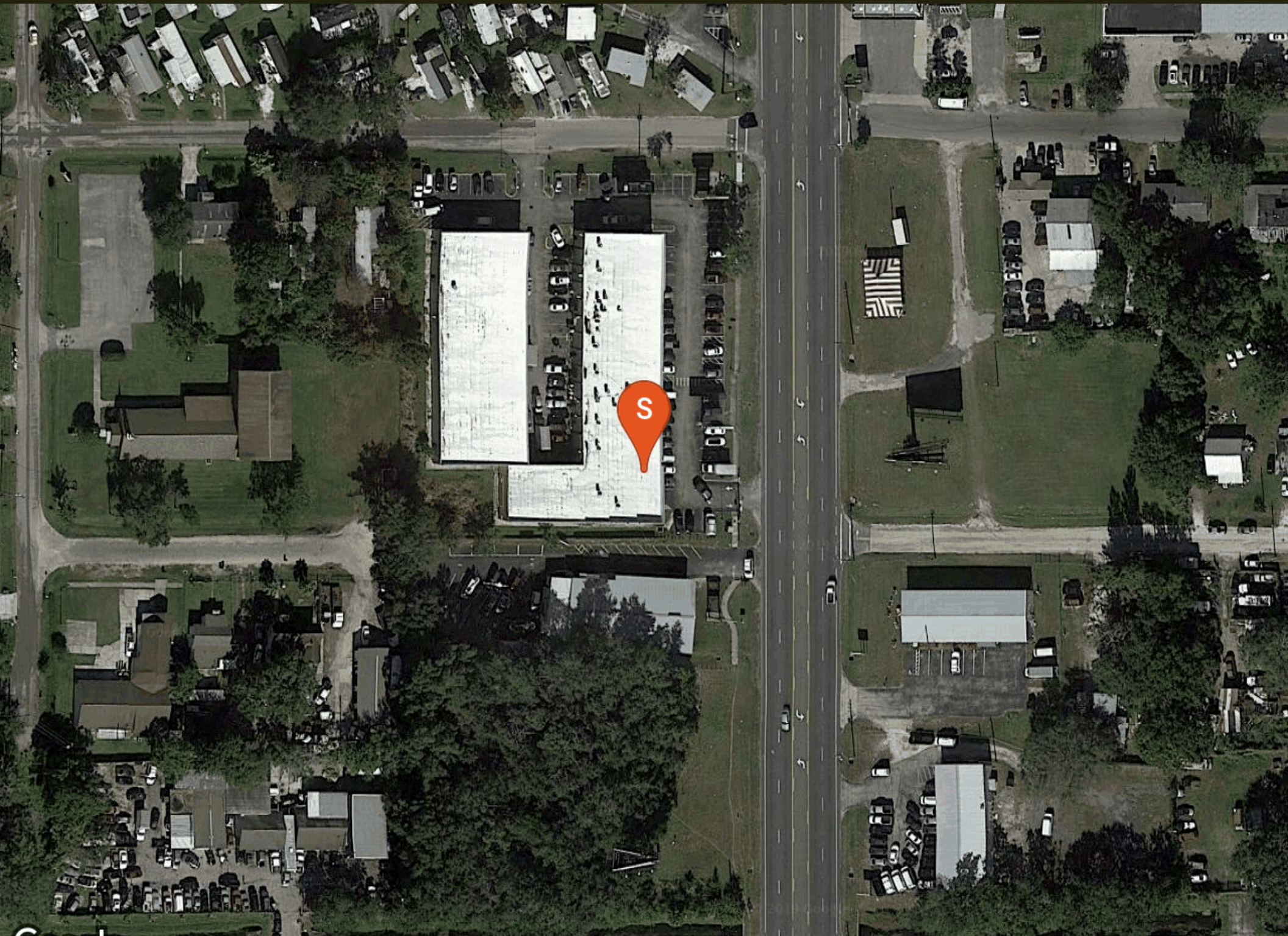


Locator Map
