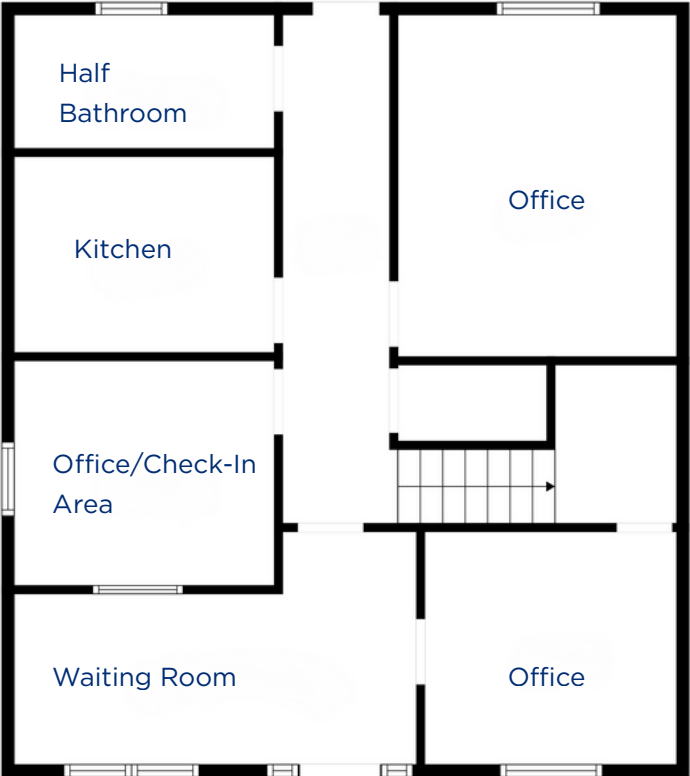

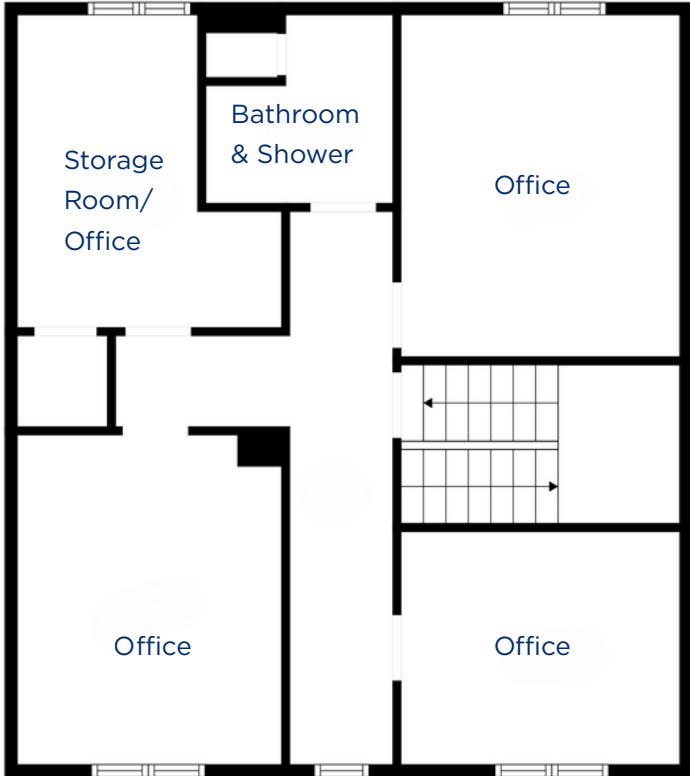


# Floor Plan

Floor 1

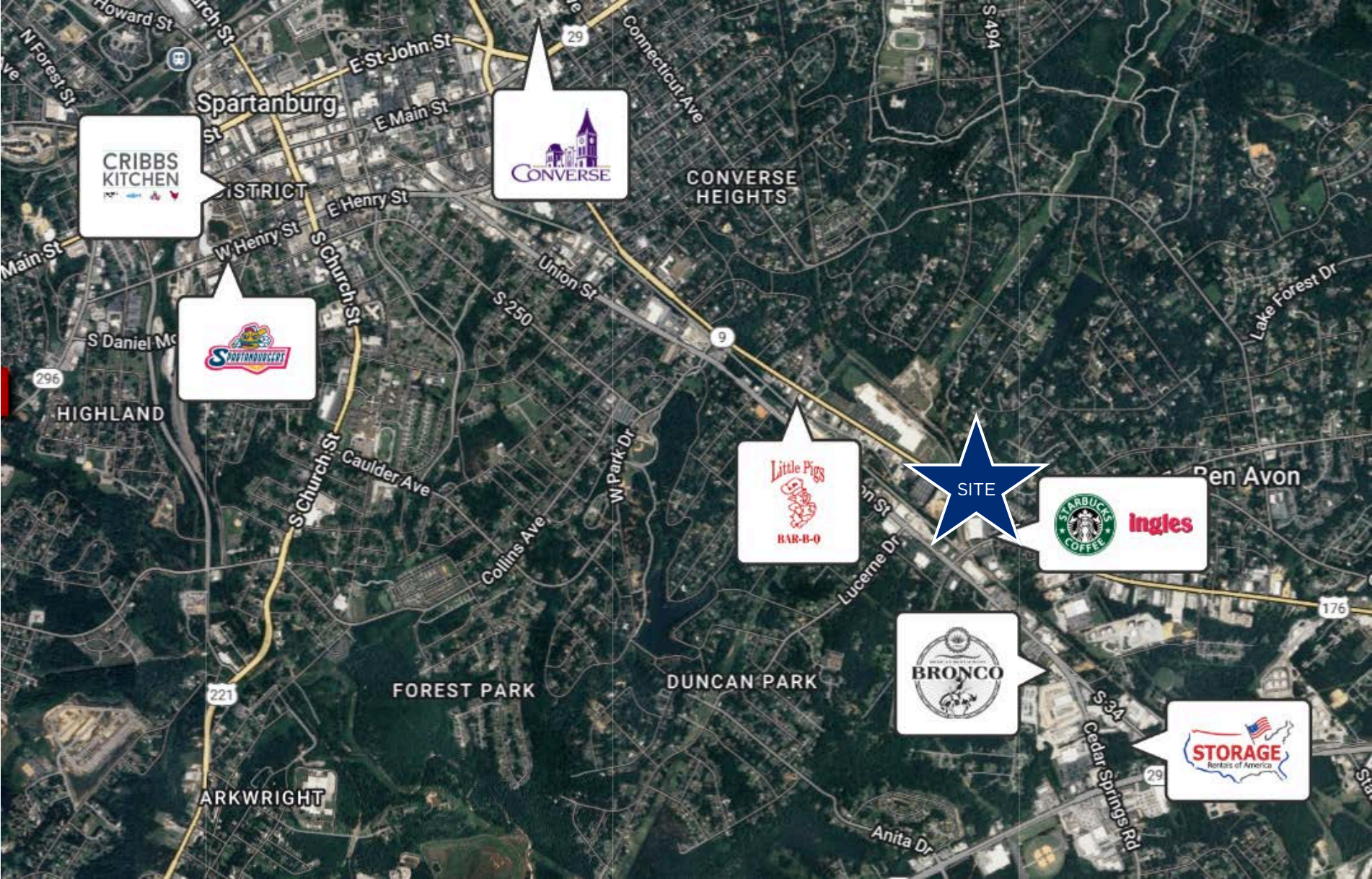


Floor 2
