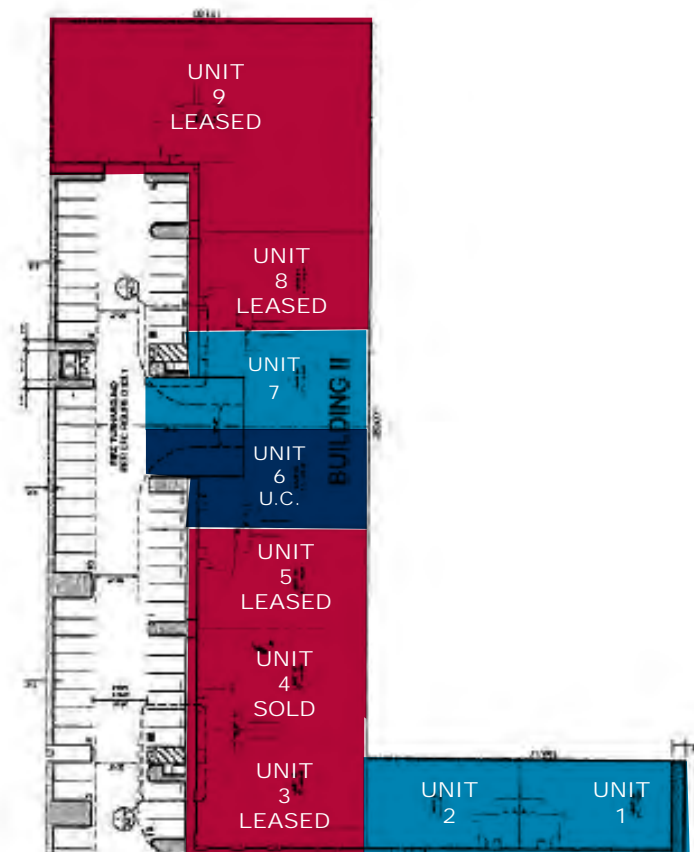

SITE PLAN



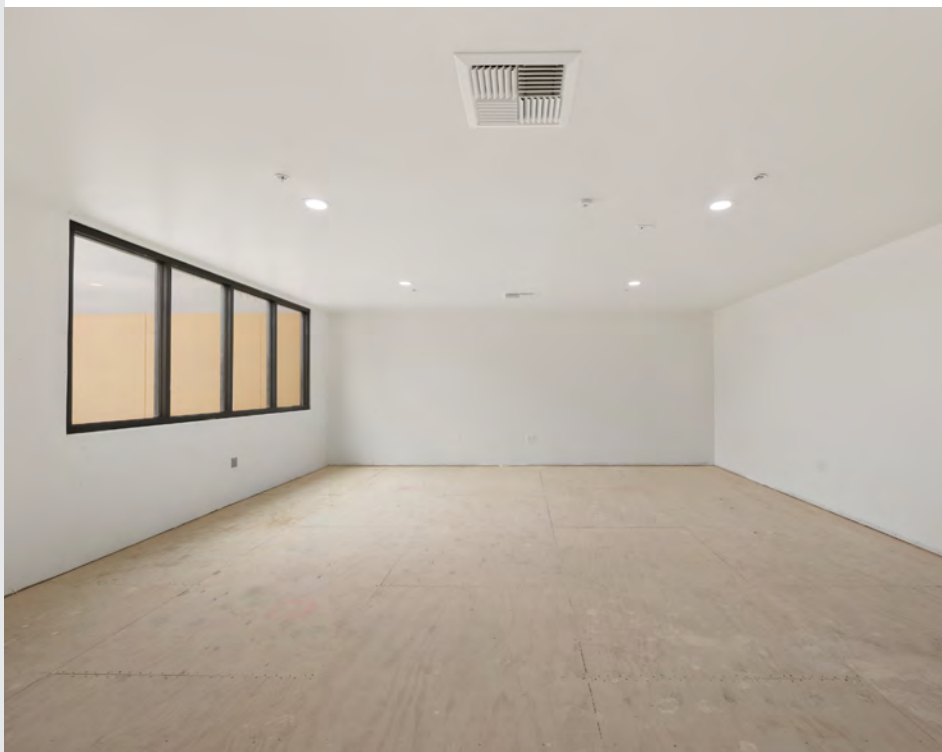
