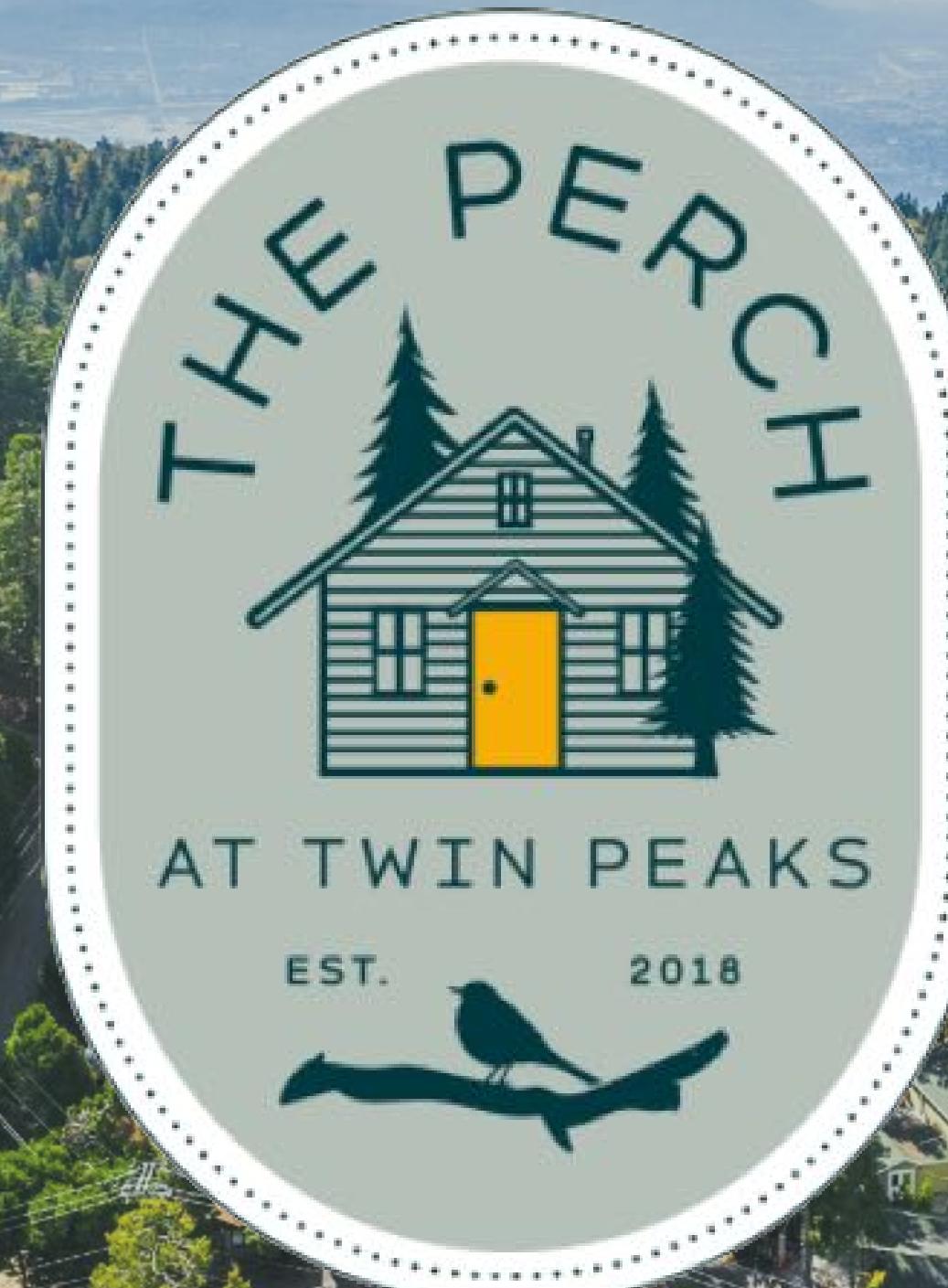

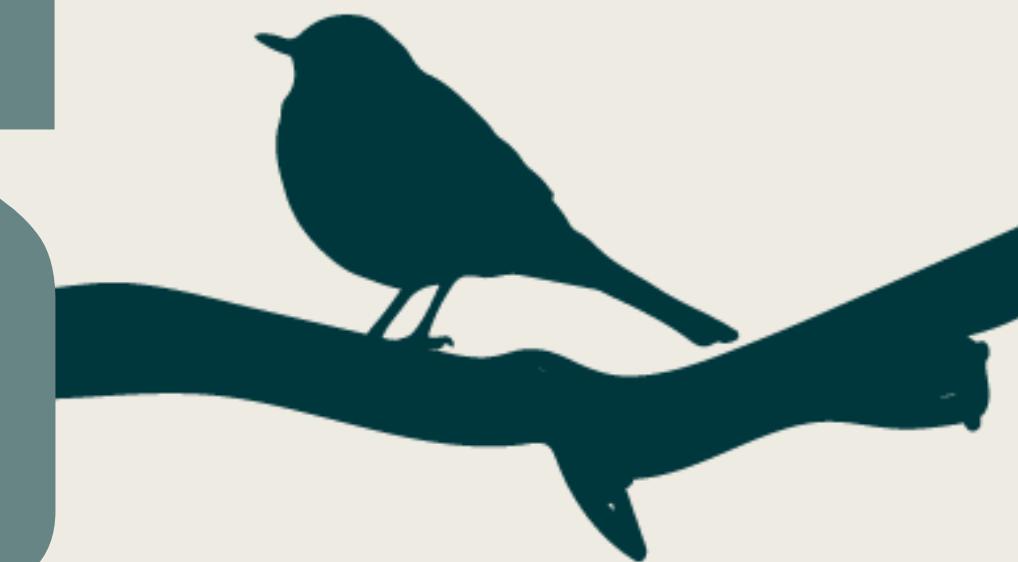

# Property Description



# DESCRIPTION *of the property*

Strands Realty Group is pleased to exclusively present The Perch at Twin Peaks, a 13-cabin boutique retreat venue set on approximately 4 acres in the San Bernardino Mountains, just minutes from Lake Arrowhead and under two hours from Los Angeles. Tucked among mature pines at roughly 6,000 feet elevation, The Perch offers a rare blend of privacy, character, and accessibility that has attracted everyone from corporate retreat groups and wellness practitioners to wedding parties and creative professionals. The property comprises thirteen detached cabins with a total of 23 bedrooms and 16 bathrooms, thoughtfully arranged around a central barn and common outdoor areas. Most cabins have been extensively renovated with eclectic, mid-century-inspired interiors while preserving their original 1930s mountain-cabin exteriors, creating a warm, design-forward environment that feels both nostalgic and contemporary. A large in-ground pool, currently empty and awaiting full rehabilitation, and one cabin in need of complete renovation (Cabin 11) represent clear, tangible value-add components for the next owner.

Legally recognized by San Bernardino County as a non-conforming lodging use predating current zoning, The Perch operates outside of the County's STR ordinance and may continue to rent its cabins on a short-term basis without additional land use approvals—an increasingly rare advantage in California's mountain resort markets. The property's flexible layout supports a variety of use cases: full buyouts for corporate offsites and wellness retreats, intimate micro-weddings utilizing the barn and outdoor gathering spaces, or a hybrid model combining group events with individual cabin bookings. Recent high-profile events, including a Vogue-featured celebrity wedding, have elevated The Perch's brand profile and demonstrated its appeal as a destination venue. Offered with all real estate, business operations, furnishings, website, systems, and social media included in the sale, The Perch at Twin Peaks presents an exceptional opportunity for a retreat operator, wedding venue owner, or boutique hospitality investor to acquire a highly visible, experiential mountain asset with meaningful upside through the completion of existing improvements, activation of the pool, and curated expansion of wellness and outdoor amenity offerings.

In October 2025, The Perch at Twin Peaks hosted a wedding that captured the attention of the nation's most discerning publications. Actress and musician Rainey Qualley married filmmaker Anthony Wilson in an intimate, Halloween-themed celebration featured in *Vogue*—one of the world's most prestigious lifestyle publications. The guest list included actress Andie MacDowell, Emmy-nominated actress Margaret Qualley, Grammy-winning producer Jack Antonoff, and platinum recording artist Shawn Mendes. Professional wedding planner Carly Rae Williams orchestrated the event, while photographer Dana Boulos captured images that appeared in *Vogue*'s wedding portfolio, introducing The Perch to millions of affluent travelers and event planners.

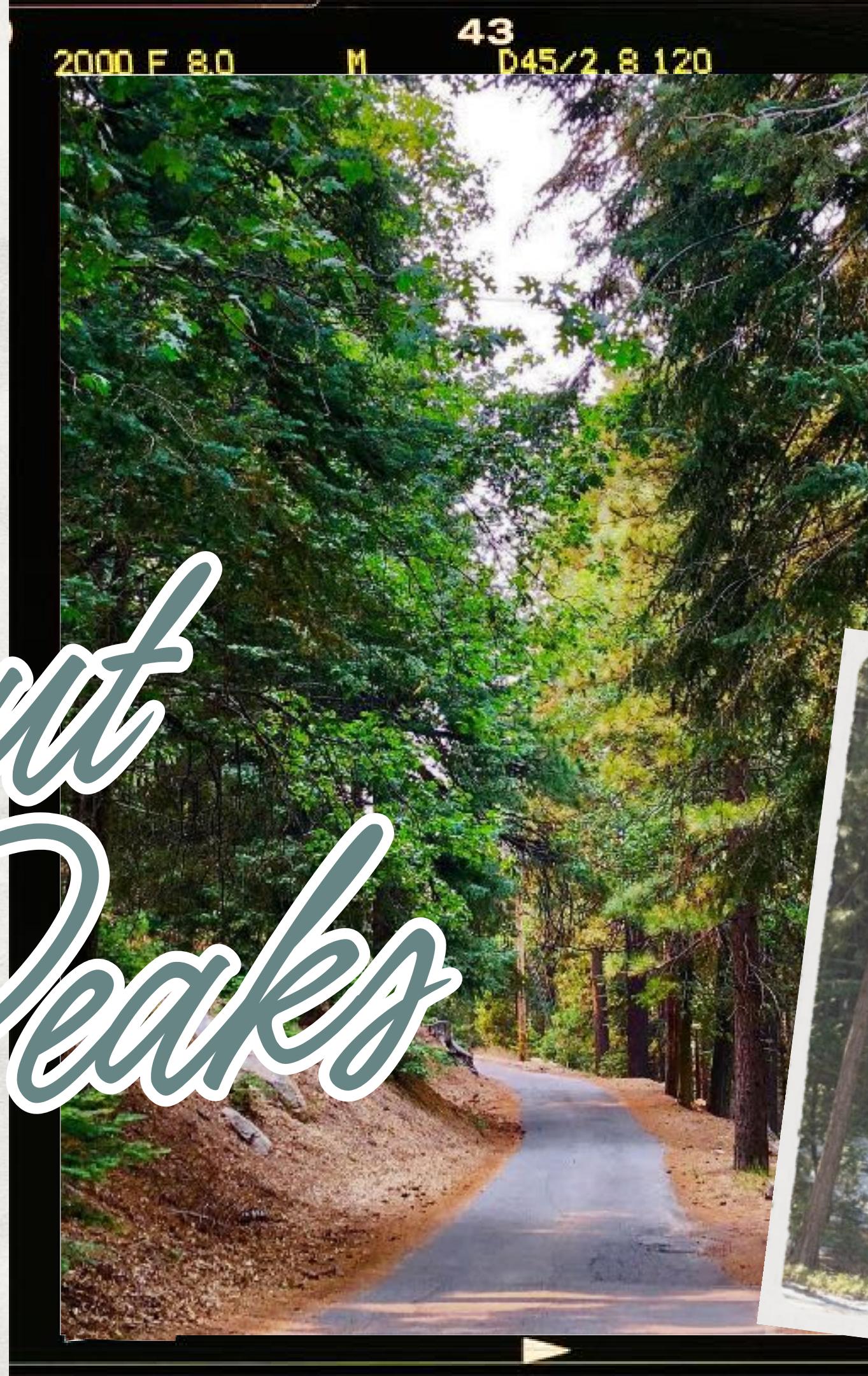

Outdoor enthusiasts are drawn to the region's hiking and mountain biking trails, while Crestline—just minutes away—is one of the country's top-rated paragliding launch sites. In winter, the mountains transform into a snow-dusted retreat, with Snow Valley and Big Bear ski resorts nearby and the whimsical Santa's Village offering family-friendly adventure year-round. Whether visitors are seeking a weekend cabin escape, a quiet place to work remotely, or a venue for life's milestone gatherings, Twin Peaks delivers the kind of peaceful, nature-immersed experience that feels worlds away from everyday life—yet is just ninety minutes from Los Angeles.

Beyond its natural beauty, the Twin Peaks and Lake Arrowhead region draws over four million visitors annually to its charming mountain villages, boutique shops, and locally owned restaurants. Lake Arrowhead Village serves as the area's commercial and social hub, hosting free summer concerts, holiday events, and lakeside fireworks throughout the year. 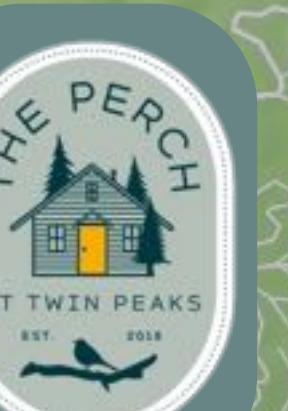
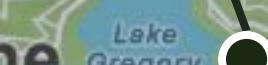

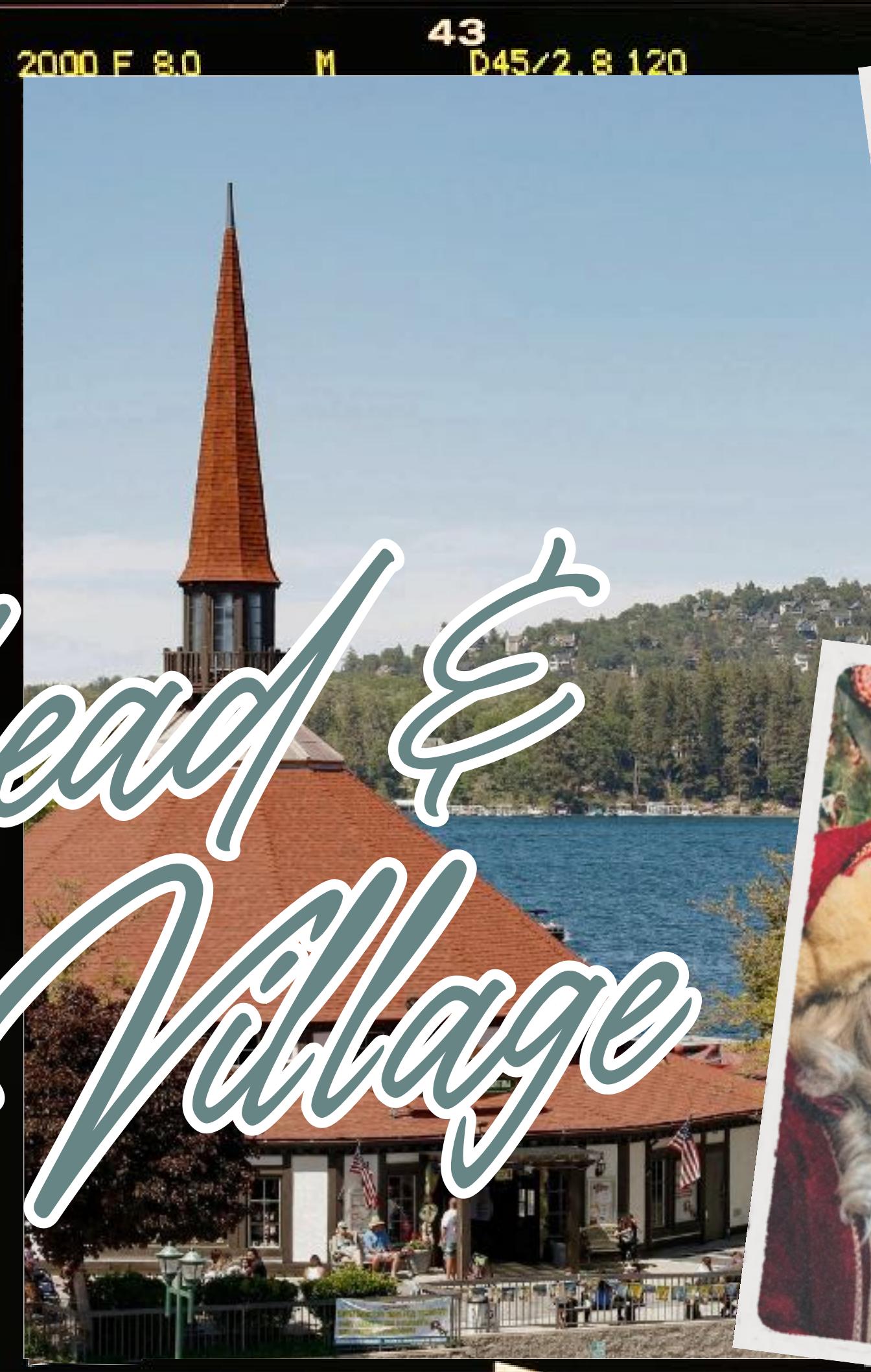

# SkyPark at Santa's Village

SkyPark at Santa's Village and Lake Arrowhead Village anchor the region's year-round draw, combining adventure, family entertainment, and lakefront events within a short drive of The Perch. SkyPark at Santa's Village in Skyforest operates as a four-season outdoor adventure and holiday park, offering mountain biking, ziplining, climbing, skating, live entertainment, and a fully immersive Christmas experience with lights, character shows, tree lightings, and seasonal programming that keeps traffic steady beyond the winter holidays.

## LAKE ARROWHEAD VILLAGE

Lake Arrowhead Village, set directly on the lake, functions as the area's main commercial and social hub, hosting a robust calendar of summer concerts on the waterfront stage, Oktoberfest celebrations, community bonfires, tree-lighting ceremonies, farmers markets, and specialty festivals like brewfests that draw visitors from across Southern California. Together, these two destinations create a continuous events pipeline that supports strong weekend and seasonal demand for retreats, weddings, and leisure stays at nearby properties like The Perch.



## Key Events & Activities:

- **SkyPark at Santa's Village:** Year-round mountain biking, ziplining, rock climbing, skating, rope courses, and live entertainment; holiday season Christmas experience with lights, shows, and character appearances.
- **Lake Arrowhead Village:** Summer Concert Series, Oktoberfest, holiday tree-lighting ceremonies, community bonfires, farmers markets, brewfests, and waterfront dining and shopping.
- **Regional Appeal:** Direct access to Lake Arrowhead water activities (boating, fishing, paddleboarding), hiking and nature trails, scenic Rim of the World Highway drives, and proximity to Big Bear ski resorts

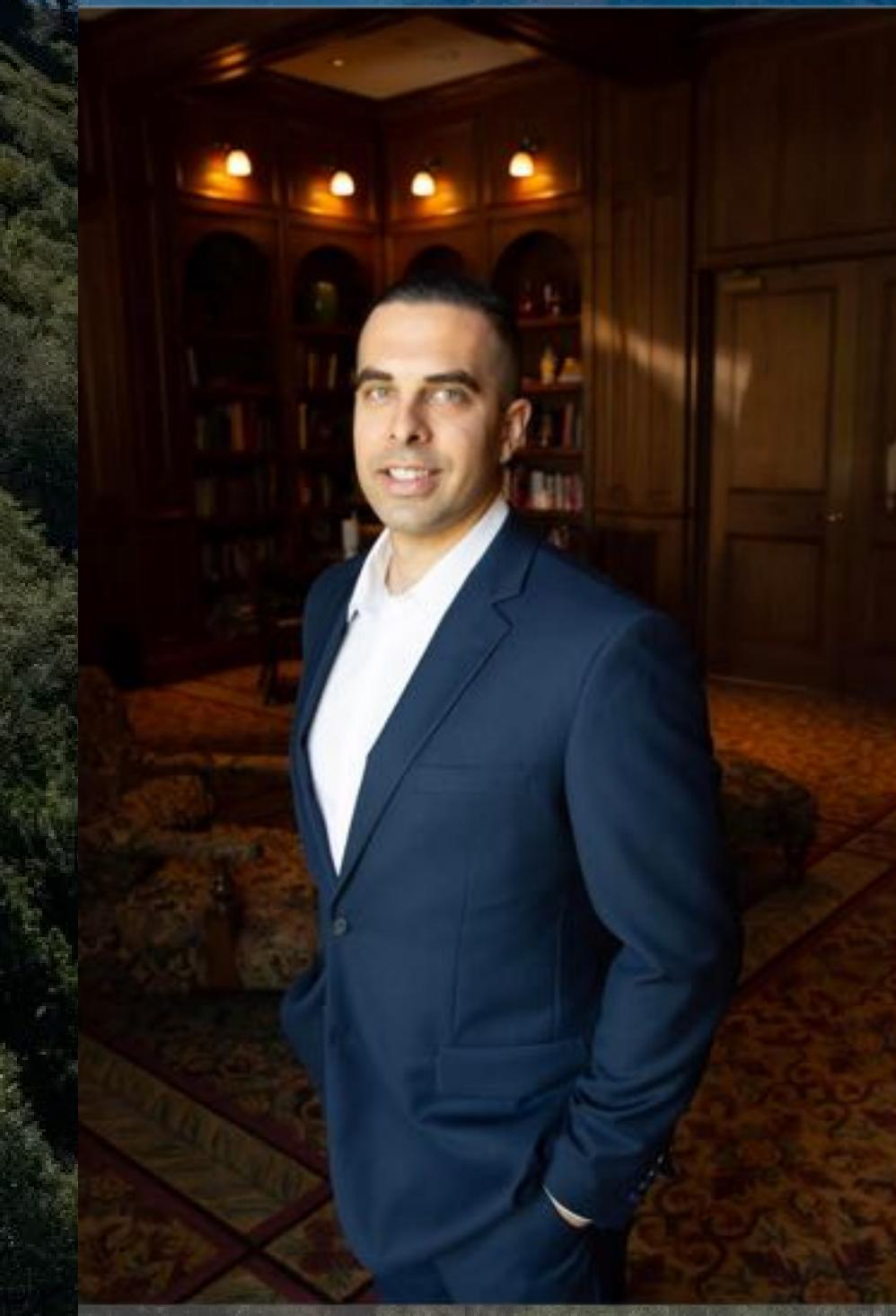
