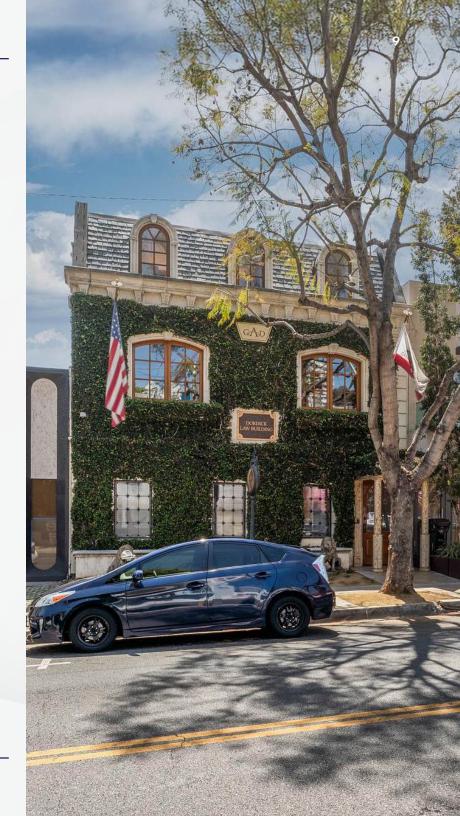

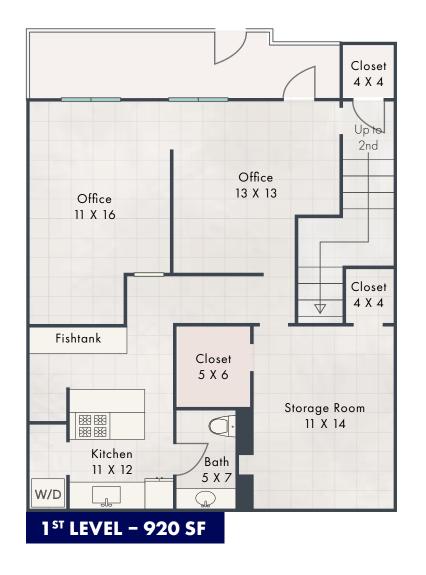




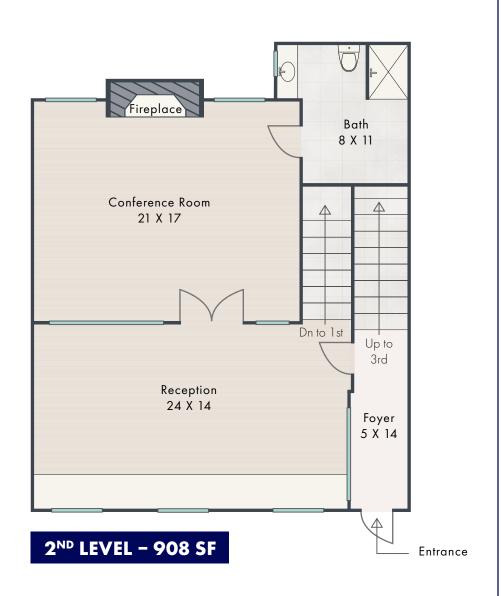
TRANSPORTATION MAP



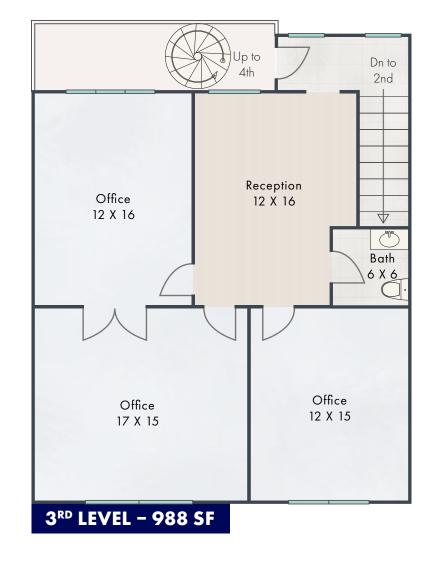
Floor Plans

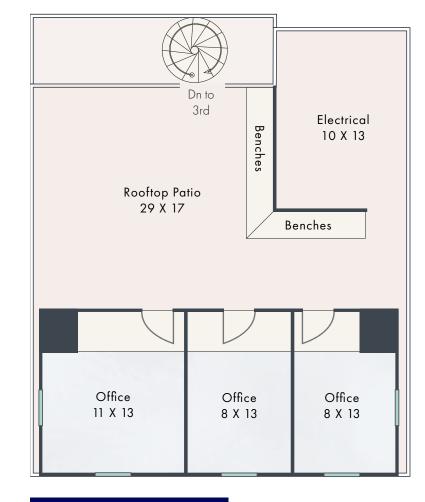
