Allowed uses include: Alcohol and drug centers, residential board and care facilities, social rehabilitation facilities, and more.





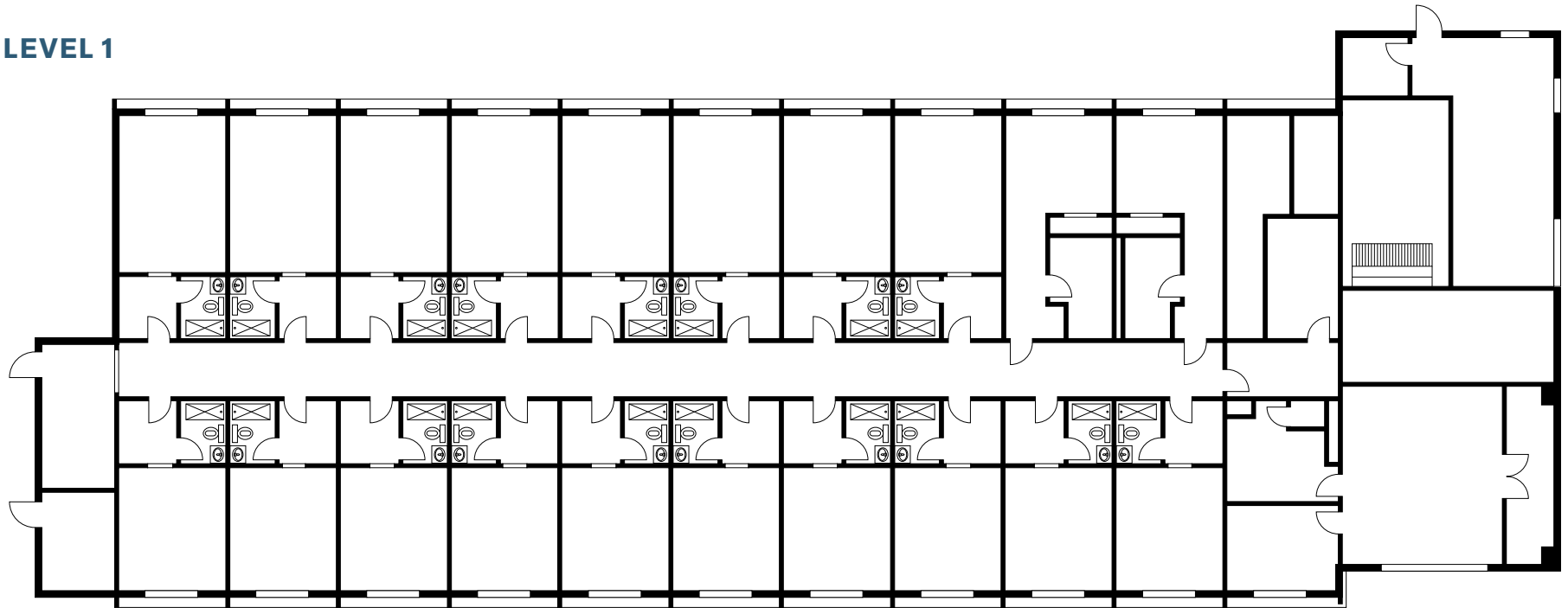

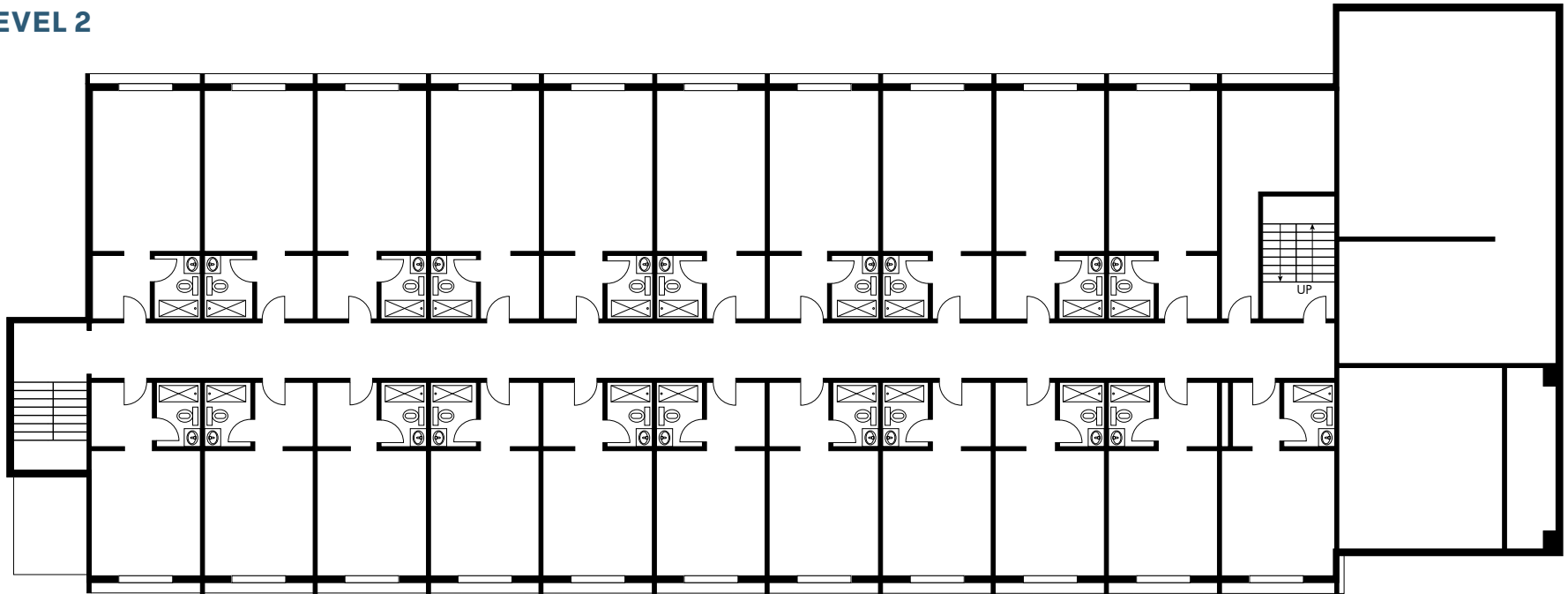
FLOOR PLANS

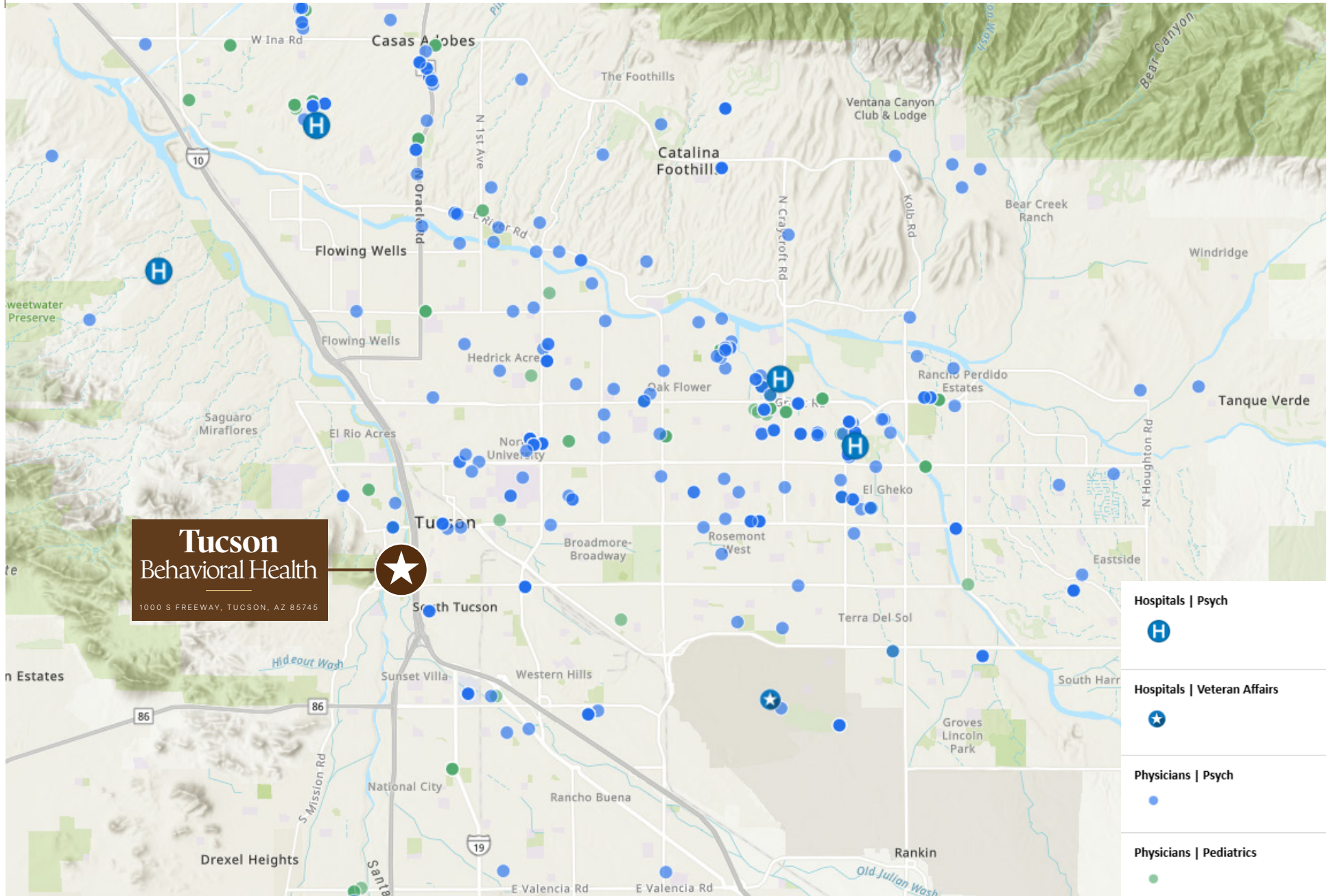

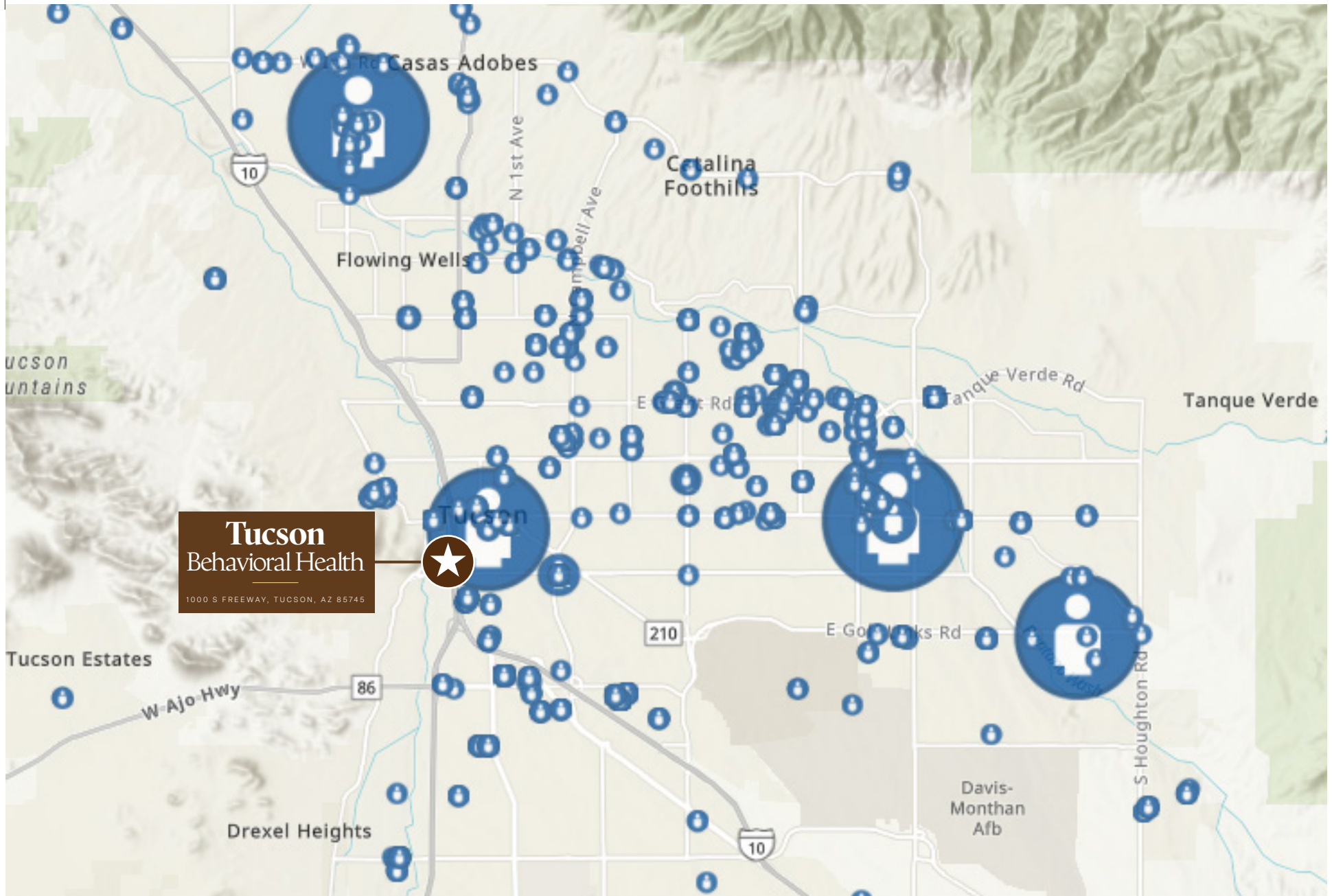

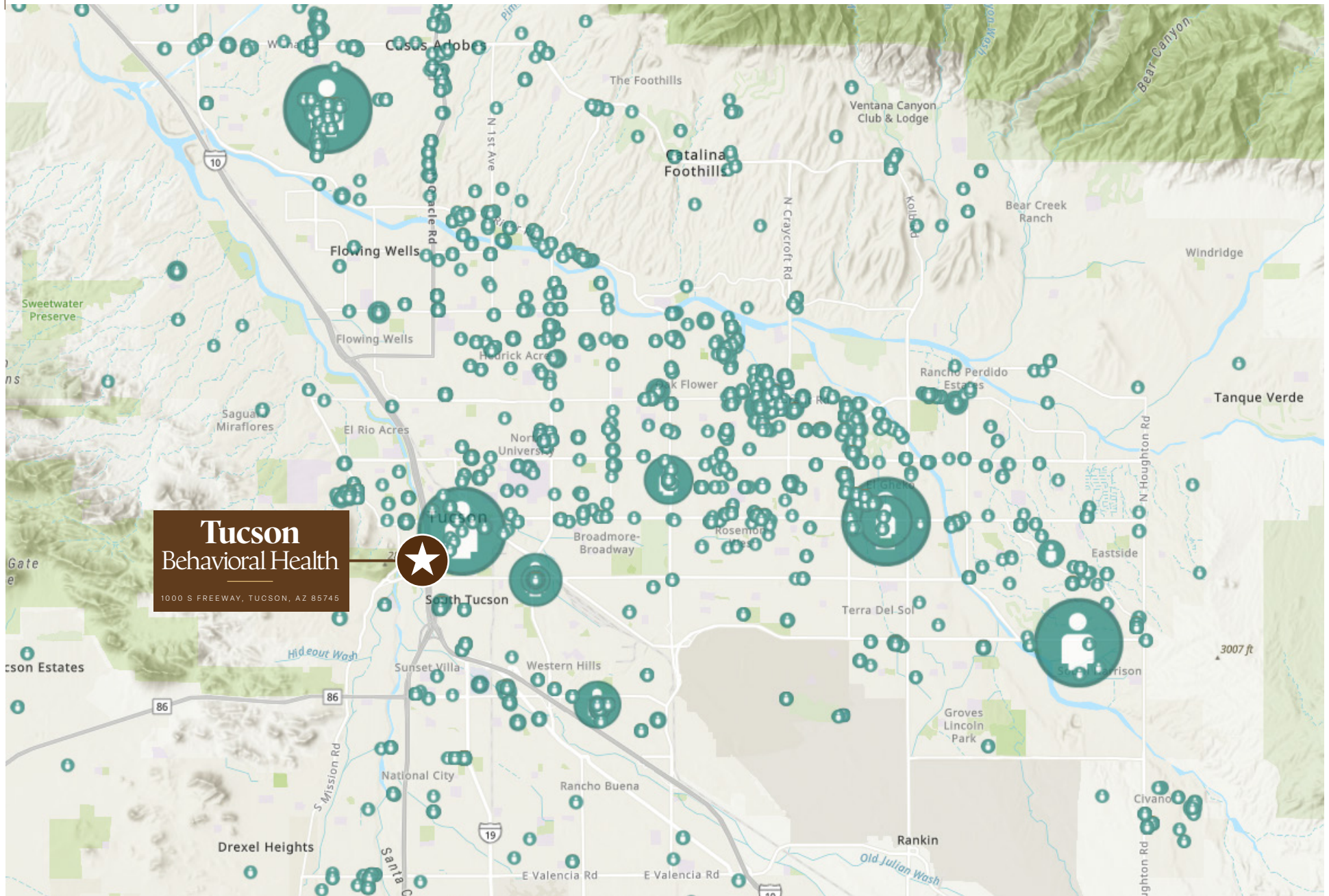


SUBSTANCE USE DISORDER DIAGNOSIS CLAIMS
