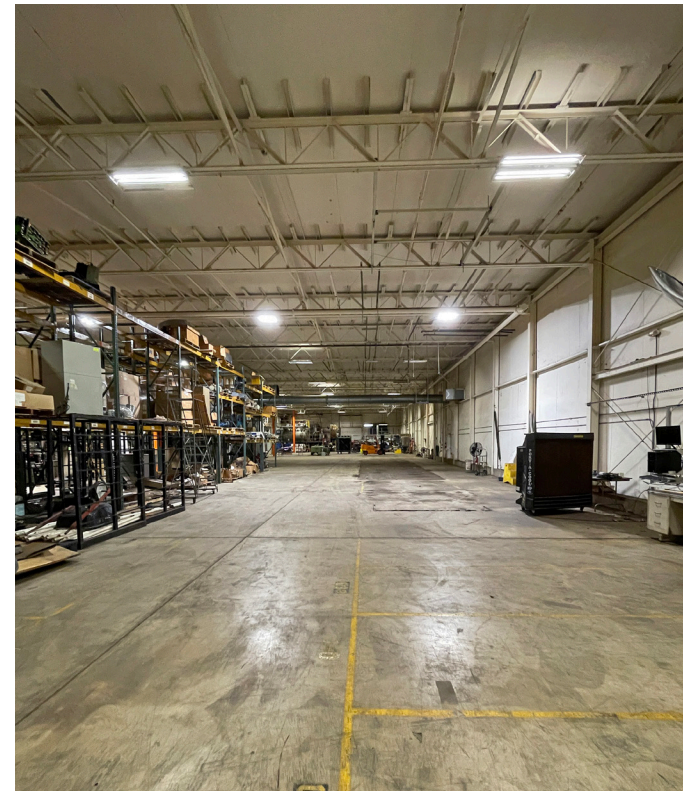

Lehigh Valley Development Incentive Opportunities

Allentown Qualified Opportunity Zone (QOZ)

Downtown Allentown has three census tracts that have been designated for a Qualified Opportunity Zone, and 1210 Sesqui Street falls within the Allentown Opportunity Zone.

Qualified Opportunity Zones (QOZ) are a community-development program established to encourage long-term investments in low-income urban and rural communities nationwide. The QOZ program provides a tax incentive for investors to reinvest their unrealized capital gains into Qualified Opportunity Funds that are dedicated to investing into QOZs designated by each state's governor.

The Qualified Opportunity Zones (QOZ) program offers three tax incentives for investing in low-income communities through a Qualified Opportunity Fund: a Temporary Deferral; a Step-Up in Basis; or a Permanent Exclusion.

A Qualified Opportunity Fund is an investment vehicle that is set up as either a partnership or corporation for investing in eligible property located in an Qualified Opportunity Zone, and that utilizes the investor's gains from a prior investment for funding the Qualified Opportunity Fund.

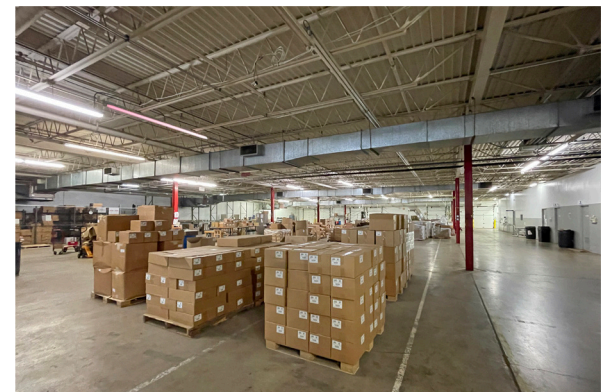
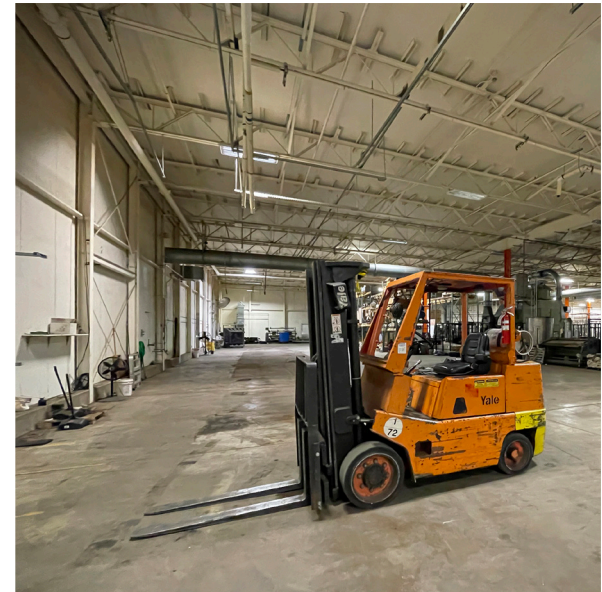

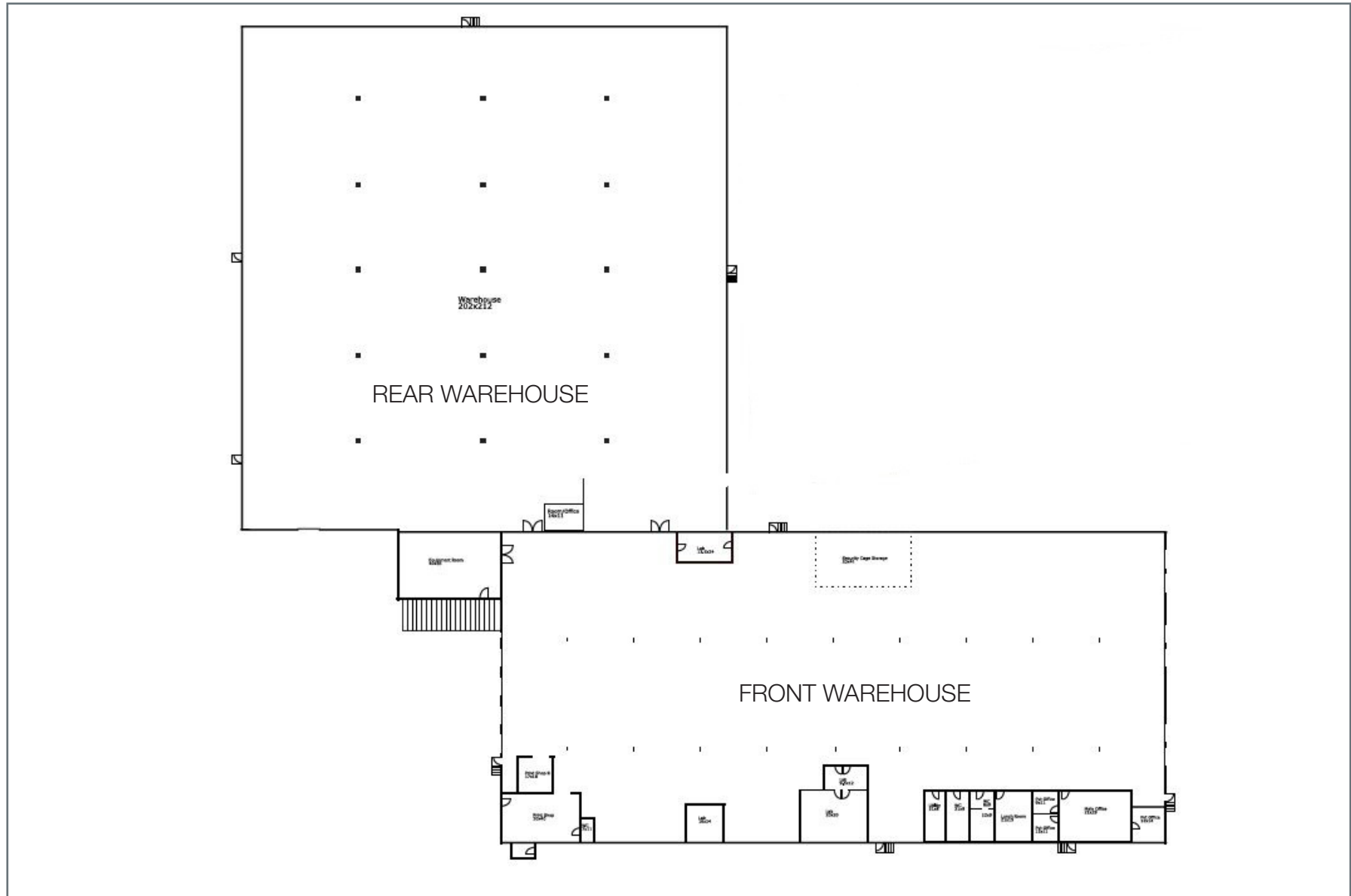

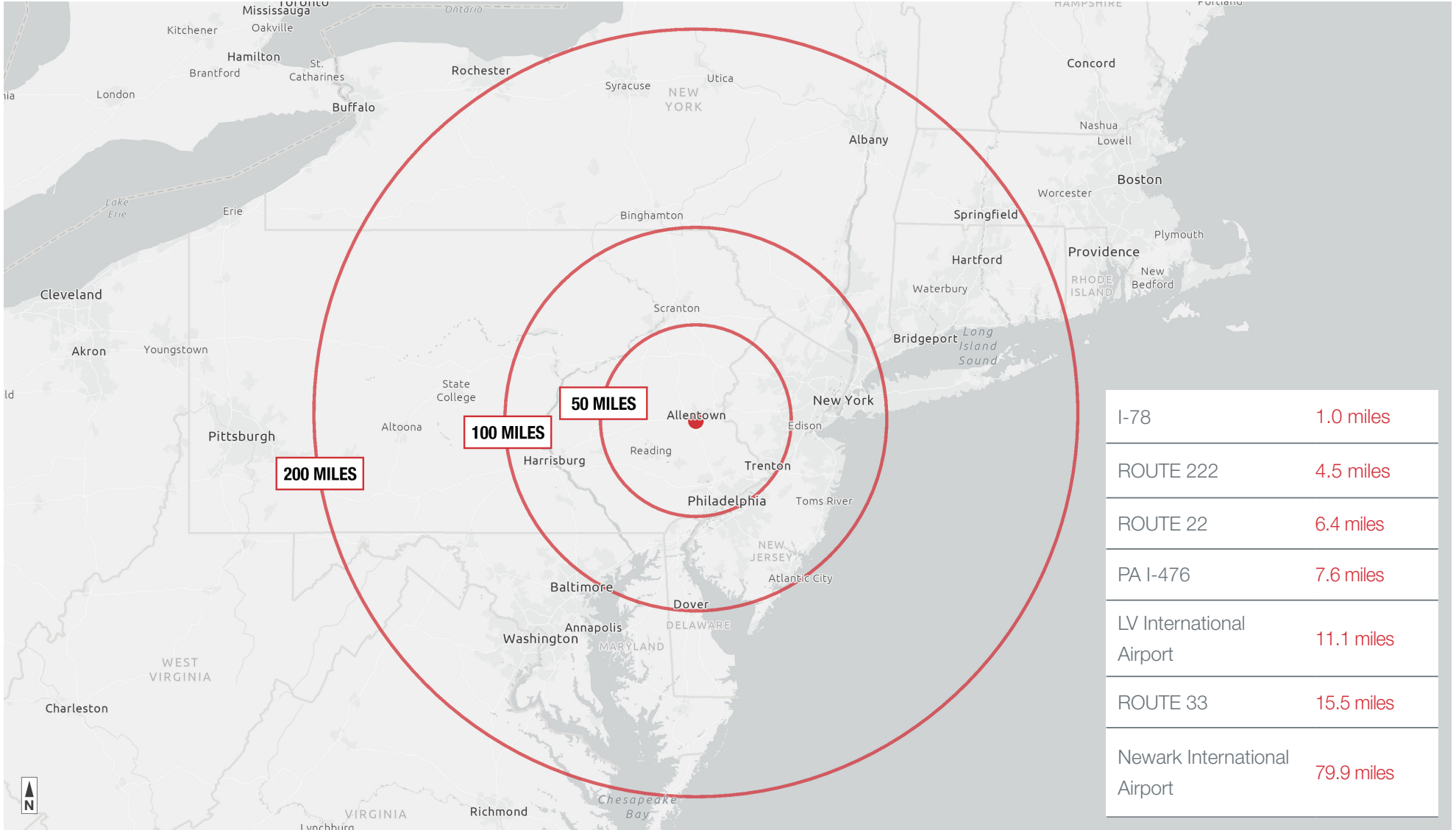
Building Floor Plan

80,000 SF



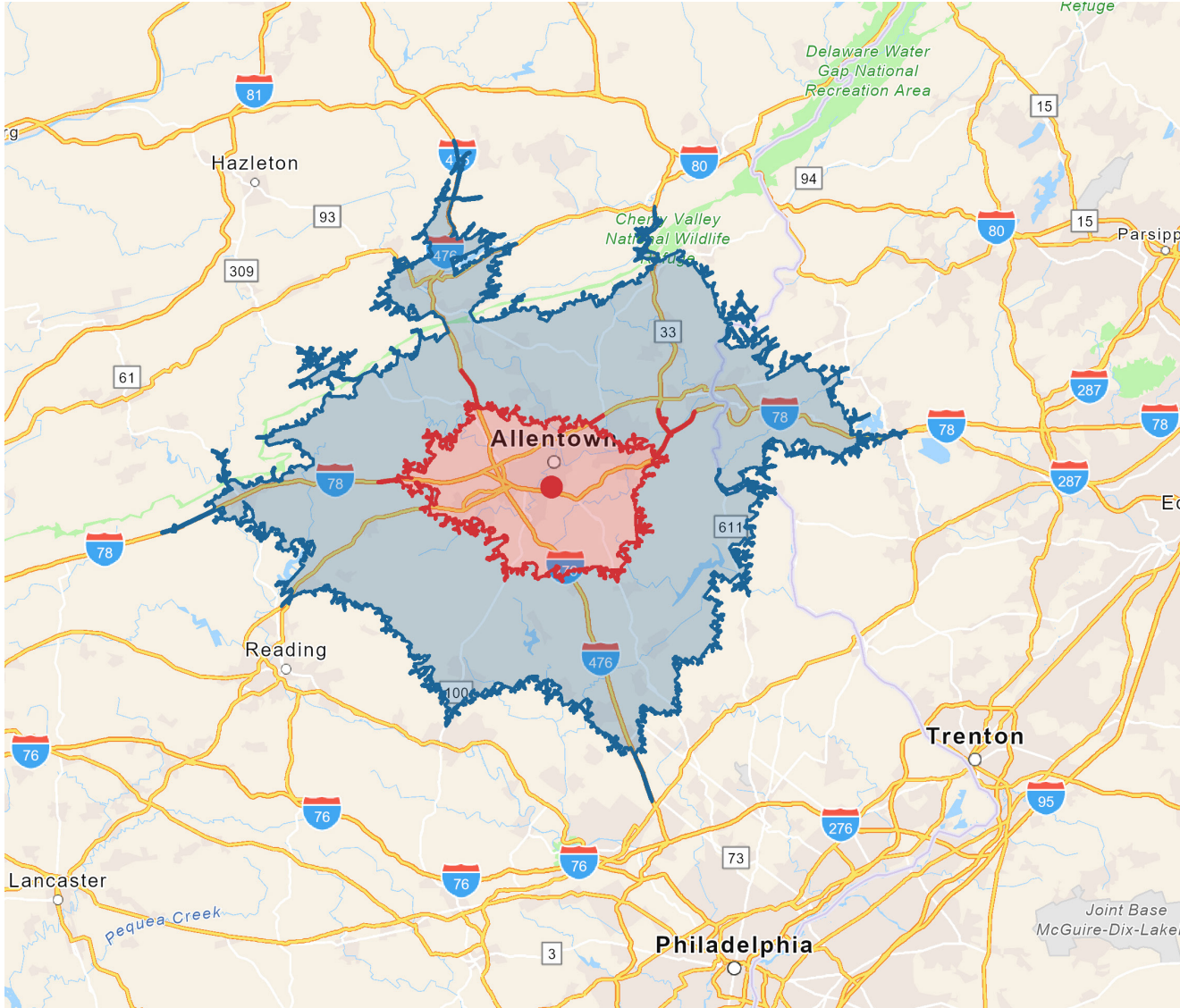
Regional Map

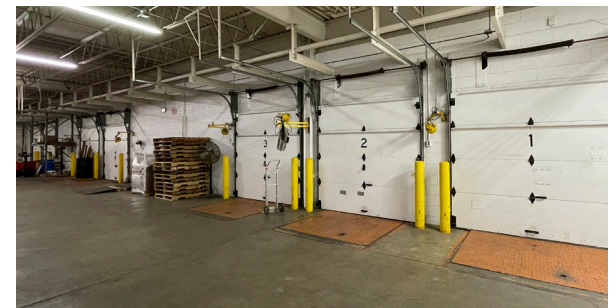

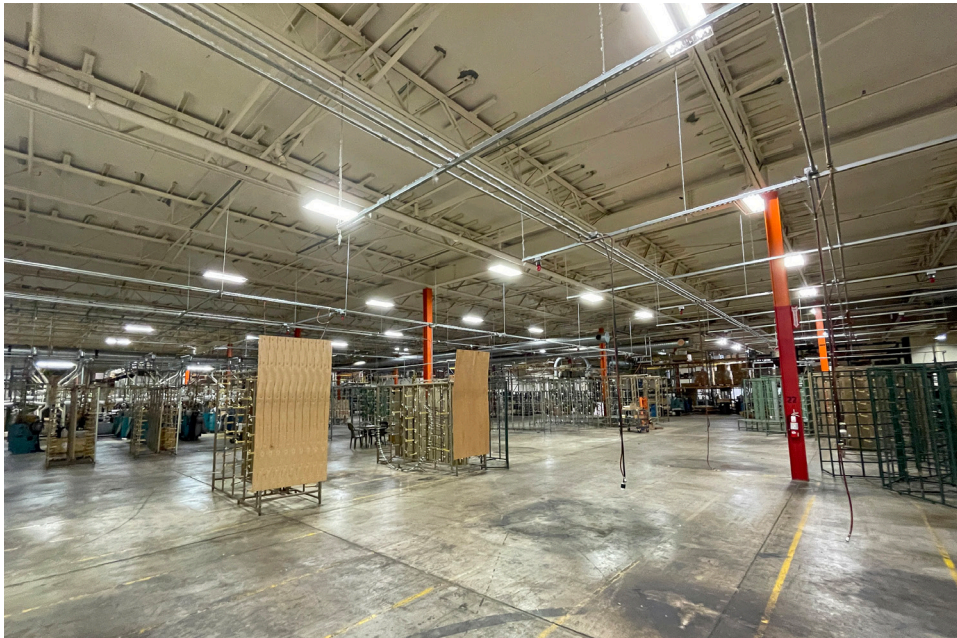
