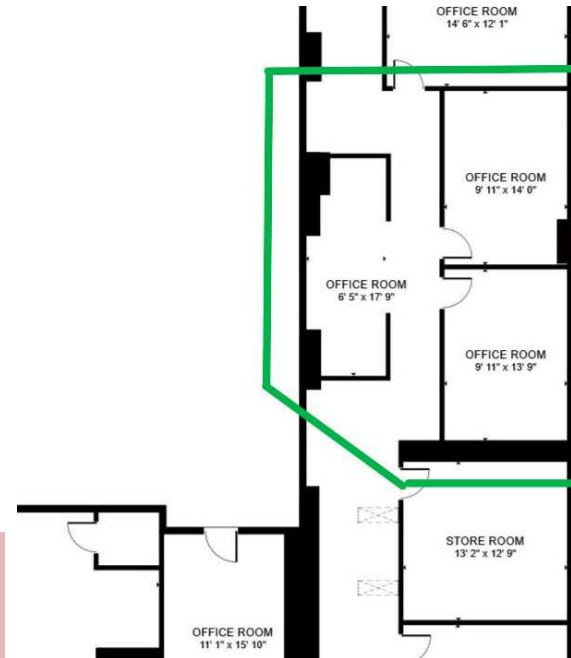

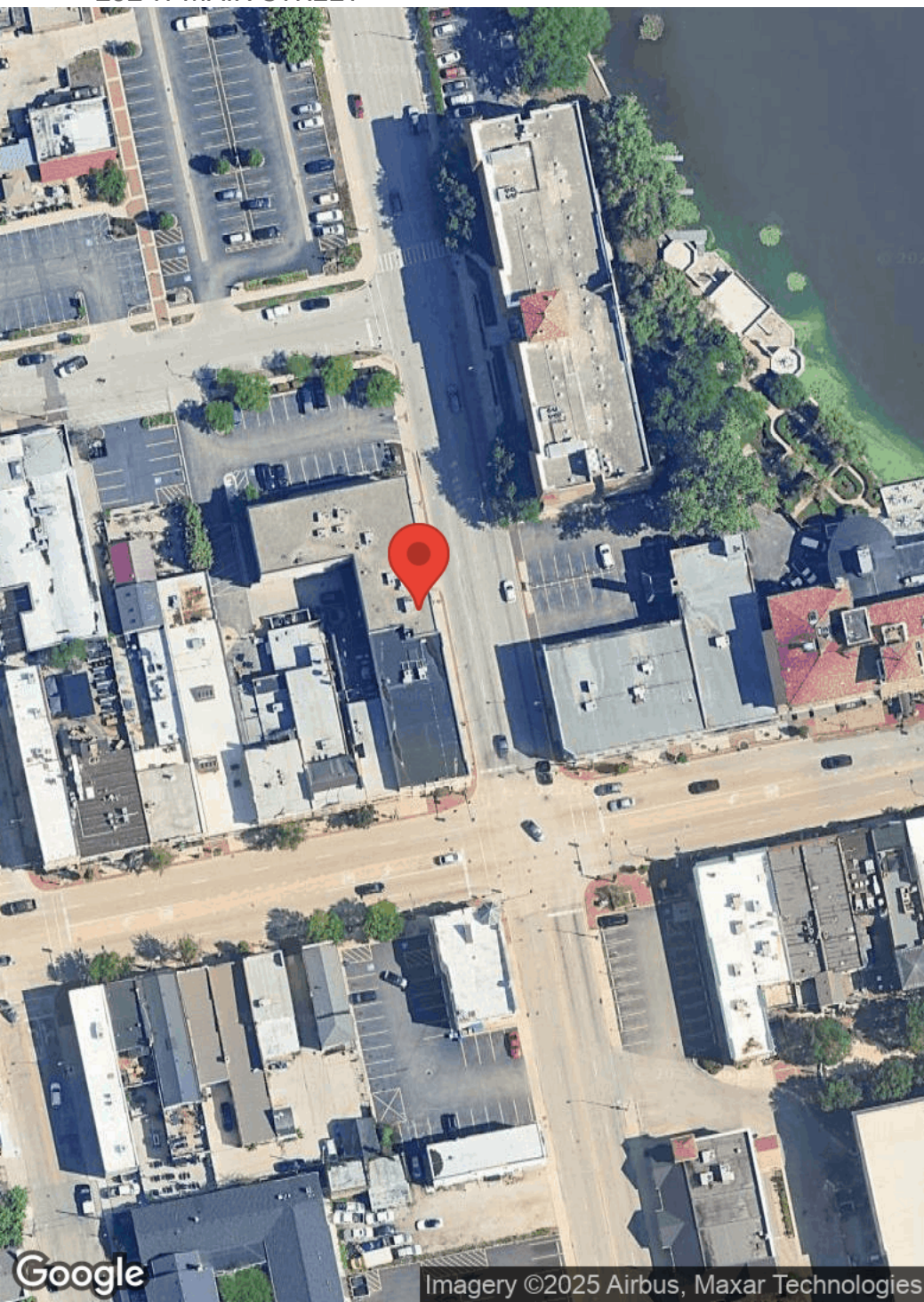

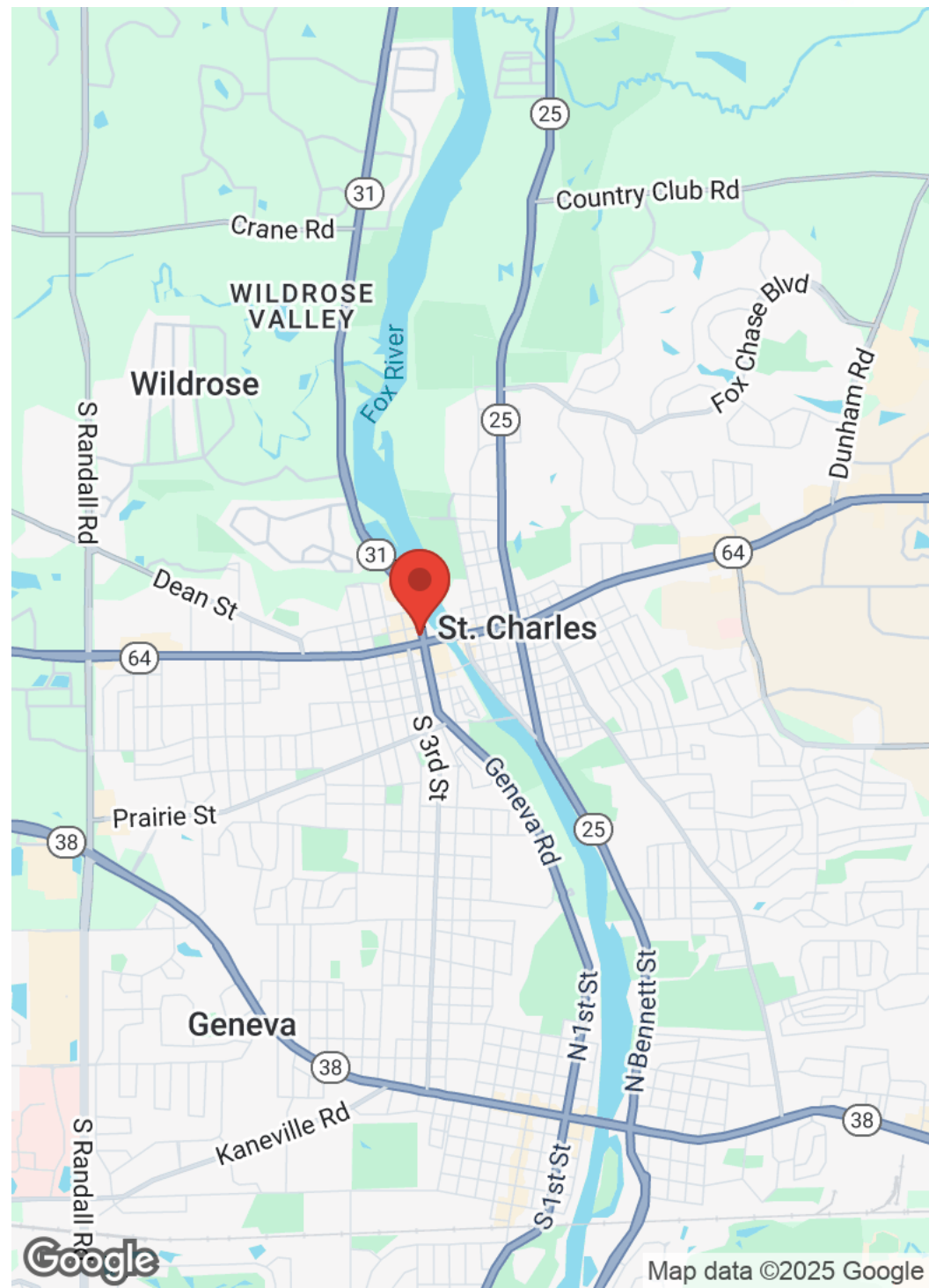


LOCATION MAPS

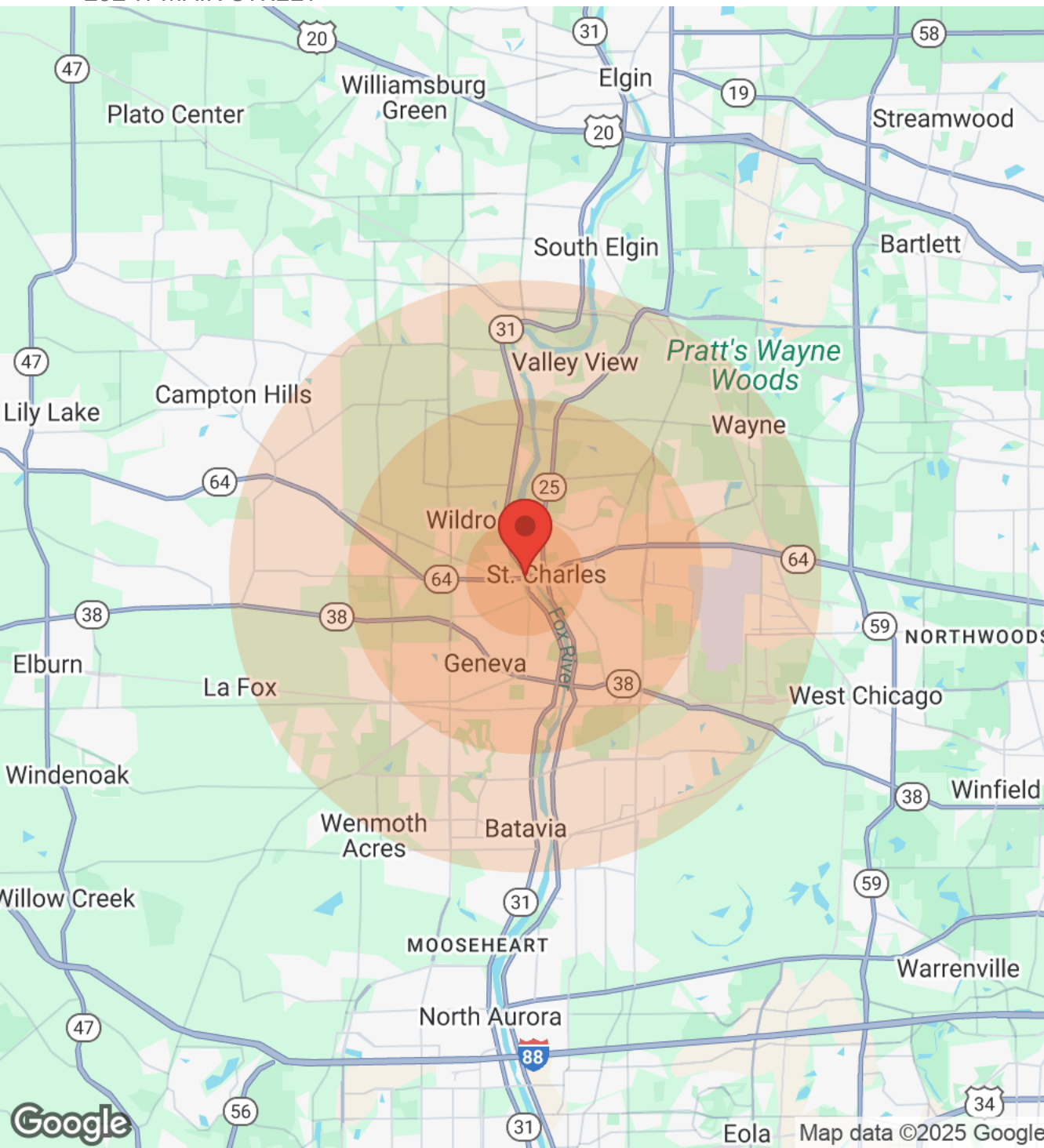
