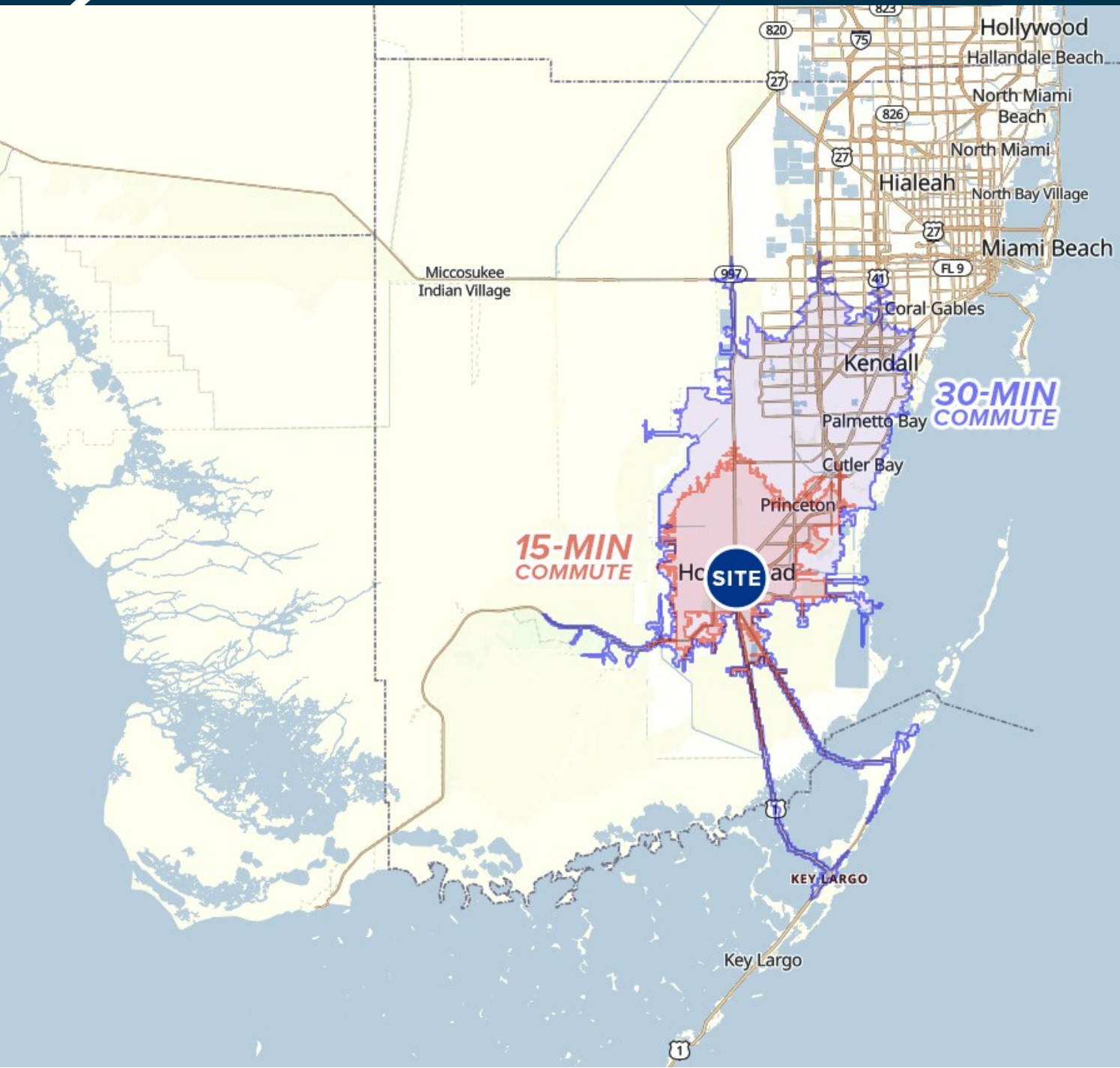

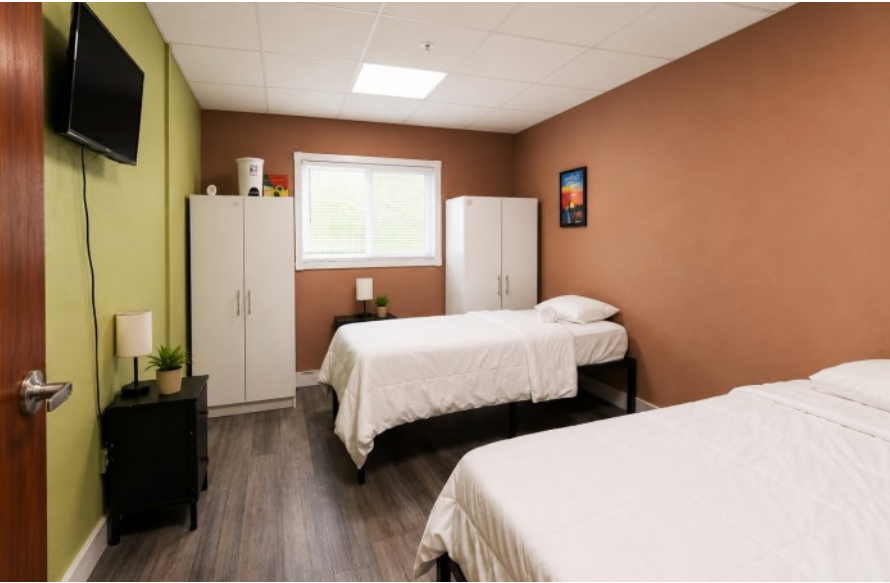
COMMUTE MAP
